## Friday, April 20, 2018

The Senate of the Twenty-Ninth Legislature of the State of Hawai'i, Regular Session of 2018, convened at 11:35 a.m. with the President in the Chair

The Roll was called showing all Senators present with the exception of Senators Harimoto and Thielen who were excused.

The President announced that he had read and approved the Journal of the Fifty-Second Day.

At this time, Senator Gabbard introduced Mahina Tuteur, gubernatorial nominee to the Environmental Council.

Senator Tokuda introduced Melanie Matsui, gubernatorial nominee to the Labor and Industrial Relations Appeals Board, who was present in the gallery with mother Marianne Ono, sisters Adele and Krystal, brother Lane, niece Kimber, nephew Payton, and staff supporters. Senator Chang noted that Daniel was a class valedictorian and would be attending Harvard University in the fall, and had forfeited his first round tennis match in the Oahu Interscholastic Association playoffs that morning in order to deliver the Moment of Contemplation, and wished him luck in the remainder of the tournament. At this time, Senator Gabbard rose to speak on a point of personal privilege as follows:

"First of all, happy Aloha Friday Hemp Day. I see the smattering of my colleagues who are wearing hemp shirts, so I wanted to personally thank each of you for supporting the bills that I began introducing in 2014, and ask that you indulge me for a couple moments here.

"Many of you don't know it was in 1999 when the first study was done out in Wahiawā; it was privately funded, lasted three years, and it was determined that the Chinese variety of hemp seed was the best for this climate. Also, December 14, 1999: Governor Cayetano proclaimed it as Industrial Hemp Day in Hawai'i. In 2014, we passed a two-year study; it was Act 56. In 2016, Act 228 – we passed a five-year pilot study. And then yesterday, you may have read that the Department of Agriculture launched the five-year pilot program.

"So, the Hawai'i Farmers Union did a survey a while back: Over a hundred farmers in Hawai'i are ready to plant hemp, so they'll now be able to go pay their fee at Department of Ag, get their seeds, and start putting hemp in the ground. And I guarantee you this is going to be a huge boon for our farmers, for the economy here in Hawai'i. I also wanted to mention that because there are over 25,000 products that are made out of hemp, and my pitch from the very beginning has been a cottage industry with the Hawai'i branding, right? The Hawai'i label, the hula girl underneath the coconut tree with the guy strumming his 'ukulele. Then, you have products like Hana hemp granola, Hanalei hemp toothpaste, Honolulu hemp aloha shirts, Hawai'i island hemp shampoo; these are just some of the products that will be coming our way. By the way, I was at a national hemp conference this last summer, and in Kentucky, tobacco sales are down so they're switching over - there's 12,000 acres of hemp planted in Kentucky. So I talked to some of my colleagues over there, on the mainland, especially the ones from Kentucky, and I said, 'Look, guys, you guys are going down. You have no chance! When the hemp products from Hawai'i hit the market, who's going to buy Kentucky hemp shampoo? Are you kidding me?' And they all go, 'Sit down, Gabbard! Sit down!'

"So, I just wanted to say again thank you for your support over the years. 1999 to 2018: It only took 19 years to get this done; it's been a long time coming. Mahalo, thank you."

Senator Ruderman rose to speak on a point of personal privilege as follows:

"To amplify on what the previous speaker said, I note that today, on the federal level, Chuck Schumer will be introducing a bill to decriminalize cannabis federally, and Mitch McConnell is introducing a bill to legalize hemp, being from Kentucky, of course. This is a plant that has possibly more economic, medical, and environmental potential than almost anything else before us. We've had 70 years of prohibition against this product that was widely used before that time. It was begun by an effort by the timber and oil industry to squash their competition from the hemp crop. Just imagine the damage that's happened to our environment over these 70 years while we deforested and burned all this oil instead of hemp! It was amplified by Nixon's war on drugs, which, as most of us know, was actually a war on culture.

"I think it's time to be serious: Stop snickering and joking about what might be the most important move we can make and join the modern world. It's time to stop the fear and recognize the potential and the urgency to stop this harmful prohibition. By the way, there are thousands of people in prison for nonviolent, victimless cannabis crimes, including my dear friend, Share Christie, who is in Honolulu Federal Detention Center rotting away right now – I've visited her many times. Her husband spent four years in there, and now she's in there for three years. There's no reason for it; it's time to stop thinking of it as a joke and recognize the serious problem that's before us and the serious potential we have if we join the modern world. Thank you."
