FINAL READING

MATTER DEFERRED FROM MONDAY, APRIL 23, 2018

Conf. Com. Rep. No. 1-18 (S.B. No. 192, S.D. 1, H.D. 1, C.D. 1):

By unanimous consent, action on Conf. Com. Rep. No. 1-18 and S.B. No. 192, S.D. 1, H.D. 1, C.D. 1, entitled: "A BILL FOR AN ACT RELATING TO THE STATE BUDGET," was deferred to the end of the calendar.

FINAL READING

Conf. Com. Rep. No. 3-18 (H.B. No. 1900, H.D. 1, S.D. 2, C.D. 1):

Senator Dela Cruz moved that Conf. Com. Rep. No. 3-18 be adopted and H.B. No. 1900, H.D. 1, S.D. 2, C.D. 1, having been read throughout, pass Final Reading, seconded by Senator English.

Senator Dela Cruz rose to speak in support of the measure as follows:

"I just have brief remarks that I would like to insert into the Journal if I may be permitted. I'd just like to thank my colleagues in the Senate, as well as my counterpart in the House. Our budget discussions were relatively smooth, efficient, and productive. As we reviewed budget adjustments line by line, the issues before us encouraged heathy discussions, and our differences and individual priorities were outweighed by our affinity and commitment to delivering what's best for Hawai'i. Together, House and Senate conferees reviewed and discussed the proposals submitted by the administration in crafting the \$14.4 billion spending plan for the next fiscal year. Our goal was to establish priorities, make necessary cuts, and provide funding for programs that can be spent in a responsible and timely manner. This budget does not just fund our shortterm needs, but it outlines our priorities and a plan for the future of Hawai'i.

"The budget supports agriculture, with Farm to School statewide, expanding extension agents for the College of Tropical Ag. It helps our economy by expanding Creative Lab to our neighbor islands, aquaculture accelerator and incubator initiatives, PISCES, the Excelerator program, and special enforcement services for tax collection. In education, we funded alternative learning centers, the Office of Hawaiian Education, Hawai'i Keiki program, early college, teacher mentoring and certification programs, online learning expansion for higher education, and support for programs that encourage student success in continuing education. In healthcare, \$7.1 million to boost payments for foster children and caregivers; \$4.5 million for new ambulances for Hawai'i island, Kaua'i, and O'ahu; \$1.5 million for the Hilo Medical Center cardiac unit; and \$28 million for Maui Health System. For homelessness, a lump sum of \$15 million for homelessness initiatives, including Housing First and Rapid Re-Housing. In regards to our aging population, we put in \$3.8 million for Kupuna Care; \$1.2 million for the Kupuna Caregivers program, doubling the amount proposed by the administration, allowing for expansion to serve more of our senior population; \$1.7 million for Aging and Disability Resource Centers for each county; and many, many other different priorities that were provided by the subject-matter chairs.

"I want to again thank the committee members for all their hard work. I'd like to also acknowledge the effort, time, and dedication of the vice chair for crafting the CIP budget. And a mahalo goes out to the Senate leadership and subject-matter chairs again in developing and discussing their priorities and making hard choices, realizing we need to live within our means. And lastly, I'd like to thank the Ways and Means and Finance staff for their hard work. Mahalo!"

Senator Baker requested that remarks in support of the measure be entered into the Journal, and the Chair so ordered.

The Chair having so ordered, Senator Baker's remarks read as follows:

"Mr. President, I rise in support of H.B. 1900, H.D. 1, S.D. 2, C.D. 1, the Executive Supplemental Budget, and commend the WAM and FIN chairs and their staff on expeditiously crafting a budget that will significantly help the people of Hawai'i. I want to highlight some of the budget items I'm most excited about – those that will keep residents of Hawai'i healthy and happy, especially our kūpuna. H.B. 1900 funds the innovative, first-inthe-nation Kupuna Caregivers program with \$1.2 million. This program gives support to our kūpuna and their family caregivers while allowing the caregivers to remain in the workplace. This funding will expand access to the program, greatly benefitting our kūpuna and their families. The budget

also adds nearly \$4 million for Kupuna Care, which provides critical services to our aging population.

"The budget adds \$2.1 million to the Hawai'i Keiki program, which coordinates school-based health services to keep our keiki healthy and ready to learn. This program is designed to improve both health and educational outcomes, leading to healthier, more successful youth.

"The bill also adds significant funds for chronic disease prevention and services for the chronically homeless, which will improve residents' quality of life and save the state money over the long-term. The bill also adds funding in the emergency medical services branch for two critically needed ambulances for Kaua'i and Hawai'i island. I commend this forward-thinking investment in our health infrastructure that will continue to serve residents for years to come. Similarly, the bill adds \$28 million to the Maui Health System, which will allow our hospitals to offer the quality of care our residents deserve.

"Additionally, the budget will provide significant benefits to the people of Maui, including funding to complete the new high school in Kihei, improvements for Lokelani Intermediate School, and millions of dollars to complete the Lahaina Bypass.

"Please join me in supporting H.B. 1900, a budget that makes great strides toward improving the health and overall well-being of the people of Hawai'i."

Senator Keith-Agaran requested that remarks in support of the measure be entered into the Journal, and the Chair so ordered.

The Chair having so ordered, Senator Keith-Agaran's remarks read as follows:

"I rise in support of this measure.

"I would like to thank colleagues and staff for their help and input in crafting this budget.

"The Senate finds capital improvement projects are essential to our economy and play a pivotal role in building social infrastructure and helping to strengthen communities.

"The Senate recognizes the great need in the State for services provided by non-governmental groups and nonprofit agencies and has thus provided \$20,000,000 in general obligation bond funds in fiscal year 2018-2019 to help aid these organizations in better serving the community.

"These projects qualify as grants, pursuant to Chapter 42F, Hawai'i Revised Statutes, and include the following:

- Aloha Medical Mission, O'ahu: \$150,000 for plans, design, construction, and equipment for a new dental clinic
- Boys & Girls Clubs of Maui, Inc., Maui: \$250,000 for design and construction for clubhouse at Paukukalo.
- Children's Discovery Center, O'ahu: \$250,000 for plans design, and construction for strategic plan.
- Habitat For Humanity, Hawai'i Island, Inc., Hawai'i: \$265,000 for land acquisition and construction for affordable housing.
- Habitat For Humanity Inc., Kaua'i: \$150,000 for land acquisition and construction for affordable housing.
- Habitat For Humanity, Maui: \$300,000 for land acquisition and construction for affordable housing.
- Hale Makua Health Services, Maui: \$175,000 for equipment for wander management systems for elder and disabled residents.

- Hawai'i County Economic Opportunity Council (HCEOC), Hawai'i: \$280,000 for plans, design, construction, and equipment for mechanical repair facility and training site.
- Hawai'i Nature Center, Inc., Statewide: \$500,000 for plans, design, and construction for Maui and O'ahu sites.
- Honolulu Habitat For Humanity, O'ahu: \$150,000 for land acquisition and construction for affordable multifamily housing.
- Ka Hale A Ke Ola Homeless Resource Centers, Inc., Maui: \$1,000,000 for plans, design, and construction for permanent supportive housing.
- Ka Lima O Maui, Ltd., Maui: \$250,000 for construction for multi-purpose building.
- Kalanihale, Hawai'i: \$200,000 for construction and equipment for Miloli'i Community Enrichment and Historical Center.
- Kalihi-Palama Health Center (Hale Hoʻola Hou), Oʻahu: \$200,000 for construction for clinical space for women and children's programs.
- Kaua'i Economic Opportunity, Incorporated, Kaua'i: \$500,000 for plans, land acquisition, design, and construction for food service facility.
- Kaua'i Philippine Cultural Center, Kaua'i: \$500,000 for plans, design, construction, and equipment for photovoltaic system.
- La'akea Foundation, Maui: \$125,000 for plans, design, construction, and equipment for housing low income and intellectually/developmentally disabled adults.
- Maui Arts & Cultural Center, Maui: \$750,000 for plans, design, and construction to continue implementation of the Maui Arts & Cultural Center's Master Plan.
- Maui County Council of the Boy Scouts of America, Limited, Maui: \$500,000 for construction for Camp Maluhia dining hall.
- Maui Economic Opportunity, Inc., Maui: \$500,000 for construction for transit facility maintenance shop.
- Maui Family Young Men's Christian Association, Maui: \$200,000 for construction for a gymnasium.
- Moanalua Gardens Foundation, Inc., O'ahu: \$890,000 for plans for Kamananui Valley Master Plan.
- North Hawai'i Community Hospital, Hawai'i: \$500,000 for construction for expansion of the emergency department.
- One Ninety Nine Initiative, O'ahu: \$231,000 for land acquisition for homeless housing program.

Senator Kidani rose to speak in strong support of the nominees as follows:

"Your Committee on Education heard from the nominees and received statements of support for all three individuals.

"Nominee Catherine Payne is very well known to many of us – her name is synonymous with Hawai'i public education. She has devoted her adult life to our schools as a distinguished teacher and administrator at the highest levels. Following her so-called retirement from the DOE, where she was principal at Farrington High School, Catherine has served as commissioner and chair of the Public Charter School Commission and is also currently DOE interim complex area superintendent for the Farrington-Kaiser-Kalani complex. When her appointment to the Board of Education is approved, she will leave both of those positions and will serve as chair of the Board of Education beginning July 1. We welcome Catherine's willingness to continue to serve, bringing her wealth of experience in the classroom and in leadership positions to more directly shape education policy.

"Nominee Dwight Takeno is director of administrative services in the UH System Office of the Vice President for Research and Innovation. Previously, he was director of collective bargaining and a human resources specialist at UH Mānoa. He was also interim executive director and chief negotiator for HSTA. In his presentation to your committee, Mr. President, Dwight indicated that many of his views on public education have been formed in deep and meaningful conversations with his spouse, Deanne, who has been a public school educator for the last 28 years. He said that, if confirmed, he expects that those conversations will continue but acknowledges that with his new positon as a board member, the dynamics of that relationship may change.

"The third nominee to the board is a re-appointment in recognition of valuable service by a longtime Hawai'i educator from Kaua'i: Margaret Cox. As with the previous two nominees, Maggie brings decades of experience to her deliberations as a board member. She currently chairs the board's Student Achievement Committee, and has made a point of inviting complex area superintendents to her committee's meetings to discuss their approaches to special education. She is also the board's representative on the Career and Technical Advisory Council that includes representation from DOE and the UH. The council recommends program priorities that should receive federal funds that are allocated to high schools for career and technical education programs."

Senator Kim rose to speak in support of Gov. Msg. No. 694 as follows:

"Mr. President, I rise in support of all of our GMs. I especially wanted to single out GM. No. 694, Catherine Payne, for Farrington High School – go Govs! FINAL READING

MATTER DEFERRED FROM EARLIER ON THE CALENDAR

Conf. Com. Rep. No. 1-18 (S.B. No. 192, S.D. 1, H.D. 1, C.D. 1):

Senator Dela Cruz moved that Conf. Com. Rep. No. 1-18 be adopted and S.B. No. 192, S.D. 1, H.D. 1, C.D. 1, having been read throughout, pass Final Reading, seconded by Senator Keith-Agaran.

Senator Thielen rose to speak in support of the measure with reservations as follows:

"Colleagues, I completely support providing the emergency funding to respond to the recent floods on Kaua'i and O'ahu and in other areas of our state. If there was ever a need to use the rainy day fund, this is certainly it, so I wholeheartedly support that. I just have some sorrow about the fact that we are taking some money from the natural area reserve fund to help fund this.

"I greatly appreciate the fact that, under the state budget, we have moved support for much of the natural area reserve and the forestry work into general funding, but there still is going to be a net loss of the overall amount of funds that are dedicated to protecting our natural and cultural resources. We talk a lot about how important taking care of these natural and cultural resources is, but I remember when I was the DLNR chair, the last year I was there, we actually did a survey of the number of acres that the state had acquired and put under the jurisdiction of the Department of Land and Natural Resources to manage over the prior decade. It was something like about 120,000 acres of land that had been acquired by the state and either dedicated for parks, natural area reserves, or as undedicated and reserved lands that were required to be managed by the department. And with that 120,000-plus acres, there were exactly zero dollars allocated and zero new positions allocated. And so we continue to put a greater and greater burden on this department, which is the department that takes the lead in the state responsibility to manage our public trust resources, but we tend to not fund that. And then to turn at a time like this, and to take some of the money that's in reserve there under those special funds for this - it's very, very hard for me to support

"So my hope is that – because these emergency funds, in many cases, are going to be replenished by FEMA under the federal emergency declaration – next year, as those FEMA monies come into the general fund, we will be able to reinstate some of the monies for the Department of Land and Natural Resources and to take care of these natural area reserves and the other areas because this is all of our kuleana under our state public trust responsibility. Thank you."

The Chair commented:

"I'd also let you know: Deputy Director Sniffen said that the highway funds, besides FEMA, will be 95 percent reimbursable as well, so we will be tracking the money coming back from the federal highway funds as well." Senator Dela Cruz requested that remarks in support of the measure be entered into the Journal, and the Chair so ordered.

The Chair having so ordered, Senator Dela Cruz's remarks read as follows:

"TOBACCO MASTER SETTLEMENT AGREEMENT (EBRF)/TRANSFER THE BALANCE OF THE NARS FUND

"The State's Financial Plan currently shows about \$367 million in our Emergency and Budget Reserve Fund, more commonly known as the 'Rainy Day Fund'.

"In 2016, the Administration put in place the **State Reserve Policy**, which recommends having 10 percent of the general fund balance on hand. Based on this policy, the EBRF should be at \$700 million

"To shore up this fund, this bill will allow for the funds received from the settlement to be deposited into the EBRF.

"In addition, the Legislature enacted Act 84, Session Laws of Hawai'i 2015, which converted funding for DLNR programs from special funds to general funds. There is \$15,307,518 unencumbered in the natural area reserve fund, established under section 195-9, Hawai'i Revised Statutes. This section will transfer the excess balances from the Natural Area Reserve Fund into the General Fund.

"KAUA'I COUNTY DISASTER AND FLOOD RELIEF FUNDING

"Part II of this bill provides the County of Kaua'i the funds they need to repair vital infrastructure as well as public facilities including roads, bridges, county parks, and other infrastructure that were severely damaged. It also provides \$25 million for disaster relief for other areas of the state that have been adversely impacted by the recent rain that occurred this month.

"The record-breaking amount of rainfall on Kaua'i was unprecedented. In just 24 hours, Hanalei recorded over 28 inches. In 48 hours, parts of the island got over 32 inches of rain

"Preliminary estimates put the damage to state highways alone at \$20 million to \$25 million. This immediate infusion of funds allows the County of Kaua'i to deploy resources to assist the affected communities. Furthermore, once expenses are made a portion of the funds will eventually be reimbursed by the Federal Emergency Management Agency."

In accordance with the disagreement of the Senate to the amendments proposed by the House to S.B. No. 2609, S.D. 1, and the request for a conference on the subject matter thereof,

the President appointed Senators Taniguchi, chair; Dela Cruz, Gabbard as managers on the part of the Senate at such conference.

S.B. No. 3058, S.D. 2 (H.D. 2):

The President discharged Senator Rhoads as co-chair on the part of the Senate at the conference to be held for the consideration of amendments proposed by the House to S.B. No. 3058, S.D. 2.

H.B. No. 1883, H.D. 2 (S.D. 2):
