Friday, April 27, 2018

The Senate of the Twenty-Ninth Legislature of the State of Hawai'i, Regular Session of 2018, convened at 6:30 p.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senators Harimoto and Ruderman who were excused.

The President announced that he had read and approved the Journal of the Fifty-Seventh Day.

At this time, Senator Baker recognized Michael Golojuch, Jr., who was seated in the gallery.

Senator Kim noted that there were over 7.7 million overseas Koreans in 178 countries around the world, and that the Overseas Korean Foundation, founded in 1997, supports Koreans to become exemplary members in the communities where they establish themselves while maintaining their national ties, and also supports Korean language schools and cultural festivals around the world.
