TWENTY-SECOND DAY

Wednesday, February 19, 2020

The Senate of the Thirtieth Legislature of the State of Hawai'i, Regular Session of 2020, convened at 11:34 a.m. with the President in the Chair.

The Roll was called showing all Senators present with the exception of Senator Nishihara who was excused.

The President announced that he had read and approved the Journal of the Twenty-First Day.

At this time, Senator Wakai introduced Palmer Yasuo Itomura Wentworth, a 13-year-old eighth-grade student from Croton, New York, who was interested in running for public office one day. Accompanying him in the gallery was his uncle, former State Representative Dennis Arakaki.

Senator Ruderman recognized and congratulated Ka'u Rural Health Community Association, Inc., and presented the following remarks:

"It's our honor to recognize Ms. Jessanie Marques and the Ka'u Rural Health Community Association for their successful achievements that have led to improved access to health, education, technology, and workforce development opportunities in Ka'ū's underserved rural community.

"Ms. Jessanie Marques, or Auntie Jessie, is the executive director of Ka'u Rural Health Community Association. Last year, she was recognized as the 2019 Community Star by the National Organization of State Offices of Rural Health. The Community Star is given to those who cultivate a vital, innovative rural health landscape and infrastructure; develop leadership capacity to grow rural population health and health equity; build capacity for rural data-driven program planning and decision-making; and contribute to rural health innovation, education, collaboration, and communication.

"For over 20 years, Auntie Jessie has continuously fought for equitable access to healthcare services and programs in our community. In 1996, she helped to prevent the closure of the local hospital in Ka'ū and has served as a volunteer organizer in Ka'ū Grassroots Coalition to preserve access to quality health care for the community of roughly 5,800 residents. In 1998, Auntie Jessie created the Ka'u Rural Health Community Association, the first and only rural health community association in the United States. She served as a volunteer on the association's board of directors as president and secretary, and was later asked to become the executive director. She has uplifted her community through her endless efforts, including the establishment of a resource and distance learning center and the first Ka'u Rural Health Academy, a training demonstration project that focuses on health education, research opportunities, and economic sustainability.

"Congratulations, Auntie Jessie, and mahalo for the valuable work that you do for the community of Ka'ū. Mr. President, may I now yield my time to my colleague from Kona?"

Senator Kanuha rose to present the following remarks

"Colleagues, today we are also honored to have with us Ms. Stacyn Sakuma and other members presenting the Ka'u Rural Health Community, whose mission is 'Doing Whatever It Takes to Keep Ka'u Healthy.' Ka'u Rural Health Community Association is a community-based membership nonprofit organization which evolved as a direct result of a community grassroots coalition to preserve access to quality healthcare in rural communities. Together this group has worked to establish the first Ka'u Resource and Distance Learning Center, the Ka'u Rural Health Academy, a community health workers program, and the first HMSA telehealth kiosk on Hawai'i island. Colleagues, please join me in congratulating and recognizing Ms. Jessanie Marques (Auntie Jessie) and Stacyn Sakuma, representing the Ka'u Rural Health Community Association.

"Members, I would also like to recognize in the gallery the following individuals who have worked closely in support of the Ka'u Rural Health Community Association: Neal Palafox and Mavis Nitta from the John A. Burns School of Medicine at the University of Hawai'i; Gregg Kishaba, Hawai'i Department of Health; Laura Arcibal, Department of Health, Family Health Services Division; Joanne Higashi, Department of Health, Maternal and Child Health Branch; Danette Wong Tomiyasu; Felea'i Tau, representing Lieutenant Governor Josh Green; Elena Cabatu, Hilo Medical Center; Charlene Iboshi, Community First Board of Directors; Christian Alameda, CEO, Bay Clinic Inc.; Kathryn Matayoshi, Senior VP of HMSA.
