THIRTY-SEVENTH DAY

Thursday, May 14, 2020

The Senate of the Thirtieth Legislature of the State of Hawai'i, Regular Session of 2020, convened at 12:04 p.m. with the President in the Chair.

The Roll was called showing all Senators present, with Senators Chang and Ruderman present and participating via videoconference, and with the exception of Senator Harimoto who was excused.

The President announced that he had read and approved the Journal of the Thirty-Sixth Day.

The Chair greeted Senate Communications Director Jesse Broder Van Dyke, who was present in the gallery.

MESSAGE FROM THE GOVERNOR

The following message from the Governor (Gov. Msg. No. 808) was read by the Clerk and was disposed of as follows:

Gov. Msg. No. 808, informing the Senate that on May 13, 2020, the Governor withdrew the nomination of CHRISTOPHER FLANDERS to the Hawai'i Medical Education Council, under Gov. Msg. No. 607, from consideration by the Senate, was placed on file.

In compliance with Gov. Msg. No. 808, the nomination listed under Gov. Msg. No. 607 was returned.

The Chair then remarked:

"I'll probably say it at the end next week, but this also would be an appropriate time. We're dealing with over 260 governor's messages—whether boards or commissions or cabinet members—and I appreciate the efforts of all of the chairs to contact, reach out, and try to do the best job that we can in vetting all of these individuals with the limitations we're confronted with. But, in particular, to you, Chair Baker: You have just over one-third of all of the nominations that we have received, and we did end originally on May 7th; we have no session staff to assist us, so not just to you, but to you and your regular full-time staff for the work that you have put in to get this done, I just want to extend my thanks and appreciation."

Senator Inouye rose to request that remarks in support of the nominee be entered into the Journal, and the Chair so ordered.

The Chair having so ordered, Senator Inouye's remarks read as follows:

"I am in support of Leodoloff 'Leo' Asuncion, Jr. for PUC Commissioner, G.M. 541. Leo is a well-qualified individual with extensive and in-depth understanding of administrative management strategies and planning, economic, regulatory, and fiscal principles. He's a team player, and is well-versed in time management and organization skills. His work ethic is strong and formidable in doing the right thing and keeping the work above board. I appreciate the opportunity to share my thoughts in support of this nominee for the PUC Commission, Leo Asuncion."
