## ORDER OF THE DAY

### MESSAGE FROM THE GOVERNOR

The following message from the Governor (Gov. Msg. No. 1102) was read by the Clerk and was placed on file:

Gov. Msg. No. 1102, dated June 23, 2020, transmitting the Governor's statement of objections to House Bill No. 1631, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO STATE BONDS," which was returned without approval and reads as follows:

STATEMENT OF OBJECTIONS TO HOUSE BILL NO. 1631

Honorable Members Thirtieth Legislature State of Hawai'i

Pursuant to Section 16 of Article III of the Constitution of the State of Hawai'i, I am returning herewith, without my approval, House Bill No. 1631, entitled "A Bill for an Act Relating to State Bonds."

The purpose of this bill is to authorize the issuance of general obligation bonds by the State. In addition, this bill authorizes the borrowing of moneys from the Municipal Liquidity Facility under section 13(3) of the Federal Reserve Act, 12 U.S.C. § 343(3). Further, this bill declares the Legislature's findings with respect to these bond authorizations as required by Article VII, Section 13 of the Constitution of the State of Hawai'i.

This bill is objectionable because, due to revisions in the State's bond issuance plan, the State plans to issue an additional \$100,000,000 in general obligation bonds in the second half of fiscal year 2022-2023. This bill needs to be vetoed so that the Legislature can consider this additional bond authorization.

For the foregoing reason, I am returning House Bill No. 1631 without my approval.

At this time, Senator Inouye, Chair of the Committee on Transportation, requested a waiver of the notice requirement pursuant to Senate Rule 21 for H.B. No. 2475, H.D. 1, Proposed S.D. 1.

Senator Inouye noted:

"Mr. President, due to the emerging financial situation with Young Brothers, it is imperative that we hear this bill in the Transportation committee and move it to Ways and Means. The proposed Senate draft authorizes the PUC to address any situation where the condition of a regulated water carrier of cargo may result in the disruption, reduction, or cessation of essential services, and also amends the basis upon which the commission may issue a certificate of public convenience and necessity to an applicant seeking authority to serve as a regulated water carrier."

The Chair granted the waiver.

Senator Inouye announced that the Committee on Transportation would be holding a public hearing on H.B. No. 2475, H.D. 1, Proposed S.D. 1 the following day at 1:40 p.m. in Conference Room 225.

Senator Baker, Chair of the Committee on Commerce, Consumer Protection, and Health, requested a waiver of the notice requirement pursuant to Senate Rule 21 for H.B. No. 2502, H.D. 1, Proposed S.D. 1.

Senator Baker noted:

"We received a copy of a proposed Senate draft drafted by the attorney general. Although the chair has some concerns about it, I think it addresses important topics that COVID has created, and request that we hear this measure to give it due consideration."

The Chair granted the waiver.

Senator Baker announced that the Committee on Commerce, Consumer Protection, and Health would be holding a public hearing on H.B. No. 2502, H.D. 1, Proposed S.D. 1 on Thursday, June 25, 2020, at 9:30 a.m. in Conference Room 229.

Senator Kim rose to seek clarification that Gov. Msg. No. 1102, returning H.B. No. 1631, S.D. 1 without the Governor's approval, was a veto, and the Chair responded in the affirmative.

Senator Kahele rose to extend happy birthday wishes to Senator Inouye, wishing her hau'oli lā hānau.

The Chair then announced that there would be a Senate leadership meeting in his office immediately following adjournment.
