S.B. No. 1092, S.D. 1:

Senator Dela Cruz moved that S.B. No. 1092, S.D. 1, having been read throughout, pass Third Reading, seconded by Senator Keith-Agaran.

Senator Acasio rose to speak in opposition to the measure as follows:

"The Legislature could and, I believe, should have raised the conveyance tax last year to address needs we're facing now. Protecting profit margins of those wealthy enough to be shopping for property in a recession is not more important than our environment or housing those in need."

The motion was put by the Chair and carried, S.B. No. 1092, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO THE DISPOSITON OF TAXES," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

S.B. No. 1240, S.D. 1:

Senator Dela Cruz moved that S.B. No. 1240, S.D. 1, having been read throughout, pass Third Reading, seconded by Senator Keith-Agaran.

Senator Acasio rose to speak in support of the measure with reservations as follows:

"I believe the language is too vague in this bill. I would like to ensure that those tax exclusions pertaining to individuals that were listed in the act will also be conformed with not just those tax exclusions that only benefit businesses."

The motion was put by the Chair and carried, S.B. No. 1240, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO TAX CONFORMITY," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Ayes, 25; Ayes with Reservations (Acasio). Noes, none.

S.B. No. 65, S.D. 1:

Senator Baker moved that S.B. No. 65, S.D. 1, having been read throughout, pass Third Reading, seconded by Senator Chang.

Senator Baker rose to request that remarks in support of the measure be entered into the Journal, and the Chair so ordered.

The Chair having so ordered, Senator Baker's remarks read as follows:

"Mr. President, I rise in support of SB65 SD1, Relating to Intoxicating Liquor.

"Due to the COVID-19 pandemic and the governmental responses to contain the spread of COVID-19 by closing bars, clubs and in-person dining, craft beer manufacturers and local liquor producers have lost income due to reduced sales. Wholesalers have shown little interest in expanding distribution opportunities for local, small craft breweries, especially for markets outside of Hawaii. It is therefore necessary to allow brewpubs, small craft producer pubs, and other alcohol manufactures to obtain direct shipper permits, as smaller producers usually do not have access to distributors or wholesalers that adequately represent the unique aspects of craft beer and alcohol made in Hawaii.

"The State of Hawaii stands to gain additional tax revenue from this legislation. Direct to consumer shipping offers opportunities for Hawaii's craft beer and liquor manufacturers to increase their production to meet the demand for increased sales. This in turn increases beer excise and gallonage taxes, adding to alcohol tax revenue for the State of Hawaii. Reciprocity created through this legislation facilitates market expansion into other states for Hawaii manufacturers. Direct shipping provides tax revenue to the State of Hawaii, with payment by beer and other liquor producers for product they may ship directly into our state.

"Direct to consumer shipping is critical to the survival of breweries due to the COVID-19 pandemic. Direct shipment of wine is already allowed and adding language to export craft beer and other liquor to other states and direct shipping between the islands can be accomplished using a similar process to what is already in place for wine. This measure will allow manufacturers in Hawaii to access customers through direct shipping to help meet the current needs for those businesses struggling through the financial challenges brought upon by COVID-19.

"Please join me in support of SB65 SD1. Mahalo."

"Mr. President, I rise in strong support of SB610, Relating to Boards and Commissions.

"This measure prohibits public members from being engaged in the occupation that the board regulates, from being associated with a member of the occupation that the board or commission regulates that association of results in a material conflict of interest, or having a direct financial interest in the occupation that the board regulates.

"The role of a public member on a licensing board is to represent the public interest. The presence of a well-informed public member brings several advantages to regulation. A public member reduces the potential for board decisions that favor the industry over the public and the potential for decisions that illegitimately favor one faction of an industry over another, encourages public participation in government decision-making, enhances the public's confidence and trust, and strengthens the board's credibility in its decision-making and advocacy.

"Please join me in support of SB610 SD1. Mahalo."

The motion was put by the Chair and carried, S.B. No. 610, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO BOARDS AND COMMISSIONS," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

The Chair having so ordered, Senator Baker's remarks read as follows:

"Mr. President, I rise in strong support of SB784 SD1, Relating to Association Governance.

"The COVID-19 pandemic has prevented many, if not most, of the condominium associations whose annual meetings were scheduled after March 16, 2020, from having their annual meetings, due to the prohibition on socially gathering in large numbers and a result of the Governor's emergency proclamation. The COVID-19 pandemic has further established the need for common interest communities to have flexibility regarding meetings. This measure is important to enable these communities to efficiently conduct their business during pandemics and other emergency situations.

"The need to have flexibility regarding meetings is evident considering the current pandemic. As the state legislature has experienced, electronic meetings have kept us connected and allowed important work to continue despite the restriction on physically gathering in large numbers. Most association bylaws were written when videoconferencing did not exist and now that we have the option for electronic meetings it is necessary to allow all boards to conduct their meetings and elections electronically.

"Please join me in support of SB784 SD1. Mahalo."

"Mr. President, I rise in strong support of SB799 SD1, Relating to Condominiums.

"Because there is a lack of affordable housing options for Hawaii residents, there is a need for more policies to promote owner-occupancy and new condominium developments to increase the housing pool for Hawaii residents.

"This measure amends condominium laws regarding sales to owner-occupants inapplicable to time share units and increased the minimum number of residential units in a condominium project that must be offered for sale to prospective owner-occupants in the thirty-day period following the initial date of sale of the condominium from fifty percent to sixty-seven percent. These amendments will encourage developers to promote owner-occupied units and allow more residents to affordably live in Hawaii.

"Please join me in support of SB799 SD1. Mahalo."

The motion was put by the Chair and carried, S.B. No. 799, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO CONDOMINIUMS," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

"I believe this constitutional amendment leads the public to believe our problem is one of production when it is actually about who we are selling housing supply to. When it comes to managing population growth, locals are leaving Hawai'i because we are too busy selling our current housing production to out-of-state investors who leave their dwellings empty, and locals cannot outbid them with their low wages. Mahalo."

Senator Kim rose to speak in support of the measure with reservations as follows:

"My concern is that we're putting a plan in the constitution and yet, this is something that we should be able to do. We have enough tools in the Legislature. If we feel that the administration is not putting together a housing plan or it's directing us to do a plan, I'm not sure why we would put it into the constitution. We have the budget; we have confirmation powers to have and encourage this kind of planning, and so I don't think it's appropriate that we put it into the constitution.

"I also have a concern that the language of the bill says, 'the demand': We have to plan for the demand, yet demand changes, and so I'm not sure at what point we could be sued by the public if, in fact, the plan does not meet any demand, so for those reasons ...

"And it does have a defective date on it, and so, therefore, I'm voting 'with reservations,' and if it comes back, I may have

to vote 'no' on it. And it's not because I'm against housing—certainly, that's not it. Thank you."

The motion was put by the Chair and carried, Stand. Com. Rep. No. 402 was adopted and S.B. "I just want to make sure that PISCES, when there is the transfer to the aerospace department, will still be allowed to do the basalt pavers, basalt rebar, and these innovative products that have nothing to do with space. With that concern, I still stand in strong support. Thank you."

Senator Wakai spoke in support of the measure as follows:

"We talk about diversification of our economy, and oftentimes we look at Hawai'i and our proximity in the middle of the ocean as a detriment, and we often talk about the price of paradise, and I'm always a believer that we should try and change that discussion to global and should be global leaders in, and aerospace is one of those areas. Although I differ from the opinion of the senator from the Big Island, District 1, in this bill, as Senator San Buenaventura said, we're talking about basalt. If man ultimately one day does colonize the moon, we're going to practice it on the Big Island, and that just a few days ago was a glorifying moment for humankind when NASA sent a rover to Mars. There's so much opportunity in the aerospace sector, and Hawai'i should be the global leader in that area, so this bill helps to create a clear direction in our efforts to capture this market, so it goes far beyond launching satellites into space. I hope that my colleagues will be supportive of this particular

"Coffee borer beetle did not pop up overnight, nor did the coffee leaf rust. These pests are a result of decades worth of mismanagement, both in terms of soil depletion and the introduction of green coffee beans used for blending that harbor such pests. The question we are faced with now is how to handle this crisis. What we have learned by looking closely at the situation is that there are a significant number of coffee farms that are owned by one party and managed by another. It is not entirely clear what rights the farm owners, many of them who actually live on their farms, have when it comes to deciding whether or not these pesticides will be used.

"Senate Bill 855 mandates the State to request an exemption from the EPA to use a chemical that is not currently approved for use on coffee, a chemical that has not undergone the necessary tests to prove that it is safe or effective for this application. It also mandates the State to pay for this pesticide. In doing so, Senate Bill 855 puts the State in the middle of a legal quagmire that is already brewing. How will the farmers who own the coffee fields they turned over to a third-party manager protect their property, themselves, their children, their pets, and their land from exposure to a chemical that has not been approved by the EPA for use in coffee? Clearly, lawsuits that arise from this problem will include the State, which, as the deepest pockets in the proceedings, will suffer the greatest consequence. This is not to mention Priaxor's unknown effect on bees and known toxic effects on our soils and aquatic life via the watershed. Mahalo."
