Thursday, March 4, 2021

The Senate of the Thirty-First Legislature of the State of Hawai'i, Regular Session of 2021, convened at 11:44 a.m. with the President in the Chair.

The Roll was called showing all Senators present, with Senators Chang, Gabbard, Keohokalole, Lee, Rhoads, Riviere, and Shimabukuro present and participating via videoconference.

The President announced that he had read and approved the Journal of the Twenty-Third Day.

At this time, Senator Baker noted that March was Developmental Disabilities Awareness Month, a nationwide campaign to raise public awareness about the abilities and strengths of individuals with developmental disabilities. Senator Baker further noted that the State Council on Developmental Disabilities was hosting their 21st Annual Day at the Capitol event, which would include online training with the Public Access Room, participating in mock hearings, and meeting with legislators. MISCELLANEOUS COMMUNICATION

The following communication (Misc. Com. No. 1) was read by the Clerk and was placed on file:

Misc. Com. No. 1, from the Honorable Ronald D. Kouchi, President of the Senate, and the Honorable Scott K. Saiki, Speaker of the House of Representatives, dated March 3, 2021, transmitting a legislative communication amending the 2021 Legislative Timetable to change the Budget Decking deadline from March 15 to March 22, 2021, and to change the Budget Crossover deadline from March 17 to March 24, 2021.

At this time, Senator Moriwaki, Chair of the Committee on Government Operations, requested a waiver of the notice requirement pursuant to Senate Rule 21 for S.B. No. 1350.

Senator Moriwaki noted:

"The proposed draft addresses recommendations from the 2011 Reapportionment Commission. It was just brought to our attention that certain recommendations of the 2011 Reapportionment Commission should be addressed by the Legislature to clarify and improve the process for future commissions. Due to the pandemic, time to address all concerns is not on our side. In February 2021, the U.S. Census Bureau announced that the census results to the states will most likely be delayed as much as six months, which will significantly delay the work of the 2021 commission. To best prepare under this curtailed timeframe, this measure addresses the major recommendations of the 2011 commission, which should assist the 2021 commission; and provide adequate time for candidates intending to run for office, and ensure voters that they have proper representation. Due to the upcoming single referral deadline, your committee is requesting this waiver to hear this measure."

The Chair granted the waiver.
