The Senate of the Thirty-First Legislature of the State of Hawai'i, Regular Session of 2021, convened at 12:37 p.m. with the President in the Chair.

"This Administration bill will allow promoters to make necessary fight card changes while still complying with the requirements of state law by allowing mixed martial arts promoters to pay fighters with cash.

Because the accountancy profession's standards of review change frequently, the Board's Peer Review Oversight Committee duties will increase substantially. The amendments in this measure will provide the Board of Public Accountancy the flexibility and discretion to select appropriate members who have the proficiency to serve on the Board's Peer Review Oversight Committee.

"Between 2016 and 2018, there were twenty-three motor scooter and moped operator fatalities. Twenty-two of the 23 were not wearing helmets. Wearing a helmet while operating these motorized cycles can significantly decrease fatalities and serious injuries.

"According to the Hawaii Injury Prevention Plan for 2012-2017, published by the Department of Health and the Emergency Services and Injury Prevention System Branch, properly worn helmets can reduce the risk of death by 42% and reduce head injury by 69% in the event of a crash. The measure before us acknowledges that wearing a helmet can be a significant factor in helping to reduce fatalities or the severity of injuries in accidents on Hawai'i's roadways. Accordingly, this measure requires all moped and motor scooter rental companies to ensure the rider wears a safety helmet supplied either by the rental company or by the renter prior to operating the moped or motor scooter. The measure also prohibits the rental of any moped or motor scooter with aftermarket modifications.

"This measure can help save lives. Please join me in voting to support SB615, SD1. Mahalo."

Requiring that a pharmacist-prescribed opioid antagonist be reported to the State's Electronic Prescription Accountability System will help improve the efficiency for reporting and collecting data to prevent opioid overdose. This measure aligns with and supports the goals of the Hawaii Opioid Initiative.

"Act 255, Session Laws of Hawaii 2019, allows pharmacists to issue prescriptions for opioid antagonists, thereby increasing access to lifesaving drugs. The Electronic Prescription Accountability System acts as a prescription drug monitoring system and is a useful tool to reduce the risk of substance abuse and addiction and helps prevent unintended drug interactions.

"Efforts to track dispensing and distribution of opioid antagonists are currently decentralized. This measure will require pharmacists to report opioid antagonist prescriptions to the EPAS, thereby improving efficiency for reporting and collecting data to prevent opioid overdose.

Not only will this help in reducing single-use plastic, it will allow local businesses to expand into new, more sustainable products as well as encourage economic growth.

"Please join me in support of SB348 SD1. Mahalo."

Senator Gabbard spoke in strong support of the measure as follows:

"Colleagues, we continually hear and are acutely aware of the damage that plastics are causing to marine life, human health, or our environment. The truth is, things are getting worse! In this legislation before us, we have a simple change in law that can have a big impact on the amount of plastic bottled water that we go through each year. Companies here in our state, such as Ball Corporation and Maui Brewing Company, would like to bottle water in aluminum cans, but right now, that's cost-prohibitive. That's because we are the only state that has an archaic law that expressly prohibits carbonated soft drinks, juice, and beer operations from using the same equipment to can non-carbonated bottled water. This bill would repeal the requirement that non-carbonated bottled water be bottled in or through lines or equipment through which only water is passed. It would save companies \$3 million to \$5 million, and, unlike plastic bottles, 100 percent of the aluminum can is recyclable. So S.B. 348, S.D. 1 will allow our state to continue to be a leader in reducing plastic pollution in our islands, so I ask for your support of this bill. Mahalo."
