TWENTY-EIGHTH DAY

Friday, March 12, 2021

The Senate of the Thirty-First Legislature of the State of Hawai'i, Regular Session of 2021, convened at 11:36 a.m. with the President in the Chair.

The Roll was called showing all Senators present, with Senators Chang, Dela Cruz, English, Fevella, Gabbard, Ihara, Inouye, Keohokalole, Lee, Misalucha, Rhoads, Riviere, Shimabukuro, and Wakai present and participating via videoconference.

The President announced that he had read and approved the Journal of the Twenty-Seventh Day.

At this time, Senator Chang introduced legislative aide Perry Arrasmith, who had delivered a Moment of Contemplation prior to the Senate's floor session and was accompanied in the gallery by office manager Lynn Robinson-Onderko. Senator Chang also acknowledged his other hardworking staff members for doing a great job for the citizens of Senate District 9.

Senator English introduced Department of Land and Natural Resources staff and people from Hāna who were working at Wai'ānapanapa State Park, and noted that it was third or fourth week of the new system, which they observed was going very well.

The Chair then clarified that they had visited the island of Kaua'i two summers ago with the Ways and Means committee after the flooding, after which carrying capacities were adopted and a permit system implemented for Hā'ena State Park at the end of the road on the North Shore. The Chair further noted that when they looked at things that were happening in the Hāna area at Wai'ānapanapa State Park, they implemented a similar system of charging a fee for visitor parking, and projected to collect \$90,000 each month in fees.

"From a young age, Director Betts was inspired to help those in need after seeing firsthand the consequences of what happens when vulnerable members of our community fail to get the support they deserve, especially in her position in the Commission on the Status of Women. Director Betts's work with DHS started in 2008 as a deputy attorney general, where she represented DHS and Department of Health in child welfare cases and involuntary commitment proceedings. In 2017, she was appointed as deputy director of DHS, under Director Pankaj Bhanot, in managing and overseeing operations for the department, including all policy and budget decisions. When Director Bhanot retired in the middle of the pandemic, Ms. Betts was able to step into his shoes without a hiccup. Despite a huge rise in SNAP and Med-QUEST applications, DHS was able to handle the huge influx without complaints.

"Prior to joining DHS, Director Betts has also served, again, as the executive director of the Hawai'i State Commission on the Status of Women. Her legal experience included a private practice as a partner of Betts & Wood, in the fields of immigration and family law; as an associate attorney for Greg Ryan; as deputy attorney general for the Department of the Attorney General; as well as a law clerk for the Honorable Derrick Chan and the Honorable Marcia Waldorf. She was also a community outreach and educator for the Sex Abuse Treatment Center at Kapi'olani Medical Center for Women & Children.

"In closing, with Director Betts's extensive experience and passion for serving others, I trust that she will meet the high expectations set by those who came before her, and I urge my colleagues to join me and support her nomination. Thank you."

Senator Fevella spoke in support of the nominee as follows:

"I had her visit not once but twice, having intense conversations with her, having the confidence. On her previous director, we had lot of talks, too, and having the confidence that, like our previous speaker just said, in having her go ahead and just step in and go pretty much 100 percent forward, was awesome. Filipino ancestry to know that there is no limit to what they can achieve, so congratulations."
