Thursday, April 15, 2021

The Senate of the Thirty-First Legislature of the State of Hawai'i, Regular Session of 2021, convened at 11:33 a.m. with the President in the Chair.

The Roll was called showing all Senators present, with Senators Chang, Dela Cruz, Ihara, Keith-Agaran, Lee, Misalucha, Moriwaki, Riviere, and Shimabukuro present and participating via videoconference.

“The members may recall that this bill is the one that allows the mayors and the governor, when they declare an emergency, to apply penalties less than the misdemeanor that’s current law. I’m recommending that we accept the changes because there’s only one substantive one: It changes ‘authorize’ instead of ‘require’ that the notice of the infraction be sent to the person’s electronic email address, so, in this bill, any violations of the emergency orders can be dealt with by infractions that just entail a fine, and that’s the only substantive change. The observant will notice that the H.D. is much longer than the S.D. 1 was; it’s all a giant technical amendment, and it doesn’t change the meaning or intent of the bill. Mahalo.”
