The Senate of the Thirty-First Legislature of the State of Hawai'i, Regular Session of 2021, convened at 6:31 p.m. with the President in the Chair.

"This resolution came about as response to UHPA's concerns and a compromise to SB 1328 relating to Tenure at the University of Hawaii and SB1394 relating to Univ. of Hawaii Research faculty salary. Working with UHPA, both SB 1328 & SB 1394 were deferred and SCR 201 was introduced and passed instead.

"This resolution calls upon the UH administration, UH Board of Regents and UHPA to convene a task force to examine and assess the University of Hawaii tenure system for researchers and other non-instructional faculty and compensation structure of faculty engaged in activities supported by extramural funding and grants in comparison to peer institutions across the US and propose the best practices that could be implemented by the University of Hawaii.

"Tenure has been instrumental in assuring academic freedom in higher education. It was established and meat to allow faculty to teach freely, in line with the search for truth, no matter how controversial the subject matter without fear of being fired.

"This resolution does not address tenure for instructional faculty. It is directed at non-instructional faculty.

"Few, if any, colleges in the United States or the UH's peer universities, grant tenure to researchers. Other institutions require researchers to attract extramural research grants to cover 40 percent to 80 percent of their salaries and benefits. Instead, the UH pays its research staff from general funds. UHPA claims that this could jeopardize Hawaii's R1 status, which is false because most, if not all, R1 institutions do not tenure researchers. Additionally, UH has been using tuition dollars paid by students to supplement research that is not related to their instruction.

"A report of the task force including any proposed legislation to be submitted to the Legislature no later than 20 days prior to the convening of the 2022 legislative session.
