Wednesday, February 2, 2022

The Senate of the Thirty-First Legislature of the State of Hawai'i, Regular Session of 2022, convened at 11:38 a.m. with the President in the Chair.

The Roll was called showing all Senators present, with Senators Chang, Dela Cruz, Gabbard, Keohokalole, Misalucha, Moriwaki, Rhoads, and Shimabukuro present and participating via videoconference, and with the exception of Senator Kidani who was excused.

The President announced that he had read and approved the Journal of the Eighth Day.

Senator Rhoads moved that Stand. Com. Rep. No. 2007 be adopted and S.B. No. 206, S.D. 2, having been read throughout, pass Third Reading, seconded by Senator Keohokalole.

Senator Rhoads spoke in support of the measure as follows:

"A bill like this has been introduced for a number of years now by several of us in both the House and the Senate. The pandemic has made the problem much more acute, and the underlying problem is, if someone gets a Section 8 housing voucher or some kind of government support for a rental, in many cases they can't use it. Now, there are different kinds of housing vouchers available, but the state got 708 emergency housing vouchers as part of the federal help on the pandemic. Of those 708, only 36 have been able to find a place to live as of the date of the hearing that the Judiciary committee heard this bill. So this is a real problem if the aid that we're giving as a government to people can't be used because they can't find anybody to take the money; that at least partially defeats the purpose of the aid that we're trying to give people who are struggling to get by with affordable housing. So that's it; thank you very much, and I support the bill. Mahalo."

Senator San Buenaventura rose to speak in strong support of the measure as follows:

"As the chair of Judiciary has pointed out, there is a huge problem when over 690 households could not use the rental vouchers that we have given them. We need the use of these vouchers to be able to transition the homeless over into affordable housing. We already know that there's already a problem with affordable housing, but this transitory need that is not being served because landlords are refusing to accept these vouchers is causing a strain on our homeless population and our homeless shelters, and, as such, hopefully, by passage of this bill, we will ease at least 690 households into not using our homeless services. Thank you."

Senator Chang announced that the Senate Committee on Housing and House Committee on Housing would be conducting an informational briefing at 1:30 p.m. today via videoconference about the affordable housing projects in TOD areas along the Honolulu rail line. Senator Chang noted the briefing's promise to be really interesting, with a number of state agencies and a city agency, and he invited all of his colleagues to join.
