Monday, March 28, 2022

The Senate of the Thirty-First Legislature of the State of Hawai'i, Regular Session of 2022, convened at 11:37 a.m. with the President in the Chair.

The Roll was called showing all Senators present, with the exception of Senator Shimabukuro who was excused.
