"Mr. President and members, these are five highly qualified individuals. They'll be an asset to the Board as they will offer insight and wisdom in the decisions they will make. I ask for your support and recommend that they be confirmed to their positions today.

"G.M. 683, Aimee Barnes, is currently a member of the Board who was appointed on January 1st. She fills the seat for the island of O'ahu, and Ms. Barnes has an extensive résumé of professional experience, having worked in different positions and locations throughout her career.

"I also support G.M. 684, Doreen Canto. Doreen Canto—and she's known as Doreen 'Pua' Canto—has been serving on the Board since July 2021, with her term expiring in 2025 as well. She has extensive community experience, having served on the Maui Charter Commission, Kula Community Association, Maui Native Hawaiian Chamber of Commerce, the Hawaiian Homes Commission, among others as well.

"G.M. 685, Riley Smith, the designated appointee to the Hawai'i County position as well: he has extensive experience, having held positions at Parker Ranch, the County of Hawai'i Department of Public Works, and Bedford Properties, among others. He's a member of numerous civic groups and community organizations, including the Kona Water Roundtable and the Mayor's Advisory Committee on Planning and Permitting.

"G.M. 686, Wesley 'Kaiwi' Yoon, is the current member. He will be serving another term as well. His term expires in 2026. He's the vice president of operations for planning and program management with Bishop Museum, and he previously was with the State Historic Preservation Division.

"And lastly, G.M. 687, Karen Ono, is a lifelong resident with strong ties to her community on the County of Kaua'i. She has been with the Kaua'i Board of Realtors from 1979 to her retirement in 2021. She brings great experience with government affairs committee member on Kaua'i's Board of Realtors and a great community member—always active on Kaua'i island.

"Members, I do ask for your support and recommend that they be confirmed to their positions today, and I have other

comments, Mr. President, I'd like to insert into the Journal. Thank you."

The Chair having so ordered, Senator Inouye's additional remarks read as follows:

"Aimee Barnes, is a current member of the board who was appointed on January 1. She fills the seat for the City and County of Honolulu, island of Oahu. Miss Barnes has an extensive resume of professional experience, having worked in different positions and locations throughout her career. She is currently with Hua Nani Partners and serves as an advisor to major policy, non-profit and philanthropic organizations on climate change since 2019. When asked about why she wished to become a BLNR member, she stated 'I see Hawaii as a beacon of climate and sustainability leadership for the world.... I am deeply concerned about the climate crisis and its current and future impacts on Hawaii's natural resources and economy.'

"Doreen Canto has been serving on the board since July 2021, with her term expiring in 2025 pending our confirmation. Doreen has extensive community experience having served on the Maui Charter Commission, Kula Community Association, Maui Native Hawaiian Chamber of Commerce, Hawaiian Homes Commission among others. She is presently with Pelekana Permitting & Planning, LLC. She was previously employed at the Kula Hospital and Hawaiian Telcom. As a BLNR appointee, Ms. Canto sees herself as 'being open minded and honest in decision making that are supported by facts, while being respectful at all times.'

"Riley Smith, the designated appointee for the county of Hawaii, is President and Chief Executive Officer of Lanihau Properties, LLC. He has extensive professional experience having held positions are Parker Ranch, the County of Hawaii Dept. of Public Works and Bedford Properties among others. Mr. Smith is a member of numerous civic groups and community organizations including the Kona Water Roundtable and the Mayor's Advisory Committee on Planning and Permitting. As a BLNR member he hopes to help with 'sound decision making, offer strategic direction as well as help with instituting consistent policy guidance to the department.'

"Wesley 'Kaiwi' Yoon is a University of Hawaii and Kamehameha Schools alumni, who is already sitting on the board as an at large member. He is being appointed to a full term that expires in 2026. Mr. Yoon is Vice President of Operations, Planning and Program Management with Bishop Museum. He previously was with the State Historic Preservation Division. One of the reasons why he wants to continue with the BLNR is 'to be part of effectuating positive and meaningful change for issues surrounding our fleeting and fragile cultural and natural resources'.

"Karen Ono is a life-long resident with strong ties to her community on the County of Kauai. She has been with the Kauai Board of Realtors from 1979 to her retirement in 2021. She was also a Government Affairs Committee Member on the Kauai Board of Realtors. When asked why she wanted to be a member of the Board of Land and Natural Resources, Karen responded, 'I believe it is my duty as a member and resident, to protect the cultural and historical resources that we had growing up in the best interest of the public for our future generations and residents."

Senator Acasio spoke in support of Gov. Msg. No. 685 with reservations as follows:

"While G.M. 685 comes to the Senate floor with notable support, I feel obligated to give voice to a portion of my constituency and members of the public who have raised serious concerns about two aspects directly related to the duties that come with this very important appointment to the Land Board.

"The first concern is a track record that shows G.M. 685 takes positions against conservation in favor of development. After my interview with said G.M., I remain highly concerned with his lack of knowledge of the precautionary principle and, more importantly, the public trust doctrine, which is a constitutional priority that this position is entrusted to uphold and to dutifully apply.

"Secondly, I want to give voice to individuals who have reached out to me directly expressing their concerns and sharing their personal experiences but aren't at liberty to be public with these concerns. The words they used to describe the experience of working with the nominee were, 'silencing of opposing viewpoints,' 'bullying,' 'aggressive behavior,' and even 'harassment.' In addition to the workplace safety issue these concerns raise, we must ask ourselves how such tendencies would impact the Board's productivity.

"The nominee's likely confirmation today leaves me hoping, now that these concerns have been voiced, that G.M. 685 will take them to heart as he engages with fellow colleagues and the public to fulfill the important fiduciary responsibilities of this position. Mahalo."

Senator Fevella requested that remarks in support of Gov. Msg. No. 685 with reservations be inserted into the Journal, and the Chair so ordered.

The Chair having so ordered, Senator Fevella's remarks read as follows:

"I agree with the remarks of the senator from Hilo and request that her remarks be entered into the Journal as my own."

Senator Inouye spoke in support of the nominees as follows:

"Mr. President and members, these are five highly qualified individuals. They'll be an asset to the Board as they will offer insight and wisdom in the decisions they will make. I ask for your support and recommend that they be confirmed to their positions today.

"G.M. 683, Aimee Barnes, is currently a member of the Board who was appointed on January 1st. She fills the seat for the island of O'ahu, and Ms. Barnes has an extensive résumé of

professional experience, having worked in different positions and locations throughout her career.

"I also support G.M. 684, Doreen Canto. Doreen Canto—and she's known as Doreen 'Pua' Canto—has been serving on the Board since July 2021, with her term expiring in 2025 as well. She has extensive community experience, having served on the Maui Charter Commission, Kula Community Association, Maui Native Hawaiian Chamber of Commerce, the Hawaiian Homes Commission, among others as well.

"G.M. 685, Riley Smith, the designated appointee to the Hawai'i County position as well: he has extensive experience, having held positions at Parker Ranch, the County of Hawai'i Department of Public Works, and Bedford Properties, among others. He's a member of numerous civic groups and community organizations, including the Kona Water Roundtable and the Mayor's Advisory Committee on Planning and Permitting.

"G.M. 686, Wesley 'Kaiwi' Yoon, is the current member. He will be serving another term as well. His term expires in 2026. He's the vice president of operations for planning and program management with Bishop Museum, and he previously was with the State Historic Preservation Division.

"And lastly, G.M. 687, Karen Ono, is a lifelong resident with strong ties to her community on the County of Kaua'i. She has been with the Kaua'i Board of Realtors from 1979 to her retirement in 2021. She brings great experience with government affairs committee member on Kaua'i's Board of Realtors and a great community member—always active on Kaua'i island.

"Members, I do ask for your support and recommend that they be confirmed to their positions today, and I have other comments, Mr. President, I'd like to insert into the Journal. Thank you."

The Chair having so ordered, Senator Inouye's additional remarks read as follows:

"Aimee Barnes, is a current member of the board who was appointed on January 1. She fills the seat for the City and County of Honolulu, island of Oahu. Miss Barnes has an extensive resume of professional experience, having worked in different positions and locations throughout her career. She is currently with Hua Nani Partners and serves as an advisor to major policy, non-profit and philanthropic organizations on climate change since 2019. When asked about why she wished to become a BLNR member, she stated 'I see Hawaii as a beacon of climate and sustainability leadership for the world.... I am deeply concerned about the climate crisis and its current and future impacts on Hawaii's natural resources and economy.'

"Doreen Canto has been serving on the board since July 2021, with her term expiring in 2025 pending our confirmation. Doreen has extensive community experience having served on the Maui Charter Commission, Kula Community Association, Maui Native Hawaiian Chamber of Commerce, Hawaiian Homes Commission among others. She is presently with Pelekana Permitting & Planning, LLC. She was previously employed at the Kula Hospital and Hawaiian Telcom. As a BLNR appointee, Ms. Canto sees herself as 'being open minded and honest in decision making that are supported by facts, while being respectful at all times.'

"Riley Smith, the designated appointee for the county of Hawaii, is President and Chief Executive Officer of Lanihau Properties, LLC. He has extensive professional experience having held positions are Parker Ranch, the County of Hawaii Dept. of Public Works and Bedford Properties among others. Mr. Smith is a member of numerous civic groups and community organizations including the Kona Water Roundtable

and the Mayor's Advisory Committee on Planning and Permitting. As a BLNR member he hopes to help with 'sound decision making, offer strategic direction as well as help with instituting consistent policy guidance to the department.'

"Wesley 'Kaiwi' Yoon is a University of Hawaii and Kamehameha Schools alumni, who is already sitting on the board as an at large member. He is being appointed to a full term that expires in 2026. Mr. Yoon is Vice President of Operations, Planning and Program Management with Bishop Museum. He previously was with the State Historic Preservation Division. One of the reasons why he wants to continue with the BLNR is 'to be part of effectuating positive and meaningful change for issues surrounding our fleeting and fragile cultural and natural resources'.

"Karen Ono is a life-long resident with strong ties to her community on the County of Kauai. She has been with the Kauai Board of Realtors from 1979 to her retirement in 2021. She was also a Government Affairs Committee Member on the Kauai Board of Realtors. When asked why she wanted to be a member of the Board of Land and Natural Resources, Karen responded, 'I believe it is my duty as a member and resident, to protect the cultural and historical resources that we had growing up in the best interest of the public for our future generations and residents."
