Monday, April 18, 2022

MISCELLANEOUS BUSINESS

RECONSIDERATION OF ACTIONS TAKEN

S.B. No. 3044, S.D. 1 (H.D. 1):

Senator Baker moved that the Senate reconsider its action taken on April 12, 2022, in disagreeing to the amendments proposed by the House to S.B. No. 3044, S.D. 1, seconded by Senator DeCoite and carried.

This bill provides a mechanism to assign non-participating tobacco manufacturers qualified escrow fund balance to the State and would authorize the transfer of funds to the State when the qualified escrow fund is abandoned. The only changes made by the House were technical, nonsubstantive as the bill already had a clean date. I move that the Senate agree to the

amendments made by the House in the House draft before us. Mahalo."

S.B. No. 3311, S.D. 2 (H.D. 2):
