At this time, Senator Keohokalole introduced Kathy Ho, an unsung hero of the Red Hill crisis who had started as a deputy in the environmental division of the Department of Health right before the Red Hill crisis broke out. Senator Keohokalole noted that he was not sure whether Ms. Ho had slept a day since then

and that she had done incredible work fighting on behalf of the people of Hawai'i on Red Hill. Senator Keohokalole commented that he was really happy that Ms. Ho had come to check on the Senate and make sure they were going to give her the money that the Department of Health needed in the emergency appropriation. Joining Ms. Ho in the gallery was Katie Arita-Chang. Senator Keohokalole explained that Ms. Arita-Chang was another hero of the State of Hawai'i and that she had done incredible work on communications for the Department of Health related to Red Hill as well as the vaccination plan that was rolled out with the Department of Health last year. Senator Keohokalole clarified that all of the graphics the members had seen on social media to help convey what was going on around the vaccination plan was due to Ms. Arita-Chang's work. Accompanying Ms. Arita-Chang was her husband, Dan Kouchi.

Senator Misalucha rose to speak on a point of personal privilege as follows:

"I've always been envious when Senator Kidani makes this kind of announcement, so I hope that you would indulge me. Congratulations to the Pearl City champions, the Chargers, who swept the Nānākuli Golden Hawks last night, 25–21, 25–18, 25–19, to win the 2022 Oahu Interscholastic Association Division II boys volleyball championship at a packed and very loud Jim Alegre Gymnasium at Radford High School. Congratulations—go, Chargers!"

The Chair replied that he had caught the end of the match, and it had been so noisy he had thought it was a sold-out college match.

The Chair then commented, in defense of the Vice President of the Senate, who had been excused on Monday, that he had had the misfortune on Saturday night to watch his good friend Wes Yonamine coach the Pearl City High School boys, who lost a heartbreaker, 5–4, to Mililani High School. The Chair noted that Mililani had won their third consecutive OIA baseball championship, and that Senator Kidani would not have to do the bragging that evening because he would do it for her.

The Chair then made the following announcement:
