Friday, March 10, 2023

The Senate of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2023, convened at 11:35 a.m. with the President in the Chair.

The Roll was called showing all Senators present, with the exception of Senators Fukunaga and Lee who were excused.

The President announced that he had read and approved the Journal of the Twenty-Seventh Day.

At this time, Senator Kanuha recognized Lieutenant Governor Sylvia Luke and her staff, who were seated in the gallery.
