Senator Kim rose to speak in support of the measure as follows:

"Mr. President, these are resolutions—they're not even bills, but resolutions urging respective departments to establish and implement a five-year pilot program to mitigate and control the significant increase in the population of feral chickens, roosters, and pigs. Mr. President, the top four issues of my constituents of Moanalua and Kalihi that have been raised during the campaign and again in my community surveys mailed out to the entire district were the Red Hill water contamination, rock falls, low-flying helicopters, and feral chickens. Sixty percent of the survey respondents said their neighborhoods were affected by feral chickens. One of them suggested that the state provide free traps to the public to capture feral animals on their property since the city program only applies to public property. I also have other comments in my community bulletin regarding feral chickens, and one of them stated, 'One way to control them is by animal control team, but no one does anything anyway, so why even ask the question.'

"Mr. President, these feral chickens have multiplied and have become a nuisance. They also carry diseases that threaten other animals and our native birds. I know you all know this because this problem is island-wide. Many bills were introduced last year and this year only to die in committee, which is why this resolution is important. I want to thank the Ways and Means committee for including \$5 million in the budget for feral chickens early on in the budget process.

"Mr. President, you know, I will continue, as I have in my tenure as an elected official, to advocate for my district and do all that I can to help the people no matter what district they reside in when they are crying out for help on state issues that we have jurisdiction. There is nothing nefarious about this

measure being reconsidered, Mr. President. Rule 66, Motion for Reconsideration, is part of our rules, and I'm sure that there is not anyone on here, in this body, that has ever not reconsidered the vote that they have taken.

"And, finally, Mr. President, having served on this body for 21 years, I've come to the conclusion that you don't get angry over any of your bills because it's dying because if you did, you'd be angry all the time, so I never get angry about a bill going down, but I do advocate and will continue to advocate for my constituents. Thank you, Mr. President."

Senator Wakai moved that Stand. Com. Rep. No. 1657 and S.R. No. 85 be adopted, seconded by Senator DeCoite.

Senator Kim rose to speak in support of the measure as follows:

"Mr. President, these are resolutions—they're not even bills, but resolutions urging respective departments to establish and implement a five-year pilot program to mitigate and control the significant increase in the population of feral chickens, roosters, and pigs. Mr. President, the top four issues of my constituents of Moanalua and Kalihi that have been raised during the campaign and again in my community surveys mailed out to the entire district were the Red Hill water contamination, rock falls, low-flying helicopters, and feral chickens. Sixty percent of the survey respondents said their neighborhoods were affected by feral chickens. One of them suggested that the state provide free traps to the public to capture feral animals on their property since the city program only applies to public property. I also have other comments in my community bulletin regarding feral chickens, and one of them stated, 'One way to control them is by animal control team, but no one does anything anyway, so why even ask the question.'

"Mr. President, these feral chickens have multiplied and have become a nuisance. They also carry diseases that threaten other animals and our native birds. I know you all know this because this problem is island-wide. Many bills were introduced last year and this year only to die in committee, which is why this resolution is important. I want to thank the Ways and Means committee for including \$5 million in the budget for feral chickens early on in the budget process.

"Mr. President, you know, I will continue, as I have in my tenure as an elected official, to advocate for my district and do all that I can to help the people no matter what district they reside in when they are crying out for help on state issues that we have jurisdiction. There is nothing nefarious about this measure being reconsidered, Mr. President. Rule 66, Motion for Reconsideration, is part of our rules, and I'm sure that there is not anyone on here, in this body, that has ever not reconsidered the vote that they have taken.

"And, finally, Mr. President, having served on this body for 21 years, I've come to the conclusion that you don't get angry over any of your bills because it's dying because if you did, you'd be angry all the time, so I never get angry about a bill

going down, but I do advocate and will continue to advocate for my constituents. Thank you, Mr. President."

The Chair made the following comments:

"As an individual who represents an island who have put the chickens on t-shirts and coffee mugs, I appreciate the concerns of your district."

Senator Kim rose to speak on a point of personal privilege as follows:

"Mr. President, in order for anything to get passed in this body, you must have a majority to prevail—that's democracy. And I know this is a civic lesson review, but we are elected by our districts to be their voice and to be effective. We do so, we inform, we educate, and we try to influence our colleagues in order to advocate for our constituents. When you campaign door to door, members, you put up signs, you wave signs, you pass out swag—you are guilty of influencing voters to vote for

you. The public send in testimony hoping to influence us to vote for or against a measure. Unions, nonprofits, business, the general public call our offices, send in testimony, ask to meet with us, all trying to inform, educate, and influence our vote. Whenever any of you stand up on this floor and make a speech for or against a measure, you have a purpose. You often end your remarks by urging the body to vote for or against. Thus, you are guilty of using your influence (what little you may have) to sway members with your arguments and with your reasoning.

"According to the Internet, influential people move through life with a purpose; they focus on ways to create the impact they wish to have and achieve the outcomes they are aiming for. They give constructive feedback and show appreciation for hard work. So, Mr. President, I have been accused of using my influence, but according to my data, I have had more bills die and don't get heard or passed, so so much for using what little influence I have. Thank you, Mr. President."
