At this time, Senator Kim suggested to the members that they watch *American Idol* because a local boy from Kahuku, 18-year-old Iam Tongi, had made it to the top 26, the only Hawai'i contestant to have made it that far. Senator Kim noted that the show would be cutting contestants, but that unlike voting on measures, where only one vote could be cast, viewers could vote 10 times per candidate on *American Idol*. Senator Kim explained that Mr. Tongi reminded her of Iz and was emotional and very talented. Senator Kim stated her belief that all of Hawai'i needed to support Mr. Tongi because residents of other states would be voting for their own contestants. Senator Kim reiterated the need to vote for Mr. Tongi.

The Chair noted, in good humor, his appreciation of Senator Kim's working in such a bipartisan way in support of the young man.
