#### ELEVENTH DAY

## Friday, February 2, 2024

The Senate of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2024, convened at 11:35 a.m. with the President in the Chair.

The Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Tenth Day.

At this time, Senator Kidani welcomed a group of students participating in the annual Secondary Student Conference (SSC), which had been empowering Hawai'i's youth for over 50 years. Senator Kidani explained that the statewide conference offered participants from public middle and high schools an opportunity to identify widespread issues, learn about the legislative process to address those issues, and gain advocacy experience by sharing viable solutions to solve those issues. Senator Kidani then introduced Mililani High School delegates.
