The Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Twelfth Day.

On motion by Senator Wakai, seconded by Senator DeCoite and carried, the report of the Committee was adopted and S.B. No. 2375, entitled: "A BILL FOR AN ACT RELATING TO JUDGES FOR THE DISTRICT COURT OF THE FIRST CIRCUIT," passed Second Reading and was referred to the Committee on Ways and Means.

Senator Rhoads, for the majority of the Committee on Judiciary, presented a report (Stand. Com. Rep. No. 2151) recommending that H.B. No. 129 pass Second Reading and be placed on the calendar for Third Reading.

On motion by Senator Wakai, seconded by Senator DeCoite and carried, the report of the majority of the Committee was adopted and H.B. No. 129, entitled: "A BILL FOR AN ACT RELATING TO RECOUNTS," passed Second Reading and was placed on the calendar for Third Reading on Wednesday, February 7, 2024.
