### **TWENTY-FOURTH DAY**

## Thursday, February 29, 2024

The Senate of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2024, convened at 11:56 a.m. with the President in the Chair.

The Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Twenty-Third Day.

At this time, Senator Ihara welcomed former state senator Laura Acasio, a community and midwifery advocate, who was seated in the gallery. Senator Ihara explained that he had friendships with both Senator Acasio, who had previously represented District 1, and Senator Inouye, who currently represented District 1, and wished them both well. Senator Ihara then noted that his parents were from Hilo, his uncle had been a circuit court judge during the Quinn administration, and that Hilo constituents were fortunate to have both Senators Acasio and Inouye.

Senator Richards recognized cattlemen present in the gallery who were visiting for that day's Cattlemen at the Capitol event. Senator Richards also introduced his aunty Sarah Richards and his sister Pat Richards, who were seated in the gallery. Joining them was Charles Izumoto, Senator Moriwaki's office manager.

### **ORDER OF THE DAY**

## ADVISE AND CONSENT

Stand. Com. Rep. No. 2735 (Gov. Msg. No. 595):

Senator DeCoite moved that Stand. Com. Rep. No. 2735 be received and placed on file, seconded by Senator Wakai and carried.

Senator DeCoite then moved that the Senate advise and consent to the nomination of JAMES KUNANE TOKIOKA as Director of the Department of Business, Economic Development & Tourism, term to expire December 31, 2026, seconded by Senator Wakai.

Senator DeCoite rose to speak in strong support of the nominee as follows:

"As chair of your Committee on Energy, Economic Development, and Tourism, I carefully reviewed the personal history, résumé, and statement submitted by Mr. Tokioka for service as a director. James Kunane Tokioka has been serving as the interim director of the Department of Business, Economic Development, and Tourism since May of 2023. Previously, Mr. Tokioka served as the deputy director for the Airports Division of the Department of Transportation and, prior to that, served as a new business manager for Oceanic Time Warner Cable from 2011 to 2023, where he oversaw management programs and assisted with securing the largest single contract for Hawai'i in the state's history. Mr. Tokioka was a Hawai'i state representative from 2006 to 2022, where he served, among other positions, as the majority whip, chair of the Legislative Management and Intergovernmental Affairs committee, and vice chair of Tourism. Prior to that, Mr. Tokioka was the county council vice chairman for the Kaua'i County Council for 10 years. Mr. Tokioka has also worked with various hotels and resorts as an entrepreneur, owner, manager, and director over the course of his extensive career.

"During the committee hearing, he received exactly 100 pieces of written testimony-all in support-from a wide variety of state departments, agencies, businesses, organizations, and individuals. Many of the testimony submissions spoke to Tokioka's strengths, skills, and character. During his confirmation hearing, which has also been described as a lovefest for Mr. Tokioka, the lieutenant governor herself came to give verbal testimony about her strong support for him, praising him for the role he played in the response to the Maui wildfires. Another testimony of note was by the Hawai'i Public Housing Authority executive director, who, even though time was short in the hearing, wanted to share that he contacted Mr. Tokioka on a DOT-Airports matter, not knowing he had transitioned to DBEDT. He noted that even though Mr. Tokioka was no longer at DOT-Airports, he made calls to address Executive Director's concerns and then personally called him back. Mr. Tokioka didn't just refer him to another office or pass off the matter; he made sure it was handled personally. This is the type of dedication and commitment Mr. Tokioka shows every day.

"Going the distance to assist others is not something that is new for Mr. Tokioka, but during the COVID-19 pandemic, there were many times when Mr. Tokioka used his resources to help provide the communities in need across the state. As you know, he represented a House district on Kaua'i, but that didn't stop him from helping my home island of Moloka'i in assisting with donations for a community food distribution. He did this without recognition or fanfare.

"Mr. President, over the past six months since the Maui wildfires, we have seen how Mr. Tokioka's leadership was a commanding factor in the state's response to get our residents and visitors safely into shelters, then into non-congregate shelters (aka hotels) and set a path forward for more permanent housing. And to show more of his character and leadership, whenever Mr. Tokioka is acknowledged for his work in the aftermath of these wildfires, the first thing he does is credit and thank his team at DBEDT and agency partners. He knows and sees the value of the contributions of everyone around him.

"Your Committee believes that Mr. James Kunane Tokioka, with 27 years of leadership experience within state and county governments and over 40 years of business management experience in the hospitality sector, possesses the qualifications to successfully serve as a director and lead the Department of Business, Economic Development, and Tourism. Mr. President, I ask for your support and all of my colleagues' in the decision made by your Committee on Energy, Economic Development, and Tourism to advise and consent on this nominee. Mahalo."

Senator Lee rose to request that remarks in support of the nominee be entered into the Journal, and the Chair so ordered.

The Chair having so ordered, Senator Lee's remarks read as follows:

"Thank you Mr. President. I rise in support of Mr. Tokioka's nomination. Many of us are often automatically accorded the title of honorable by virtue of our position in government. However, whether we rise to meet that expectation can only be determined through time. Time spent achieving the goals we set out to accomplish. Time spent overcoming unexpected obstacles and challenges we never signed up to resolve. Time spent actually earning the accolades given to us perhaps too easily. In the case of Mr. Tokioka, appointed to lead the Department of Business and Economic Development just before the Lahaina fire, at perhaps the most critical moment for that community and the state in many years, I've seen and heard of Mr. Tokioka's rise to the occasion. He handled the situation with success far beyond what anyone could expect of a newly appointed director. In fact he handled it far better than many other experienced leaders, and did what needed to be done. If his work throughout that crisis is any measure of the manner in which he may handle the department thereafter, he will have more than earned his title. I wish him the best of luck in that endeavor. Thank you Mr. President."

The motion was put by the Chair and carried on the following showing of Ayes and Noes:

Senator DeCoite introduced Director James Kunane Tokioka, who was present in the gallery with Ms. Kristine Reitan and Pono Tokioka and supporters from the Department of Business, Economic Development, and Tourism, including deputy director Dane Wicker, the director's office staff, and department program managers and staff.

The Chair announced that the director would be greeted on the Senate floor immediately after adjournment.

The Chair continued with the following remarks:

"For those of you new to the Capitol, you know, the rules are that the president presides over the meeting but does not influence the vote from the rostrum. I was going to ask for a recess and ask Vice President Kidani to preside so I could say a few words, but I know Director Tokioka didn't need my words to get him confirmed. But I still felt compelled now to say we met most formally in 1996, when he was elected to the Kaua'i County Council, and I have seen his service and his evolution as a leader. Of course, in 2006, coming to the House and serving in the House until appointed, I happened to reside in Director Tokioka's House district of the three House districts on Kaua'i, and we partnered on a lot of projects. But to paraphrase Martin Luther King (we're not so far removed from his birthday), the measure of a man is not what he does in times of comfort and ease but what he does in times of adversity. And when the fires devastated Maui, Director Tokioka leapt into action, and what he was able to accomplish in moving people out of congregate shelters and into better housing opportunities and to continue to coordinate the efforts and still have his department working with the Legislature on pursuing economic development opportunities that will generate the revenue that will help us pay for the devastation in Maui was amazing. And it was certainly an honor and a privilege to cast a vote in support of your nomination, Director Tokioka, and I wish you nothing but the best. As Chair DeCoite indicated, as a reflection of his values, he named every division head and acknowledged their contribution to help him get to the lovefest he had in his hearing and wants every one of us to know how important each member of the team is, and I just want to let you know: mission accomplished."

On motion by Senator Rhoads, seconded by Senator Gabbard and carried, S.B. No. 2333, entitled: "A BILL FOR AN ACT RELATING TO ELECTION AUDITS," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

S.B. No. 2347:

Senator Rhoads moved that S.B. No. 2347, having been read throughout, pass Third Reading, seconded by Senator Gabbard.

Senator San Buenaventura rose to speak in support of the measure with reservations as follows:

"My concern is that, of the people who have opposed it, that this is basically like a 'three strikes, you're out' law that basically has been shown in California to increase imprisonment rather than help, and my biggest concern is that it also includes mutual affrays, which means fights among consenting individuals will now be considered as a potential felony, and for those reasons, I stand in support but with reservations."

Senator Moriwaki rose to speak in strong support of the measure as follows:

"I stand in support, very strong support, of S.B. 2347. It comes from a community that has been assaulted, injured, and traumatized. They fear convicted violent offenders coming back to their neighborhoods again and again. Offenders know they can attack many times with just a few days in jail because each attack is treated as a misdemeanor, a 'minor' crime.

"Opponents say the bill is a thinly disguised attempt to punish and send Hawai'i's unhoused to prison. Actually, we agree those committing crimes need help, including those with mental illness and substance use disorders—numbers on the rise. "IHS Executive Director Connie Mitchell knows firsthand the changing landscape of substance abuse among our houseless. Methamphetamine and fentanyl from overseas drug labs mixed with other drugs precipitate unexpected and more violent behaviors within and outside their shelters. Her outreach workers have been threatened with machetes, bitten by dogs, and forced to de-escalate individuals in psychotic or manic crises. Incarceration enables those with mental illness or drug addiction to receive treatment—the only way to break the cycle of violence—what's offered now in the new Department of Corrections and Rehabilitation.

"Twenty years ago, residents demanded that we address repeated thefts. The Legislature responded with a 'habitual **property crime** law.' S.B. 2347 seeks the same with this 'habitual **violent crime** law.' Under this bill, a person will be charged with a class C felony for a 'habitual violent misdemeanor crime' if convicted three or more times within a five-year period for:

1) Causing bodily injury;

2) Causing bodily injury to a law enforcement officer; or

3) Compelling sexual assault, including on a minor.

Like the habitual property crime law, the penalty is up to five years in prison and a maximum fine of \$10,000.

"This bill has the potential of reducing the risk of injury to our community and sends a clear message that violent behaviors are not tolerated in the Aloha State. We need this bill for community safety and offender rehabilitation. I urge my colleagues to vote 'yes' on Senate Bill 2347. Mahalo."

The motion was put by the Chair and carried, S.B. No. 2347, entitled: "A BILL FOR AN ACT RELATING TO CRIME," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

"My concern is that we already have an existing law preventing electronic tracking, and making it an actual class C felony—my concern is, by passing this bill, we actually diminish the harassment caused by electronic tracking to that of a misdemeanor, and for those reasons, I stand with reservations."

The motion was put by the Chair and carried, S.B. No. 2310, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO HARASSMENT," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

On motion by Senator Rhoads, seconded by Senator Gabbard and carried, S.B. No. 2251, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO INDECENT EXPOSURE," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Ayes, 25. Noes, none.

At this time, Senator Keohokalole, Chair of the Committee on Commerce and Consumer Protection, rose to request a waiver of the public notice requirement pursuant to Senate Rule 21 for Gov Msg. Senator DeCoite announced that the Committee on Energy, Economic Development, and Tourism, in partnership with the Committee on Agriculture and Environment, would be holding an informational briefing that afternoon in Conference Room 229 from 1:00 p.m. to 2:30 p.m. Senator DeCoite explained that the briefing would address safety concerns regarding crimes related to farming and ranching and that the intent was to identify the root of the issues, address previous roadblocks, and identify potential solutions, with the safety of all individuals being at the forefront. Senator Richards rose to speak on a point of personal privilege as follows:

"I wanted to give thanks. First of all, I'd like to give thanks to my wife, Terri—you met her and the twins—for getting things organized and being here. Mr. President, I want to thank you for giving a little latitude with A.R. coming forth. Also want to thank acting governor Sylvia Luke for her friendship to A.R. and for attending, Speaker for attending, the cattlemen for being here and bringing the cattlemen to the Capitol. And, finally, to my colleagues: Thank you so much. Aloha."

The Chair thanked Senator Richards for having A.R.

Senator Kidani rose to speak on a point of personal privilege as follows:

"Colleagues, I rise today with a very heavy heart and request that we adjourn on a rising vote and observe a moment of silence in memory of a remarkable individual who touched the lives of countless at-risk youth in our state. Last Friday, February 23rd, we lost a true champion for our youth, our friend Sid Rosen, the founder of Adult Friends for Youth.

"In the mid-'90s, when Kalihi was torn apart by the fierce rivalries of two powerful gangs, Sid Rosen stood as a beacon of hope amidst the chaos and challenges. Through the steadfast support of mentors like Sid Rosen, Adult Friends for Youth now continues his legacy of love and support for Hawai'i's keiki.

"Today, we take a moment to honor the memory of Sid Rosen—a visionary, a mentor, and a friend to many, many of Hawai'i's youth. In remembrance of his enduring legacy, I respectfully request permission to adjourn today's floor session on a rising moment of silence, honoring the life and legacy of Sid Rosen, whose spirit will live forever to illuminate the path of countless young lives. A hui hou, Sid. May you rest in peace."

Senator DeCoite recognized Department of Human Resources Development deputy director Mr. Ryan Yamane and Mr. Wes Lo, a good friend from Maui, who were present in the gallery.

The Chair made the following announcement:

"The deadline for filing standing committee reports on Senate bills for Second Reading is 6:00 p.m. tonight."
