The Senate of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2024, convened at 9:42 a.m. with the President in the Chair.

The Roll was called showing all Senators present.

ORDER OF THE DAY

ADVISE AND CONSENT

Stand. Com. Rep. No. 2889 (Gov. Msg. No. 532):

Senator Kim moved that Stand. Com. Rep. No. 2889 be received and placed on file, seconded by Senator Kidani and carried.

Senator Kim then moved that the Senate advise and consent to the nomination of LAUREN AKITAKE to the Board of Regents of the University of Hawai'i, term to expire June 30, 2028, seconded by Senator Kidani.

Senator Kim rose to speak in support of the nominee as follows:

"First, let me say that we have three nominees this morning for the University of Hawai'i Board of Regents. All three were thoroughly vetted over a four-hour committee hearing. Each were sent a questionnaire that was completed and returned ahead of the hearing. Their responses were shared with all the senators, and all of you members were invited to the hearing and welcomed to ask questions. Two other senators did join in.

"So, Mr. President, this is the nomination of Lauren Akitake to the Board of Regents of the University of Hawai'i. Your Committee on Higher Education has thoroughly reviewed the personal history, résumé, and statements submitted by Lauren Akitake for service on the Board of Regents of the university.

"Ms. Akitake has over 15 years of accomplished experience in various areas of law, including estate planning, civil litigation, business law, and conservatorship and guardianship proceedings. She is also a recognized member of the Hawai'i legal community, serving as a 2020 Hawaii State Bar Association Leadership Institute Fellow, 2016 Hawai'i Emerging Legal Practitioners Access to Justice Fellow, and a former Maui County Bar Association board member. She also lectured at UH Maui College for five academic years, teaching business law. Ms. Akitake currently serves as a private practice attorney and per diem district court judge for the Second Circuit. She holds a juris doctorate from the University of Kansas School of Law and a master of science in applied social research from the University of Stirling in Scotland.

"Since July 2023, Ms. Akitake has served as an interim regent. In only eight months—not years, eight months—she has been a proactive leader within the Board of Regents. Her 'lead by example' actions have been driving change and bringing fresh perspective to pressing university issues, some of which have been ongoing for years.

"As the chair of the Independent Audit committee of the Board of Regents, she has been instrumental in raising concerns relating to the shameful neglect of the student housing and implementing quick corrective action to long-pending audit topics. Through her leadership skills, she has provided solutions to improve student life while ensuring accountability of university administration.

"In her questionnaire submitted to the Senate, she states:

Over the last eight months, I worked with the Audit staff to understand and monitor the effectiveness of the UH System in serving the public interest. This includes initiating a Regent suggested two-track audit of UH Manoa Student Housing, closing a long outstanding audit of the Warrior Rec. Center and setting a deadline to close the long outstanding Waikiki Aquarium Audit's corrective action. I've tried my best to address concerns by discussing them openly and publicly. I requested tours of UH Manoa Student Housing, the Warrior Rec. Center and the Waikiki Aquarium so that all 11 Regents could see first hand the status and conditions of these facilities. Should I be confirmed, you can expect more of these site visits and collaborative efforts.

She goes on to say: 'It is my hope and priority to change the culture concerning how Audit topics and corrective actions are viewed. I would like the audit function to include forward-looking audits on Regent suggested projects to assist Regents in understanding and formulating governing policies for the UH Administration to implement.'

"Upon review of the 109 testimonies, all in support of Ms. Akitake, your Committee finds that her experience, knowledge, and desire to serve are commendable. Here is an example of what was said in these testimonies that are posted online: 'Moreover, Lauren's deep roots in Hawai'i and her understanding of its unique cultural and social landscape make her particularly well-suited for this position. She recognizes the importance of preserving Hawai'i's heritage while also promoting progress and growth within the university system.'

"Another said: 'She has strong integrity and is always seeking the truth and fact in matters.'

"Another says: '[Lauren] has qualities such as integrity, morality, justice, and compassion. As a Regent I believe she will continue to be a tempering force that serves the Board well as they consider a wide range of issues where emotional extremes are not beneficial. She will be able to address issues responsibly in full service of her position. Importantly, Lauren listens!'

"On top of her outstanding résumé, Ms. Akitake is a mother of two sons, one of whom has special needs. She wakes up every day at 4:00 a.m. to exercise and get work done so she can maximize the time spent with her kids. Her levels of discipline and commitment are rarefied qualities that will be indispensable to the Board of Regents and university operations.

"Mr. President, your Committee has strong confidence that Lauren Akitake will create an imperative new perspective and action to the Board of Regents and voted unanimously to advise and consent."

Senator McKelvey rose to speak in strong support of the nominee as follows:

"You know, the recent past has taught me, if you're going to levy criticisms, you'd better have an alternative, and so I stand in strong support of that alternative. Thank you very much."

The motion was put by the Chair and carried on the following showing of Ayes and Noes:

Ayes, 25. Noes, none.

Senator Kim introduced Regent Lauren Akitake, who was present in the gallery with her partner, Jayson Watts.

Stand. Com. Rep. No. 2890 (Gov. Msg. No. 596):

Senator Kim moved that Stand. Com. Rep. No. 2890 be received and placed on file, seconded by Senator Fukunaga and carried

Senator Kim then moved that the Senate advise and consent to the nomination of NEIL ABERCROMBIE to the Board of Regents of the University of Hawai'i, term to expire June 30, 2028, seconded by Senator Fukunaga.

Senator Kim rose to speak in support of the nominee as follows:

"Mr. President, your Committee on Higher Education has reviewed the personal history, résumé, and statements submitted by Dr. Neil Abercrombie and finds that he is more than qualified to serve on the Board of Regents.

"Dr. Abercrombie has spent nearly 40 years serving as an elected official in the State of Hawai'i, representing and advocating for the best interests of our communities. He has served in an impressive range of elected positions including Hawai'i state representative and senator, United States congressional representative, Honolulu city councilmember. and, most notably, seventh governor of the State of Hawai'i. During his tenure as governor, Dr. Abercrombie was able to turn around the state's financial status of a \$220 million deficit into a positive balance of \$884 million. It is probably this fiscal responsibility that Dr. Abercrombie possesses that he departed from his fellow regents to vote against the university's budget submitted for the regents' approval. As interim regent of only eight months, Dr. Abercrombie took on potential adversity by questioning the administration and its budget in favor of fiscal responsibility to students, contrasting many other long-sitting regents' tendency to simply just go along with the administration prerogatives.

"When questioned why he was the lone 'no' vote during his confirmation hearing, Dr. Abercrombie responded, 'I did not believe that my reading of the budget reflected an ongoing relationship with the Legislature ... we're mutually required to fulfill our jurisdiction with respect to the University of Hawai'i.' He also stated in the hearing, 'I want the regents to be much more involved in making decisions in the first place, rather than being receptors. I think we should be initiators ... the regents should be informing the administration as to direction we want to go, and then asking the professionals that are hired to do that to then feed us the information that we need, to be able to share with the governor and the Legislature to accomplish the goals of the university.'

"Mr. President, Dr. Abercrombie is proving to be an emerging voice of accountability for the university administration and a changemaker on the Board of Regents. Dr. Abercrombie also has a long-standing relationship with the university. He began his career as a graduate teaching assistant in 1959 at the Mānoa campus. His relationship with the university evolved, and as governor, he incorporated the university president into all cabinet-level meetings to ensure cross-department coordination. During his tenure, he facilitated the opening of the UH West Oʻahu campus to provide higher education to underserved groups, such as Native Hawaiians and Filipinos.

"His verbal and written statements affirm his objectives to re-establish and strengthen the cooperative relationship between the university, Board of Regents, Legislature, and governor. While Dr. Abercrombie has taken the initiative to be an informal liaison between the Board of Regents and the Legislature, he notes that additional engagement by the Board of Regents leadership is imperative to ensuring effective policymaking and initiation of key projects and goals. I am convinced that his role as a regent will bring about a new level

of transparency within both the university administration and the Board of Regents.

"Mr. President, your Committee received 23 testimonies in opposition to Dr. Abercrombie's nomination by UH students, graduates, and community members of the university. Committee members raised these concerns with the nominee, noting that he has not been receptive to students' issues, accompanied with long-winded rants. Dr. Abercrombie acknowledged that his response was intense and regrets the reception of his response and will publicly address this at the next Board of Regents meeting. I understand he has also personally met with senators to address these criticisms.

"Despite the concerns raised in testimony and in light of Dr. Abercrombie's statements in response, and based on his extensive public service, experience in higher education, and commitment to public service, your Committee voted three (and one 'with reservations') and two opposed to advise and consent to his nomination. Thank you."

The motion was put by the Chair and carried on the following showing of Ayes and Noes:

Ayes, 22; Ayes with Reservations (Fukunaga, Moriwaki, Wakai). Noes, 3 (Awa, Elefante, Kidani).

Senator Kim introduced Regent Neil Abercrombie.

Stand. Com. Rep. No. 2891 (Gov. Msg. No. 597):

At this time, the Chair stated:

"Members, pursuant to Senate Rule 37, the final question on nominations made by the governor must be stated in the affirmative.

"The recommendation of the Committee on Higher Education on Governor's Message No. 597 was that the Senate not advise and consent to this nomination. Therefore, the Chair will first entertain a motion to file Standing Committee Report No. 2891, then we will move on to the final vote on this matter."

Senator Keohokalole moved that Stand. Com. Rep. No. 2891 be received and placed on file, seconded by Senator Inouye and carried.

Pursuant to Senate Rule 37, Senator Keohokalole moved that the Senate advise and consent to the nomination of ALAPAKI NAHALE-A to the Board of Regents of the University of Hawai'i, term to expire June 30, 2028, seconded by Senator Inouye.

Senator Kim rose to speak in opposition to the nominee as follows:

"Mr. President, it gives me no pleasure to rise in opposition to G.M. 597, the nomination of Alapaki Nahale-a to the Board of Regents of the University of Hawai'i. Your Committee on Higher Education has thoroughly reviewed Mr. Nahale-a's five-year tenure on the Board of Regents, along with the statements he submitted, and have concluded that he did not exercise his oversight responsibilities of accountability, nor has he been an advocate for the university students.

"Mr. Nahale-a was first appointed to the Board of Regents in July of 2019. As the chair of Higher Education then, I wholeheartedly supported his confirmation along with the members on the committee, two of which are still members of this committee. So it is not personal, as the media reports, but based on his record and responses.

"During his first term, he held leadership positions as first and second vice chair. Mr. President, every member of your Higher Education committee was engaged and asked legitimate questions on the nominee's record over the past five years. None of the questions were inappropriate. The two-hour hearing covered the university student housing, student safety, graduate assistants, the university's budget, athletics, Cancer Center, community colleges, and the Board of Regents' priorities-all subjects have been of ongoing concern over the many years. Two other senators were concerned enough to join the hearing; one posed questions regarding the nominee's tenure at DHHL, and the other on the UH budget. The questions were not about whether he was responsible for all of the issues that are occurring at UH, but rather whether he was aware of them and whether he even attempted to bring it to the university administration's attention to get them addressed. The nominee's responses were general in nature and lacked specifics. He admitted to not knowing or did not review the regent-initiated reports on the Cancer Center or even inquired about student housing and the seven-year shutdown of Hale Noelani during his five-year tenure.

"The student housing situation was brought to light by a new regent, and board minutes reflect that the chair delayed agendizing the student housing issue despite the request of the audit committee chair, and then scheduled it but in a different committee. He admitted that the administration is involved in not only setting the board meeting agendas but also the committee meeting agendas.

"Mr. President, your Committee received a total of 43 testimonies for this nominee: 20 in support, 21 in opposition, and 2 with comments. The majority of the opposition came from UH students, graduates, and university community. This is the first Board of Regents confirmation where we received so many testimonies from students and those directly impacted by the regents' decisions.

"A graduate student of UH Hilo wrote in his testimony, 'It is in my belief and experience that as a Hawai'i County Regent, Nahale-a hasn't paid enough attention to the students' needs, safety, and well-being. UH Hilo housing is somewhat of a mess. . . . He has either remained silent, or not taken student concerns as significant enough to act.'

"An individual wrote, 'I am concerned about Interim Regent Nahale-a's transparency and independence from the current UH administration.'

"The Academic Labor United College of Social Sciences chair told the committee that 'not only has Regent Nahale-a not supported ALU's constitutional right to collectively bargain, but he has also failed to prioritize meaningful graduate student representation in the Presidential Search Process.'

"A UH employee wrote, 'I am in strong OPPOSITION to . . . the re appointment of Alapaki Nahale-a. During his first five year term, the student dorms have gone to shambles, there have been blatant Title IX violations in athletics and the system President/Chancellor of Manoa/ [Principle Investigator] on huge DOD contracts has been allowed to run the board without proper oversight, intervention and implementation/enforcement of fiduciary duties by the Board of Regents.'

"A community leader and alumni of UH Hilo wrote, 'Through first hand experience as a [UH Hilo] student, I firmly believe that as a Hawai'i County Regent, Nahale-a has done nothing of significance that can be felt by the [UH Hilo] student body, and has remained silent when confronted by the issues faced by students across campus.'

"The ASUH president told the committee, 'As a student I believe that . . . we need a Chair who should commit to being present to answer questions to the Senate, and also asks questions that are necessary to be vetted. . . I hope these comments can be helpful on the Committees deliberation, and

we can see improved Board action . . . so the community and State Senate need not have to serve as watchdogs so often.'

"Mr. President, these excerpts were taken directly from the testimonies that are all posted online, and they were not form letters. It sums up the concerns raised by the Committee and much more, such as: as the chair of the Board of Regents, Mr. Nahale-a has been completely absent during any legislative briefings on the University of Hawai'i's budget, briefings on the Cancer Center and UH athletics in person or by Zoom to respond to questions. This also includes bill hearings in both houses that impacted the university. Clearly, there has been a lack of representation of the Board of Regents by the chair.

"I also note that Mr. Nahale-a made no effort to meet with senators prior to and leading up to the confirmation hearing. The regent board chair also gave us no plausible reason for not appointing a Board of Regents member to the important Maunakea transition working group despite being asked many times since December, and I'm told that for the past three months, he's ignored emails and calls asking him to make the appointment.

"Finally, and most disturbing, was Mr. Nahale-a's failure to publicly disclose his potential conflict of interest as CEO of 'Iole: his failure to disclose this to his colleagues as required in the regents' policy and failure to ask for a written opinion from the Ethics Commission.

"For these reasons and more, your Committee, Mr. President, on Higher Education voted unanimously four (and one 'with reservations') to not advise and consent. Thank you."

Senator Keohokalole rose to speak in support of the nominee as follows:

"I would like to thank the committee and the members of the Senate who participated in that four-hour hearing. Their work was thorough and searching and critical and, on many fronts, fair—on many fronts. And that was noted.

"I watched the hearing last night because I sit on other committees and this was a busy week and was not able to attend. And so what I found during the hearing were many, many reasons to find fault, and what I've come to learn in this body is that when you go looking for fault, you can find it. And what really resonates with me is, when the fault is found, what is the reaction of the individual when they are taken to task on it in as public a forum as the Hawai'i State Senate? What I've found in his responses were accountability and leadership. For at least the first 45 minutes of question-and-answer of the nominee, there were multiple instances in which, on the record in a live hearing before the Legislature, he admitted fault, acknowledged the issue, and gave comprehensive and informed responses on how he thought those issues should be remedied and on the specific action that he desired to take. While doing so, he also articulated his vision and approach for the Board of Regents at large, and at times it came into conflict with what I saw in the hearing as a specific prerogative of the Higher Education committee to hold the university accountable. And as someone who went to the university—and I've said this a bunch of times-as someone who went to the University of Hawai'i at Mānoa for eight years (three as a law student and five as an undergrad), working while going to school and commuting all five years because I lived with family to save money and minimize the student loan payments that I still pay, I know there are problems at the university.

"And I believe that we need more than just searching critical inquiry. We need people who can be collaborative, people who can be accountable. He visibly struggled with many of the criticisms in a way that I resonated with because it's a type of approach that I have tried very hard to emulate in my time in the Senate and in my communication with constituents. When

we're wrong, we're wrong, and we should have the courage to admit it. And we should have the diligence to be able to take those criticisms to heart and figure out a way to respond that moves us forward. And when we're right, we're right, and we should be fair about it. I fear that the standard that we set for a volunteer—statewide, unpaid board—based off of the inquiry in the hearing was not realistic. And these are my feelings alone, and I acknowledge and understand the criticisms of the nominee. But, again, what I thought I saw and what I felt from watching that hearing, and from my interactions with Alapaki, who I do not know well (who I've met several times and that's all), was that he has aloha and that he strives to find a collaborative way to solve problems and that he's a leader, and I think those are sufficient reasons to serve as a regent. And so for those reasons, I stand in support. Mahalo."

Senator Inouye rose to speak in support of the nominee as follows:

"Mr. President, may I have the comments of the senator of District 24 be inserted into the Journal as if it was mine? Mahalo." (The Chair so ordered, by reference only.)

Senator McKelvey rose to speak in opposition to the nominee as follows:

"I wasn't going to speak, but I think I have to now to kind of explain my vote. When I met him yesterday for the first time, I mean, what was said was true: He's a man with aloha, a big genuine heart, Hilo boy—I can envision myself having a beer with him, maybe knocking a few around the Naniloa—good man. But, unfortunately, as I myself have personally seen, being a good man, having a good heart, sometimes isn't enough to feed the bulldog.

"A person in a power and position of this magnitude—now more than ever, a detailed vision and a plan to address issues that have been around since I can remember are needed. The disaster unfolding is going to affect everybody, including the university. Untapped potential, untapped resources, inability to articulate detailed plan down to the individual level means that, at the end of the day, the kids will suffer the rate increases because the costs will increase; they always do. And so, now, more than ever, I needed to see a detailed plan; I needed to see a vision; I needed to see a sense of urgency, and, unfortunately, I didn't see that.

"So he's a good man, and I look forward to that day when I hopefully can go to Hilo and hang out with him, but, unfortunately, right now, I can't support him in this position in this role in this time given what is facing the university and the state. Thank you."

Senator Kidani rose to speak in opposition to the nominee as

"I ask that the words of the chair of the Senate Higher Education committee be entered into the Journal as if they were my own."

Senator Kanuha rose to request that remarks in support of the nominee be entered into the Journal, and the Chair so ordered.

The Chair having so ordered, Senator Kanuha's remarks read as follows:

"Mr. President, I rise in strong support of GM597, nominating Mr. Alapaki Nahale-a to serve on the Board of Regents of the University of Hawai'i.

"Born and raised in Hilo on Hawai'i Island, Mr. Nahale-a has consistently demonstrated a dedicated advocacy for Native Hawaiians, which has been instrumental in helping the University of Hawai'i achieve its educational and research goals, particularly for in-state students.

"Mr. Nahale-a provides a vital voice for the Neighbor Islands, including Hawai'i Island, where the University's only other 4-year undergraduate campus is located. His extensive public service experience—as Chairman of the Department of Hawaiian Home Lands, East Hawai'i Commissioner, and CEO of the Global Resiliency Hub at 'Iole in Kohala—enhances his institutional knowledge of the University. Moreover, his deep understanding of educational systems and unwavering commitment to quality education for all make him an exceptional candidate.

"I greatly admire Mr. Nahale-a's collaborative approach to decision-making, effective communication skills, and ability to navigate complex issues. Therefore, I urge my colleagues to join me in voting 'yes' for GM597. Mahalo."

Senator Richards rose to speak in support of the nominee as follows:

"My experience working with the candidate, Alapaki, has been very positive. He's been collaborative, very cooperative, and has helped move the agenda forward for the people of the Big Island and, really, for the state, so I am in strong support of this candidate. Thank you."

Senator Ihara rose to speak in support of the nominee as follows:

"Mr. President, I've had—actually, last night—an epiphany. All my career from entering the Legislature 38 years ago, I've wanted to bridge the divide between citizens and legislators, and I've spent my entire career doing that. The last 20 years, I've been doing a lot of national work because this is a problem that happens everywhere, all the states. And, basically, there are two realities that seem to be independent of each other, and I've been a recent student of quantum physics, and that seems to explain everything. We have parallel universes here. One universe lives outside of this building, and I came from there. They are very hurt. I've been in here, and I can tell those outside that every single one of us here—all of you—I know firsthand love Hawai'i so much, and that is the motivation for everything that you do, and I do honor that.

"We are, in a way, in between the two. We are politicians; we have to make the decisions; we may have to trade a horse with a pig, and if that's what works, we'll do it because I would do that to further the civic mission of our community. And I see today as a political decision between two realities, both legitimate.

"You know, I was there in 1978, the constitutional convention, when we passed—really, my uncle was the chair of the Education committee, and we passed what we thought was some autonomy. We gave the university their own board as well as the Board of Education. And then in 1997, the governor then had an economic revitalization task force, and the conclusion of that was that we wanted ... back then, just as we were turning into the millennium, we were entering a global, knowledge-based economy, and we wanted to be a player in that because we know our people—we have smart kids. Hawai'i people have learned to adapt in ways that other places have never experienced. Our history is filled with adaptations. The Hawaiians went from Stone Age to Iron Age in one generation—unbelievable!

"And then in the year 2000—I'm going to name drop now—I was a member of the New Economy Caucus. In that caucus was Lieutenant Governor Sylvia Luke, Congressman Ed Case, former governor David Ige, and Senator Carol Fukunaga. And we put together a package of bills; we passed about 20 bills that year—extraordinary year. And part of that was to have the University of Hawai'i be an economic engine for Hawai'i like other places, and we know and we had faith that they can do it. And that year, we passed the constitutional amendment. I'm going to give you a couple quotes from testimony in the year

2000 for Senate Bill 539 that put the constitutional amendment on the ballot. It did not require the governor's approval. University of Hawai'i Professional Assembly: Part of their statement is, 'This constitutional amendment is necessary because the concept of university autonomy passed by the 1978 Constitutional Convention has never been implemented.' And another testimony from the University of Hawai'i basically affirms that the constitutional amendment would put in constitution the rights passed. But in Act 115 earlier (1997), and there was concern of the accreditation committees.

"When I point all this out, I want to give due respect to the work of the Higher Education chair because I know, when we passed the amendment back in the year 2000, we trust-I still trust-the university to be one of the leaders of the state in guiding our future, our economic future. And I know it's difficult to watch some of the mistakes that are happening, but I believe we need to let them make their own mistakes and correct their own mistakes. And I know it's been really hard; I partnered with the Higher Education chair when she was president then when we uncovered one of the biggest blunders I think I've seen: the Wonder Blunder, and it was an example of how it's so difficult to keep our hands off of the university when they make such atrocious errors. So I want to validate the concern of the Senate because not only do we pass legislation, it's our responsibility to guard the other two branches to make sure that they have the best people possible, and we take that

"The other reality is the reality of being disrespected—not like we intended it, but there is genuine hurt, a community that is hurt. We don't have to take responsibility for it; it was not intended, but that's true—ask them.

"So we have two parallel universes, and in quantum physics—one of the weird things about quantum physics—they both are true at the same time. And that's where politicians come in: We vote on which one we're going to enact. Not that one is better than the other, but the majority will decide which truth will prevail today. Mr. President, I call for a Roll Call vote on this issue. Thank you."

The Chair clarified the voting procedures.

"Basically, it's the same amendment. There was a word 'not' that was added before the word 'operating,' so if you just take a look at it, it'll be clarified there. Thank you."

S.B. 2345, S.D. 2, which is also on our calendar today, further expands the training already proven successful in crisis intervention for proper treatment. Mahalo."

Senator San Buenaventura rose to speak in strong support of the measure as follows:

"There is nothing that prevents a police officer or an emergency worker from bringing somebody in crisis to the E.R. Basically, what S.B. No. 3139 does is actually expands the definition of a 'mental health emergency worker' when it comes time for an assessment, when it comes time for determining, after the E.R., where that person goes. So, for those reasons, we do need to have this continuum of flow to ensure that those who get treated will get proper treatment, and, for those reasons, I stand in strong support. Thank you."

Senator San Buenaventura rose to speak in support of the measure with reservations as follows:

"Mr. President, I have voted in favor of every gun control bill since I have been in office. I appreciate the amendments that were done in Judiciary for this bill. However, my reservations stem from the fact regarding intestate succession and the automatic imprisonment for a term of five years. It doesn't even give the judge the discretion. Unlike any other crime we have created where we give the judge discretion, this bill says you're guilty of a class C felony and shall be imprisoned for a term of five years. So somebody who obtains title by bequest or intestate succession to one that we have invalidated by passing this bill will automatically be imprisoned.

"I want to point out the fact that, in the preamble, the author admitted that we have the third lowest number of gun deaths per capita. In fact, we haven't had the kind of gun deaths like they've had in the mainland for decades since the Xerox shooting. We need to take into account the fact that we do have law-abiding gun owners, that there are people who use these weapons as tools: Hunters use them as tools, ranchers use them as tools.

"And we also have to take into account that, unlike those who can afford probate, there are people who don't do probate and who automatically end up inheriting without knowing that they would be automatically, upon this passage, be subject to imprisonment, despite being law-abiding otherwise, for five years. For those reasons, I stand in support because I do understand the need for gun control, but with strong reservations. Thank you."

Senator Richards rose to speak in opposition to the measure as follows:

"I appreciate the concern and the efforts that have been put forth to establish guardrails around what we're trying to accomplish. That being said, it's been stated previously that agriculture views a firearm as just another tool, and we have some of the strictest gun laws in the nation. That's reflected by some of the lack of the problems that we've seen. It's not lost on me that we need to be concerned, and I am concerned about safety going forward. That being said, this is an overreach in my estimation, and I cannot support something that'll turn law-abiding citizens into criminals by passing the law. Though I support the concept and intent, I cannot support this bill. Thank you, Mr. President."

Senator Kim rose to speak in opposition to the measure as follows:

"I ask that the words of the senators from Puna and from Kohala as my own. This is the first time, Mr. President, I will be voting against any gun control bills, but I do agree with the previous speakers. Thank you."

Senator McKelvey rose to speak in opposition to the measure as follows:

"I, too, unfortunately cannot support this measure, but I'd like the words of the speakers from Puna and Kalihi entered into the record as if they were my own because my record and my thoughts are the same. However, besides the issues that they pointed out, there are other huge, glaring issues, I believe, in this bill, including what I think is an equal protection argument. That being said, because of all of these issues and because we do have the strongest gun laws in the country and because we've just passed many bills last year, I'm hoping that we could hit pause on this one and perhaps look at this issue more tangentially later on. Thank you."

Stand. Com. Rep. No. 3057 (S.B. No. 3335, S.D. 2):

Senator Keohokalole moved that Stand. Com. Rep. No. 3057 be adopted and S.B. No. 3335, S.D. 2, having been read throughout, pass Third Reading, seconded by Senator Dela Cruz.

Senator Fevella rose to request that remarks in opposition to the measure be entered into the Journal, and the Chair so ordered.

The Chair having so ordered, Senator Fevella's remarks read as follows:

"Mr. President, I understand the benefits marijuana provides in alleviating pain and symptoms for those suffering from an array of illnesses and is the reason why Hawai'i currently allows the use of medical marijuana; however, I do not support the recreational use. As Hawai'i presently allows some substances for leisure, it has been shown to be abused as it is composed of addictive properties. I believe Hawai'i is not prepared to take on another potential addicting substance at this time."

Senator Moriwaki rose to speak in opposition to the measure as follows:

"Due to the serious concerns by our public health and public safety agencies, the attorney general, and the Department of Health, I have written remarks I'd like to insert into the Journal. Thank you."

The Chair having so ordered, Senator Moriwaki's additional remarks read as follows:

"I rise In opposition. I appreciate the hard work of the Attorney General's Office in researching and drafting this measure. It sought to protect Hawaii's communities from the adverse effects and unintended consequences of legalizing marijuana recreational use. SB2335 creates a huge infrastructure with staff and funding of millions of dollars in the departments of the attorney general, law enforcement, health, and commerce and consumer affairs; plus newly-created boards--- Hemp and Cannabis Control Board, Hawaii Hemp and Cannabis Authority, and Hemp and Cannabis Control Implementation Advisory Committee. Nevertheless, I believe these safeguards and initiatives do not outweigh the risks and dangers cannabis legalization poses to our public health and safety.

"Legalization of cannabis in Hawaii has been the subject of ongoing conversations in the Legislature for over twenty-five years. The legislature responded in 2000 by allowing the use of marijuana for strictly medical purposes under the Medical Cannabis Registry Program. It also established the Hawaii Medical Marijuana Dispensary System to regulate a statewide dispensary system for medical marijuana to ensure that qualifying patients have access to medical marijuana; and, in 2020, Act 273 decriminalized small amounts of cannabis.

"Initial support for medical-use marijuana addressed those who needed it for medical use. To the concern that it would bleed into recreational use, proponents proclaimed it would not. But here we are. They moved the conversation to advocacy for legalized marijuana for recreational purposes.

"To this day, however, none of the agencies responsible for the health and safety our communities support for expanding marijuana use. In fact, as more data come in, we learn cannabis is even more dangerous to the public health and safety than tobacco or alcohol use. The experience of other states that have legalized marijuana distribution through regulated points of sale is that a parallel illicit and unregulated market expands and underprices the legal market. The danger to public health of the increased availability of untested cannabis increases, as does the likelihood of involvement by organized crime in the parallel illicit market. States that have legalized marijuana report that the availability of legalized cannabis products correlates with increased incidents of driving under the influence, resulting increased motor accidents causing injury and death. The Centers for Disease Control and Prevention has already warned that cannabis causes harm to developing young brains, including difficulty thinking and maintaining a healthy social life.

"The Attorney General's Office spent months coming up with this bill; yet, legalization remains a big problem. Our health department still has serious concerns about the public health impact due to the increased new forms of cannabis. It sees no benefit; only harm. Despite the strong regulatory requirements, DOH believes the public health and environmental impacts of adult recreational use will impact children born to mothers who use marijuana during pregnancy leading to attention problems, reduced cognitive functions, and decreased academic ability.

"The State Attorney General cautioned that, even with the bill's comprehensive regulatory framework, 'from a law enforcement perspective, the legalization regime is always subject to substantial risks, including the difficulty of ascertaining whether a person is driving while high to the very real health impacts especially on the youth' She said, 'I cannot support a bill legalizing adult-use cannabis irrespective of how well-crafted the bill may be.'

"For these reasons, I respectfully oppose this bill."

The motion was put by the Chair and carried, Stand. Com. Rep. No. 3057 was adopted and S.B. No. 3335, S.D. 2, entitled: "A BILL FOR AN ACT RELATING TO CANNABIS," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Ayes, 19; Ayes with Reservations (Aquino, DeCoite, Fukunaga, Kidani, McKelvey, Shimabukuro). Noes, 6 (Elefante, Fevella, Inouye, Kim, Moriwaki, Wakai).

Stand. Com. Rep. No. 3059 (S.B. No. 3068, S.D. 1):

Senator Dela Cruz moved that Stand. Com. Rep. No. 3059 be adopted and S.B. No. 3068, S.D. 1, having been read throughout, pass Third Reading, seconded by Senator Moriwaki.

Senator Dela Cruz rose to speak in support of the measure with reservations as follows:

"This measure tries to put together all the expenses for the Maui fire for the coming fiscal year, upcoming fiscal year '25. The Senate still has quite a bit of work to do to vet all of the different appropriations in the bill. In the committee report, we try to include all the expenses in the current fiscal year. The governor just sent down a governor's message over the weekend asking for approximately \$400 million more for '24. We've had a number of hearings, and we still have yet to ascertain what are going to be the complete costs for sheltering and hotels and what is the housing plan so that we can transition survivors from the hotels into housing programs. I'm hoping over the next couple of weeks we can work with the administration to get a better idea of what we can support to make sure that Lahaina residents can move on, and at the same time ensure that we have some fiscal restraint so that we can support all the residents of our state, so thank you."

The motion was put by the Chair and carried, Stand. Com. Rep. No. 3059 was adopted and S.B. No. 3068, S.D. 1, entitled:

"A BILL FOR AN ACT MAKING APPROPRIATIONS FOR WILDFIRE RECOVERY," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

Ayes, 25; Ayes with Reservations (Aquino, Chang, DeCoite, Dela Cruz, Elefante, Fevella, Gabbard, Hashimoto, Inouye, Kanuha, Keohokalole, Kidani, Kim, Lee, McKelvey, Moriwaki, Richards, San Buenaventura, Shimabukuro, Wakai). Noes, none.

At this time, Senator Keohokalole rose to speak on a point of personal privilege as follows:

"On Friday and again on Monday, the governor in two interviews criticized this body for questioning the spending plan for our continued Maui response. In relation to a question posed by a senator about whether trailers and tents from FEMA could be provided to survivors, the governor appears to have responded by characterizing the idea as 'creating refugee camps.' He said, 'I think people should be a little more thoughtful before making comments such as putting people in tent cities and trailers.' That was on Monday. I would like to note, Mr. President, that approximately 30 seconds later, the governor proceeded to talk about building kauhale everywhere in order to get a roof over people's heads and treat them in a humane way.

"This kind of distraction is not helping. If the governor's assessment is that we are not bleeding, then he should prove it by coming down and showing us because that's what it sounded like based off of his own budget director's report before the Ways and Means committee, and that's what it appears to be based off of the measure that we just voted on in support to fund the Maui recovery. We need to know the truth about what's going on, and we need to work collaboratively to find the answer. I honor his request to treat people humanely. This is hard. The Ways and Means chair has been working for a month to push for a long-term housing solution on Maui. We need long-term housing on Maui, but criticizing legislators for asking legitimate questions that have been validated by his own administration about how we as the Senate are going to fulfill our constitutional mandate to submit a balanced budget is not helping. If we're going to find a solution on this that's reasonable and transparent and in the best interest of the people of Maui and the people of Hawai'i, we need to be frank and we need to work together. That is what I believe we are trying to do in the Senate. Mahalo."

Senator Fevella rose to request that the remarks of the senator from Kāne'ohe be entered into the Journal as if they were his own, and the Chair so ordered (by reference only).
