

TWENTY-SEVENTH DAY

Thursday, March 7, 2024

The Senate of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2024, convened at 11:46 a.m. with the President in the Chair.

The Roll was called showing all Senators present, with the exception of Senators Ihara, Keohokalole, and Lee who were excused.

The President announced that he had read and approved the Journal of the Twenty-Sixth Day.

At this time, Senator San Buenaventura introduced the executive director of Full Life Hawai'i, Jim Kilgore, who had offered a moment of contemplation prior to the Senate's floor session, and Daintry Bartoldus and her staff at the Hawai'i State Council on Developmental Disabilities (DD Council), who had helped organize that day's advocacy and awareness event at the Capitol. Senator San Buenaventura added that March marked Developmental Disabilities Awareness Month, a time of amplified awareness about the abilities and strengths of individuals with developmental disabilities. Senator San Buenaventura explained that the year's theme was "A World of Possibilities," emphasizing the endless potential and opportunities that existed within the community. Senator San Buenaventura then introduced DD Council guests from Puna: Maelisa Evangelista, Robert Wong, Cheryl Obrero, and Dylan Kinoshita. Senator San Buenaventura also recognized Full Life participants, direct support workers, and staff who were present in the gallery: Noa Mano'i, Quentin Wong, Isaiah Wong, Nikki Graves, Stacey Ito, Sarah Week, Sia Talasinga, Dorothy Alapai, Dennette Sonoda, Greg Villafuerte Jr., Donna Ito-Villafuerte, Annie Craver, Paul Pascua, Jim Kilgore, Franz Weber, and Denise Lindsey. Senator San Buenaventura then welcomed self-advocates and their families who had come from Kaua'i, O'ahu, Moloka'i, Lāna'i, Maui, and East and West Hawai'i who were present in the gallery. Senator San Buenaventura described how that day's advocacy and awareness event enabled attendees to address issues and share concerns with legislators. Senator San Buenaventura noted that the DD Council had collaborated with the Alzheimer's Association to organize the event, and she encouraged members to visit the tables on the fourth floor to explore the array of services offered to the community and reaffirm their commitment to inclusivity to understand and support individuals with developmental disabilities.

Senator Moriwaki welcomed guests from the Alzheimer's Association, which had collaborated on that day's event with the DD Council. At this time, the Chair made the following comments:

“It was a difficult Tuesday morning, and on one of our confirmation votes, we wound up in a closely contested 13–12 decision not to confirm a nominee to the University of Hawai‘i Board of Regents, and it’s troubling to me that, last year, when two of the governor’s cabinet nominees faced opposition in the Senate to their confirmation, it was reported through the media and emails that we got, why aren’t we just giving him a chance? Shouldn’t the governor just be able to get who he puts in? And the resounding answer is simply ‘no.’ Our state constitution confers on the Hawai‘i State Senate the responsibility of advise and consent. It requires us as elected members of the Hawai‘i State Senate to do our due diligence and to review each candidate that comes under this advise and consent power. And on Tuesday, each of you did that job. Somehow, there have been allegations about strong-arming, arm-twisting, bullying of members, but if, in fact, that were happening, I don’t know how we get to 13–12. I don’t know how people would have the conviction to stand up and vote the way they see fit.

“It’s not lost upon me that one of the persons who filled in for a cabinet member we didn’t confirm is Director Tokioka, who has performed exemplarily during the Maui wildfires and in discharging the duties. I make no reference to the prior nominee, and who knows how he might have performed, but we did not think that was the right person, and the one we confirmed has validated the confidence that we put in him by exercising our advise and consent authority. There have been those who have disagreed with Chair Kali Watson at the Department of Hawaiian Home Lands, who we ultimately approved, but most of the reviews have acknowledged his innovation and the amount of work that he’s put in and the progress that has been made there, and, again, I feel validated in the vote that I cast.

“And until we get this constitutional authority removed, I continue to urge and applaud each and every one of you for taking your responsibility seriously and for voting your conscience—even when we come to a 13–12 vote, that you feel confident enough to cast your vote, which was really in doubt till the very end. As it turned out, the last vote cast was my own. And so, you know, I can’t stop what they write. I can only tell each and every one of you that I serve with to keep doing your job the way that you have been doing your job, and do not bend to the public trying to determine our action or characterize our action as anything other than carrying out our duties as ascribed by the constitution.”
