TWENTY-EIGHTH DAY

Friday, March 8, 2024

The Senate of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2024, convened at 11:34 a.m. with the President in the Chair.

The Roll was called showing all Senators present, with the exception of Senators Fukunaga, Ihara, Keohokalole, Kidani, and Lee who were excused.

The President announced that he had read and approved the Journal of the Twenty-Seventh Day.

At this time, Senator McKelvey introduced members of his staff who were seated in the gallery: John Chakos, who had offered a moment of contemplation prior to the Senate's floor session; Wendee Wilson; Beth MacKenzie; and Hulu Umiamaka.

The Chair commented that, if he were grading, he would grade the moment of contemplation an A-plus.

Senator DeCoite welcomed representatives from the Hawaii Automobile Dealers Association (HADA) who were at the Capitol for their annual Dealer Day.
