TWENTY-NINTH DAY

Monday, March 11, 2024

The Senate of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2024, convened at 11:33 a.m. with the President in the Chair.

The Roll was called showing all Senators present, with the exception of Senators Inouye, Lee, Richards, and San Buenaventura who were excused.

The President announced that he had read and approved the Journal of the Twenty-Eighth Day.

At this time, Senator Dela Cruz congratulated the Mililani High School boys varsity soccer team for their 2024 Hawai'i State Division I championship. Senator Dela Cruz then recognized the team, their student managers, and coach who were seated in the gallery. Senator Dela Cruz requested that the names of the players and student managers be entered into the Journal, and the Chair so ordered. Senator Dela Cruz then welcomed coach Steven McGehee.

Senator Kidani introduced Mililani High School athletes Belise Swartwood, girls Oahu Interscholastic Association swimming champion; and Moku Jackson, boys wresting state champion, who were joined in the gallery by their coaches and teammates.

Senator Elefante recognized former state senator Will Espero. Joining him in the gallery was his girlfriend, Lyra Johnson.

Senator Shimabukuro recognized constituents who were there to support the honorees on the floor: Representative Cedric Asuega Gates, who had brought drinks and paper goods for that day; Representative Darius K. Senator Shimabukuro then honored and congratulated the Westside Striking Club and Makaha Cultural Learning Center for uplifting and empowering the youth of the Wai'anae Coast, and presented the following remarks:

"We have the opportunity to recognize an organization which has committed its time and energy to provide a safe, afterschool opportunity for students to learn the dedication, discipline, and determination entailed in the sport of boxing. With us here today (please rise as I call your name), we have Coach Michael Talalotu; we have Izstyan Shirley and Tanoa Mahelona.

"The Westside Strikers Boxing Club determined that the highest risk of adverse behaviors in adolescents typically occurs right after school. It's at this time when teens often encounter gang activity, illicit drugs, petty theft, and other troubling experiences. With this in mind, Coach Michael Talalotu started and funded out of his own pocket the Westside Strikers Club, going on six years now, to allow anybody from the community to participate, but especially for our Westside youth. He builds their mind, their bodies, and the mana of their spirit. Additionally, he follows their school grades to make sure they are also meeting their academic responsibilities. He has been exceedingly successful at helping kids recognize their own selfworth, self-confidence, and self-esteem. He is the quintessential coach, mentor, and parental figure we all might have benefited from.

"With him in the audience, which is also part of the Westside Strikers—if you could please stand and remain standing till I call your name—we have Verlene Teulilo, Ikapote Teulilo, Izik Teulilo, Amanda Mahelona, Audrey Paaoao, Randy Paaoao, Mason Paaoao and Aidin Paaoao, Zion Stewart, Kaehzen Tolentino, Kekai Streadbeck, and everyone else here from the Westside Strikers Boxing Club, please stand, and let's welcome them to the Senate and congratulate them on all they've done. Thank you so much.

"Also, Mr. President, I also want to recognize our other honored guests who have joined us here on the floor (and please stand as I call your name and remain standing): We have Danielle Irwin, president; and Morisa Nakoa, board member. We are also gathered here to honor another wonderful organization in our community, the Makaha Cultural Learning Center. For almost a decade, this Native Hawaiian organization has been a critical training ground for Native Hawaiians and the people of the Wai'anae Coast, propelling them towards a future filled with promise and opportunity. With a bold vision for a world-class educational facility, the Makaha Learning Center is not just a classroom; it has become a true catalyst for change. By providing leadership, trades training, and outreach programs, they're not only breaking the cycle of poverty but also nurturing a culture of self-love and community pride. Their dedication to perpetuating the trades is not just about filling jobs; it's about empowering individuals with the skills they need to thrive. With every certification earned in alternative energy, construction, and other trades, these individuals are learning the skills they need to thrive and shaping a brighter future for generations to come. And they do all of this at no cost for participating students.

"We also have in the gallery Ryno Irwin, husband of Danielle (please stand); Miguel and Melanie Gonzalez; and Brian Silva. Please welcome and congratulate the Makaha Cultural Learning Center for being here today. Thank you."
