#### THIRTY-SEVENTH DAY

### Thursday, March 21, 2024

The Senate of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2024, convened at 11:42 a.m. with the President in the Chair.

The Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Thirty-Sixth Day.

At this time, Senator Fevella acknowledged family members of Nicholas Nishimura, who had offered a moment of contemplation prior to the Senate's floor session. Senator Kidani congratulated distinguished Hawai'i students, and presented the following remarks:

"While today marks the final day of our joint floor presentations for Education Week, presentations and events at the Capitol continue today and tomorrow. We have the pleasure of welcoming student honorees to the Senate floor who represent some of the brightest young minds of their generation and the future of our communities here in Hawai'i.

"Beginning with the Hawai'i delegates of the 2024 U.S. Senate Youth Program, I call upon the honoree's district senator from District 3, Senator Dru Kanuha."

Senator Kanuha rose to present the following remarks:

"The U.S. Senate Youth Program was created in 1962 by U.S. Senate Resolution 324 and has been funded by the Hearst Foundations. The merit-based program was established to further national youth education in the three branches of government and to emphasize the importance of democratic decisions and relationships throughout the world. Each year, only two delegates from each state are selected. It is with great pride that I acknowledge one of the student delegates, Lehua Norris. Please stand.

"Lehua Norris is a senior in my district at Konawaena High School in Kealakekua. She embodies the aloha spirit in her leadership style. Lehua has assumed multiple roles on her school's class council, including vice president, treasurer, historian, and secretary. Lehua has demonstrated her commitment to collaboration and cultural awareness as the secretary of the Hawai'i State Student Council, which represents over 170,000 Hawai'i public school students. She also serves as an officer on the Pacific and Asian Affairs Council, National Art Honors Society, and Student Credit Union. Her leadership extends to organizing local community outreach events focused on climate change and encouraging civic engagement among Hawai'i's youth. A passionate dancer of hula and 'Ori Tahiti, Lehua pursues interests in public service and advocacy through internships with local leaders.

"Please join me in recognizing Lehua Norris as one of Hawai'i's 2024 U.S. Senate Youth Program delegates.

"I now yield the floor to Senator Ihara."

Senator Ihara rose to present the following remarks:

"The Prudential Emerging Visionaries program, a collaboration between Prudential Financial and Ashoka, recognizes 25 young leaders aged 14 to 18 from all over the United States who are addressing financial and social challenges in their communities. This program celebrates inventive solutions to problems such as financial literacy, climate change, mental health, and refugee support. Awardees are selected for their innovation, potential impact, understanding of the issues, and commitment to inspiring change. This program is an evolution of the 26-year Prudential Spirit of Community Awards and extends internationally to Brazil, China, India, and Japan. I have the honor of recognizing this year's Prudential Emerging Visionary award recipient, Kylee Hamamoto. Could you stand, and could you stay standing?

"Kylee Hamamoto, a senior at Punahou School, is celebrated for her visionary leadership in creating WeGo! Hawai'i, a nonprofit aimed at empowering strong and independent female leaders. Her groundbreaking program has touched the lives of over 20,000 young women, equipping them with the necessary tools to discover their passion, boost their self-confidence, and launch initiatives that positively impact their communities. WeGo! Hawai'i offers a rich array of activities including networking opportunities, community projects, workshops, and a structured four-step process designed to nurture leadership skills. Beyond its local impact, WeGo! Hawai'i has achieved international reach, establishing chapters in California and several prefectures across Japan, creating a global network of

empowered women. Kylee's initiatives, deeply rooted in the values of aloha, kuleana, laulima, and mālama, have sparked 50 projects worldwide. These efforts address critical issues and champion gender equality, showcasing the far-reaching influence of Kylee's vision and leadership.

"Please join me in recognizing Kylee Hamamoto as our Prudential Emerging Visionary awardee.

"Thank you. Mr. President. I now yield the floor to Senator Awa."

Senator Awa rose to present the following remarks:

"I have the privilege of introducing the only public school student in Hawai'i to win the U.S. Presidential Scholar award last year. The award is one of the nation's highest honors a high school student can achieve. This student graduated with a GPA of 4.145—tops in her class—a valedictorian with a STEM Capstone, National Honor Society, and CTE awards. Representing Ka'a'awa, Hawai'i, by way of Kahuku High School, a freshman at Yale University—she speaks nearly four different languages, but her favorite word is 'yessah'—ladies and gentlemen, representing the pride of the North Shore, make some noise for Vaeanui Peck.

"A middle child stuck between two brothers, she ventured all the way to Connecticut for college, where she's studying mechanical engineering and renewable energy. Vaeanui is also involved with Bulldogs Racing, which is Yale's formula racing team. She's on the Indigenous Peoples of Oceania club for Pasifika students. She also has an eyebrow business up there and calls that her hidden talent. She's a country girl at heart—Vaeanui loves surfing and sewing swimsuits. She also has a pet chicken named Stella, so I'm not the only one in here who supports the chickens. Thank you for being here.

"In Kahuku, athletes get these [holds up red "K" letter patch with white border] all the time; scholars should, too. Vaeanui, this is yours. Congratulations. Please give her a warm welcome to the Senate.

"And I now yield the floor to Senator Chang."

Senator Chang rose to present the following remarks:

"The annual LifeSmarts consumer education competition is a game show-style contest that tests students on their knowledge of personal finance, health and safety, the environment, technology, and consumer rights and responsibilities. The LifeSmarts program, run by the National Consumers League, is sponsored in Hawai'i by the Department of Commerce and Consumer Affairs, Business Registration and Insurance Division, in partnership with the Hawaii Credit Union League. LifeSmarts is a free educational program that prepares students to enter the real world as smart consumers by teaching them the skills they need to succeed in a modern global marketplace.

"Three teams from O'ahu schools took top honors in the 20th annual statewide competition, and two teams are joining us here today. I am thrilled to acknowledge Kalani High School, the first-place winner of the 2024 LifeSmarts competition. Please rise.

"In the statewide final hosted at the University of Hawai'i at Mānoa's Campus Center Ballroom, Kalani High School emerged victorious. The deserving students of the Kalani High School team—Brandon Tran, Andy Chen, Michelle He, Kyla Iglesia, Mason Vuong, and coaches Mike Zane and Susan Hori—won a first-place victory at the annual LifeSmarts consumer education competition. Congratulations.

"I now yield the floor to Senator Aquino."

Senator Aquino rose to present the following remarks:

"I have the tremendous opportunity and honor of recognizing our last floor presentation of the 2024 Education Week program, the third-place winner of the 2024 LifeSmarts competition, Waipahu High School. Please rise.

"Please join me in congratulating the deserving students of the Waipahu High School team—Reagan Chinen, Ross Angel Bagaoisan, Stephanie Menor, Jordan Nguyen, and Joybel Parinas and assistant principal Algerico Uganiza Jr.—on their third-place victory at the annual LifeSmarts consumer education competition. Congratulations.

"I now yield the floor back to Senator Kidani."

Senator Kidani rose to present the following remarks:

"I would also like to take a moment to recognize the secondplace winners of the 2024 LifeSmarts competition from Maryknoll School, who could not join us today. We are tremendously proud of their dedication to their education and their preparation for the competition. Senate President, may I request that the names of the first-, second-, and third-place winners of the LifeSmarts competition be entered into the Senate Journal?

"Also, I would like to recognize the second U.S. Youth Senate Program delegate for Hawai'i, Ahryanna McGuirk, who could not make it today. She is currently attending an orientation at the University of Virginia after being awarded the prestigious Jefferson Scholarship. We are proud of her achievement as the first Jefferson Scholar from our state in years. Ahryanna is a senior at Kalāheo High School and currently serves as the student member on the Board of Education. She volunteers on the Youth Leadership Council for Make-A-Wish Hawaii and founded O'ahu's first-ever high school Wish Club, granting wishes for children with critical illnesses. She is an accomplished athlete and musician and is working towards her private pilot license.

"Colleagues, today's honorees are an important reminder of the profound kuleana we have in nurturing our keiki as they are the future of our state. While this concludes our 2024 Education Week floor presentations, festivities continue today and tomorrow. This afternoon from 1:00 to 3:00 p.m. in the Capitol Auditorium, guests will have the opportunity to learn about the Leadership Institute's strategies for creating a pipeline for teachers through leadership development and bridging the gap between administrators and educators. Lastly, tomorrow, Hawai'i Children's Action Network will be hosting an Early Learning Day Rally in the Rotunda.
