THIRTY-EIGHTH DAY

Friday, March 22, 2024

The Senate of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2024, convened at 11:35 a.m. with the President in the Chair.

The Roll was called showing all Senators present, with the exception of Senator McKelvey who was excused.

The President announced that he had read and approved the Journal of the Thirty-Seventh Day.

At this time, Senator Gabbard welcomed students and teachers from the Ulu A'e Learning Center, an alternative afterschool program on the Leeward side. Senator Gabbard explained that the students were at the Capitol to learn about the legislative process. Seated in the gallery were students Ezekiel Abbey, Eleu Larsen, Lily Larsen, and Carson Leong-Kailihiwa from the Kalihi campus of Kamehameha Schools; Nakili Enos-Tamanaha from Pearl City Middle School; Aukana'i Bartels from Ho'okele Elementary School in Kapolei; Rev Tagupa from DreamHouse 'Ewa Beach Middle School in Kapolei, and Rocco Silva from Honouliuli Middle School; Kumu Kamaka Cardines, the program assistant; and Mr. Tyler Tagupa.

Senator Inouye introduced Mele Kāneali'i, a 2023 graduate of Molokai High School and current freshman at Hamilton College in upstate New York who had been interning in her office. Senator Inouye noted that Ms. Kāneali'i was studying public policy and that she intended to return to Hawai'i to serve as a policy analyst or legislative attorney. Senator Inouye explained that Ms. Kāneali'i was passionate about Native Hawaiian land and water rights, access to language revitalization programs, and securing affordable and reliable air service for Moloka'i and Lāna'i. Senator Inouye added that Ms. Kāneali'i had shepherded the Water and Land committee during her time at the Senate. Joining Ms. Kāneali'i in the gallery was Senator Inouye's office manager, Tammie Kotani of 'Aiea.

The Chair thanked Ms. Kāneali'i for ensuring that all of the Water and Land committee reports had been decked on time the previous evening.

Senator Fukunaga acknowledged Mr. Pieper Toyama, who had offered a moment of contemplation prior to the Senate's floor session, and his brother Barney. Accompanying them in the gallery were members of Senator Fukunaga's staff: office manager Tercia Ku and Rochelle Gregson. Senator Fukunaga then recognized a visitor from Seattle as well as Naomi Yanagishita, a former staffer who was with the state Department of Health, who were present in the gallery.

On behalf of Senate President Kouchi, Senator DeCoite introduced visitors from the Kaua'i County Clerk's office. Seated in the gallery were County Clerk Jade Fountain-Tanigawa and staff Christiane Nakea-Tresler, Jenelle Agas, Allison Okasaki, and Randall Machado.
