Wednesday, April 3, 2024

The Senate of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2024, convened at 11:39 a.m. with the President in the Chair.

The Roll was called showing all Senators present, with the exception of Senators Fukunaga, Ihara, Kidani, and McKelvey who were excused.

The President announced that he had read and approved the Journal of the Forty-Third Day.

At this time, Senator San Buenaventura announced that that day was Massage Awareness Day at the Capitol and invited the members to go to the fourth floor for a massage to relieve stress, improve mental alertness, and reduce muscle tension. Senator San Buenaventura reminded the members to bring a \$5 donation as all proceeds would benefit the Hawai'i Foodbank. Senator San Buenaventura then introduced Adele La Fever, American Massage Therapy Association (AMTA) Hawaii Chapter president; Gwen DeLuze-Coria, AMTA Hawaii Chapter community outreach coordinator; Sterling Coria, AMTA Hawaii Chapter financial administrator; Dustin Ebesu, a former classmate, of Associated Bodywork and Massage Professionals; Arlene Estrella; Connie Cadiz; Denise Dixon Faris; Penn Calligan; Kathy Julia and Barbara Hart of the Quantum School of Massage and Holistic Healing; and students Andrea Kamahele, Aaron Pocheco, Wendee Remigio, Nathalie Wilda, Katie Fischer, Caylee Takafugi, who were all donating their time and volunteering for stress relief and for the Hawai'i Foodbank.

Senator DeCoite recognized and congratulated the Boys & Girls Club of Hawaii – Youth of the Year finalists, and presented the following remarks:

"It is my honor to present to you the four Youth of the Year finalists that are in the running to become the 2024 Boys & Girls Club of Hawaii State Youth of the Year.

"Since 1947, Youth of the Year has been Boys & Girls Clubs of America's premier recognition program. Candidates are outstanding members 14 to 17 years of age who exhibit exceptional leadership skills and academic and outstanding service to the club and their community. Youth of the Year is the Boys & Girls Clubs' highest honor, a recognition and awards program that acknowledges outstanding members in the clubs. The Youth of the Year Academy program helps young people develop their leadership and communication skills through an extensive application and interview process that is held during the annual competition.

"I would like to call upon the senators who represent these four amazing youths to share about their accomplishments and how they have become Youth of the Year finalists. I now yield the floor to the senator from 'Ewa Beach, Senator Fevella."

Senator Fevella rose to present the following remarks:

"I would like to recognize the 2024 Hawaii State Youth of the Year finalist coming from the Hale Pono Clubhouse in 'Ewa Beach, Ms. Jianna Johnson.

"Jianna Johnson has been with the Boys & Girls Club of Hawaii Hale Pono Clubhouse for more than nine years. Along with her achievements at the Boys & Girls Club, Jianna excels in academics and in leadership positions. Her accomplishments have earned her the honor of being one out of four Youth of the Year finalists. "Jianna is currently a senior at James Campbell High School—go, Sabers—and maintains a 3.5 GPA. (We never did have that when I was going to school or maybe we did—and I never did know.) But, anyway, she is a member of the multicultural club, Health Occupations Students of America, and is the president of the Hispanic Honor Society.

"At the Boys & Girls Club Hale Pono Clubhouse, Jianna was the president of LIT (Leaders in Training) from 2021 to 2022. In the LIT program, youth learn the virtue of responsibility, self-discipline, and teamwork. LIT participants assist young club members, lead recreational activities, and provide additional support when needed at the clubhouse.

"Jianna is heavily involved in community service. She has participated in an Alaska service project, Hispanic Honor Society fundraiser, and assists in cleaning of native lands.

"Colleagues, please join me in congratulating the 2024 Hawaii State Youth of the Year finalist representing the Hale Pono Clubhouse in 'Ewa Beach, Ms. Jianna Johnson. Thank you, Jianna Johnson.

"I would like to turn the floor over to the senator from Maui, Senator Hashimoto. Thank you, guys, and God bless."

Senator Hashimoto rose to present the following remarks:

"On behalf of Senator McKelvey, it is my honor and privilege to recognize the 2024 Hawaii State Youth of the Year finalist from the Lahaina Clubhouse, Mr. Christopher Leslie. Please stand; thank you.

"Christopher has been with the Boys & Girls Clubs of Maui Lahaina Clubhouse for five years. Along with his achievements at the Boys & Girls Club, Christopher is active in giving back to his community. His accomplishments have earned him the honor of being one of four Youth of the Year finalists.

"Christopher is currently a senior at Lahainaluna High School and is a member of the boys volleyball team. At the Lahaina Clubhouse, Christopher is the president of the Keystone Club, where youth participate in three focus areas: academic success, career preparation, and community service. Through the Keystone Club, he has had the opportunity to travel to Anaheim, California, and Dallas, Texas.

"Christopher is heavily involved in community service. A few events he has volunteered for include the La Ohana Mahalo First Responders Event, Maui AgFest, and the Lahaina Clubhouse Halloween and Thanksgiving events, just to name a few.

"Colleagues, please join me in congratulating the 2024 Hawaii State Youth of the Year finalist representing the Lahaina Clubhouse, Mr. Christopher Leslie.

"I now turn the floor over to the senator who represents Joint Base Pearl Harbor, Senator Wakai."

Senator Wakai rose to present the following remarks:

"Members and President, I am delighted to recognize the 2024 Hawaii Youth of the Year finalist from the Joint Base Pearl Harbor–Hickam Teen Center, Mr. Rylee Wellbaum. Rylee, if you could please stand.

"Rylee has been with the Boys & Girls Clubs of Hawaii Joint Base Pearl Harbor–Hickam Center for two years. Along with his achievements at the Boys & Girls Club, Rylee excels academically and in leadership positions. His accomplishments have earned him the honor of being one of four Youth of the Year finalists. "Rylee is currently a junior at Radford High School and maintains a 3.7 GPA while taking AP courses such as AP macroeconomics and AP English language arts. He is the founder and vice president of the business club and is involved in JROTC.

"Rylee is a National 4-H youth delegate. The 4-H program gives youth many opportunities to build confidence, learn responsibility, and develop skills that will last them a lifetime. It fosters an innovative, 'learn by doing' approach and helps youth to make positive differences in their communities. In his community, he has volunteered in various trash cleanups with Radford High School and the Surfrider Foundation.

"Colleagues, please join me in congratulating the 2024 Hawaii State Youth of the Year finalist from the Joint Base Pearl Harbor–Hickam Teen Center, Mr. Rylee Wellbaum.

"I know turn the floor over to the senator who represents Schofield Barracks, Senator Dela Cruz."

Senator Dela Cruz rose to present the following remarks:

"Mr. President and colleagues, it's my privilege to recognize the 2024 Hawaii State Youth of the Year finalist from USAG Hawaii CYS Services Bennett Youth Center, Ms. Jakhilah Barnes. She's not here today (she has a previous engagement), but I'd just like to read her certificate.

"Jakhilah has been with the Boys & Girls Club of Hawaii Hale Pono Clubhouse for three and a half years. Along with her achievements at the Boys & Girls Club, Jakhilah excels academically and in leadership positions. Her accomplishments have earned her the honor of being one of four Youth of the Year finalists.

"Jakhilah is currently a freshman at Leilehua High School and maintains a 4.0 GPA. She is in the Student Council Leadership Club and is on the track team. In her community, she has volunteered with Wreaths Across America and Fish House Food Drive.

"At the Boys & Girls Club, she is involved in various clubs, such as the writing club, cooking club, drama club, Torch Club, and the Keystone Club, just to name a few. The Keystone Club is a program that provides leadership development opportunities for youth. They participate in activities in three focus areas: academic success, career preparation, and community service.

"Colleagues, please join me in congratulating the 2024 Hawaii State Youth of the Year finalist representing USAG Hawaii CYS Services Bennett Youth Center, Ms. Jakhilah Barnes.

"I now turn the floor back to the senator from Moloka'i."

Senator DeCoite rose and stated:

"Mr. President, as you can see, we have four very impressive individuals standing before us today. As Youth of the Year finalists, each one of them is actively doing their part to make their communities better, and that is exactly what the Youth of the Year program is all about.

"Candidates who have competed in the Youth of the Year Academy and competition have gone on to great success and are proof of the impact clubs make in transforming and saving kids' lives.

"Mr. President, tomorrow, one of these amazing youths will be named the 2024 Hawaii State Youth of the Year and then will go on to compete in the Pacific Regional competition this summer. "We are proud of all of you and extend our warmest aloha along with our best wishes for your health, happiness, and continued success.

"Mr. President, the four finalists for the 2024 Boys & Girls Clubs of Hawaii Youth of the Year title: Ms. Jianna Johnson, Mr. Christopher Leslie, Mr. Rylee Wellbaum, and Ms. Jakhilah Barnes. Mahalo!"
