### FORTY-FIFTH DAY

### Thursday, April 4, 2024

The Senate of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2024, convened at 11:46 a.m. with the President in the Chair.

The Roll was called showing all Senators present, with the exception of Senators DeCoite and Fevella who were excused.

The President announced that he had read and approved the Journal of the Forty-Fourth Day.

At this time, Senator Kidani recognized family members of Mary Janell Murro, a member of her staff who had offered a moment of contemplation prior to the Senate's floor session. On motion by Senator Rhoads, seconded by Senator Gabbard and carried, H.B. No. 2513, H.D. 1, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO EXPUNGEMENT," having been read throughout, passed Third Reading on the following showing of Ayes and Noes:

H.B. No. 1800, H.D. 1, S.D. 1:

Senator Dela Cruz moved that H.B. No. 1800, H.D. 1, S.D. 1, having been read throughout, pass Third Reading, seconded by Senator Moriwaki.

Senator Dela Cruz rose to speak in support of the measure as follows:

"Mr. President, I'd like to begin by thanking you, Senate leadership, the Senate subject-matter committee chairs, and the Committee on Ways and Means. Mahalo for your leadership and assisting the Ways and Means committee in crafting a package of bills that reflect the priorities of this body. Taken together, the budget bill and other pieces of legislation which are critical appropriates the resources requested by the administration for Maui wildfires survivors and recovery efforts while addressing long-standing challenges that have persisted for decades, including diversifying exports and opportunities for workforce development to ensure economic resilience in the face of uncertainty, funding shortfalls for service providers that fill gaps in the continuum of care for at-promise communities, and protecting and preserving Hawai'i's unique ecosystems to perpetuate the integrity of our land.

"This session, the constantly changing landscape of federal support for Maui wildfire recovery required diligence and dedication to provide both the immediate and future needs of Maui wildfire survivors. I thank each of my colleagues for spending many hours discussing and collaborating with cabinet members and other stakeholders to fully grasp the gravity of the situation. We dedicated funding for Maui in separate bills outside of the budget bill also up for third reading today. This was done to increase public transparency and government accountability in how these funds are spent. House Bill 679 covers Governor's Message 4 by appropriating \$362 million in fiscal year '24 for wildfire-related costs, such as non-congregate sheltering, and \$65 million for the One 'Ohana Fund. House Bill 2610 reflects the administration's original request for response recovery efforts by appropriating over \$450 million in fiscal year '25. Senate Bills 582 and 3068 also crossed over earlier this session and contained similar language. We look forward to continuing working with the administration to overcome this catastrophe.

"Your Committee on Ways and Means has the tremendous responsibility of budgeting for the entire state. Response and recovery efforts are profound, but the promise and potential of our people is unsurpassed. I am proud to present a solutionoriented budget that amplifies the assets and values of the place we call home. The proposed budget aims to ensure that our keiki have access to high-wage jobs by expanding the Hele Imua internship program to recruit and retain a skilled workforce for state government, earmarking workforce development opportunities for regenerative tourism to increase the number of local executives in hospitality and ensure sustainability in destination management, and enhancing the healthcare pathway programs for neighbor islands to foster medical professionals for our small and rural communities. We remain resolute in our commitment to reverse the brain drain and provide a future for our families to live, work, learn, and play in our own communities.

"Your Committee on Ways and Means finds it imperative to reduce recidivism and disrupt pathways to poverty and prison. The prosperity of our state begins with the holistic health and well-being of our people: funds for cost-of-living adjustments for contracts that provide safety-net services, like homeless outreach, mental health programs, and emergency medical services; funds for employment opportunities for inmates that ease their reintegration into society and help keep our highways safe; and funds for the Hawai'i State Hospital and the DOE's multi-tiered system of support to ensure a continuum of care for most of our vulnerable communities. Altogether, these appropriations reaffirm our standing as a trauma-informed state.

"Your Committee on Ways and Means understands the importance of protecting our precious resources and supporting local farmers. Without controlling and eradicating invasive species, our agricultural tourism and natural ecosystems could collapse beyond repair. That's why we made historic appropriations, both within and outside the budget bill. Your Committee on Ways and Means inserted dedicated funding for biosecurity in House Bill 2619 to equip the Department of Agriculture to proactively mitigate the spread of invasive species at our points of entry and to combat a wide variety of pests that threaten the state's biosecurity, including coconut rhinoceros beetle, little fire ant, and coqui frog. In the Senate draft of the budget, we include appropriations to tackle the current climate and environmental crisis that jeopardize our food systems, including funding to repair and maintain parks statewide; protect native forests to help mitigate the impacts of climate change; and institutionalize pathways for local farmers to deliver Hawai'i-grown produce and commodities to all, including low-income families, and for local entrepreneurs to scale up and export their value-added products to markets in Hawai'i and across the globe.

"There are many noteworthy priorities that are addressed in the Senate's budget, but with our limited time, I'll end with sharing a few more critical budget appropriations. The remaining adjustments can be found in the budget worksheets. Funding for long-overdue technology modernization projects for various departments and agencies which improves efficiencies for state government and enhances services for the general public: The Senate draft includes technology modernization projects for DCCA, DAGS, DOE, DOA, DOTAX, DHS, and DHRD. With increasing operating costs and growing demands for state-funded programs and services, the Senate's approach strategically budgeted to draw down federal dollars with state matching funds to facilitate public-private partnerships and encourage select programs to expand entrepreneurial and commercial activities and, finally, to utilize special and revolving funds to promote financial sustainability. Additionally, we deployed several cost-saving strategies to maximize government efficiencies and reduce government spending. For example, department vacancies were reduced to offset new positions; lease rent funds were appropriated on nonrecurring basis to better align with telework policies and reduce lease office spaces; and utility funds, including for electricity, were appropriated on a nonrecurring basis to help

reach our renewable energy goals. Mr. President, I would like to request that the budget PowerPoint presented to the Senate also be entered into the Journal." (The Chair so ordered.)

The Chair having so ordered, the budget PowerPoint is identified as "ATTACHMENT A" to the Journal of this day.

Senator Dela Cruz continued:

"In conclusion, mahalo to Senate subject-matter chairs for their countless hours spent meeting with departments and asking critical questions on hundreds of budget requests, the Ways and Means committee members for their bold leadership in developing a solution-oriented budget, and the vice chair and her team for crafting the CIP budget. And, lastly, thank you to the Ways and Means budget staff for their unwavering dedication and perseverance in putting together the Senate draft of the budget. I'd like to introduce committee clerk Scott Fuji; budget chief Colin Peros; budget analysts Parker Spencer, Alexander Ozawa, Carol An Nacario, Sean Herman, and Kathy Sokugawa; CIP specialist Malcolm Iwami; and office manager Dot Fujinaga.

"I urge my colleagues to support Senate Draft, House Bill 1800. Thank you."

Senator Moriwaki rose to speak in support of the measure as follows:

"I echo Ways and Means Chair Dela Cruz in thanking you, Senate leadership and colleagues, and the Ways and Means committee. I especially want to thank Chair Dela Cruz and our hard-working committee staff that you met for their support in designing this capital improvement budget.

"The CIP budget is this body's expression of our values and commitment to Hawai'i's future. Beyond the Maui response and recovery efforts, the CIP budget reflects this body's statewide priorities: health and safety, education, economic and workforce development, infrastructure, and affordable housing. You will see it in the budget, but some highlights are, the health of our community being foremost went to neighbor-island hospitals, critical biosafety lab repairs and improvements. It also includes safety and security considerations—outside siren warning systems and deferred maintenance of assets that cannot be deferred yet another year. A significant portion of the budget invests in our public schools: over \$570 million to renovate and improve classrooms and buildings, to ensure campus safety, and to upgrade athletic fields and playgrounds; and \$73 million for the University of Hawai'i, community college, medical school, and university research improvements. The budget also recognizes the importance of diversifying Hawai'i's economy through investments in technology, healthcare, tourism, and agriculture. Specifically, regarding agriculture, value-added processing and storage spaces to support farmers to bring their products to market. And included is over \$30 million to modernize our state's financial system. We cannot grow our economy and maintain and develop a thriving workforce without a major infusion of affordable housing. A large infusion of \$180 million for the Rental Housing Revolving Fund, \$45 million for teacher housing statewide, and an additional \$63 million for renovations to the University of Hawai'i's student housing facilities. Overall, our team focused on our state's critical infrastructure, health and safety needs, our economic growth, and investing in a strong foundation for our

"This fiscally responsible budget represents the hard work of many. I again thank my colleagues, Ways and Means Chair Dela Cruz and his staff, and my staff. I'm going to reintroduce CIP staff Malcolm Iwami, who does double time; Randall Tanaka; Charles Izumoto; and Venus Delos Santos. Please rise and be recognized; mahalo. Thank you, Mr. President."

The Chair made the following comments:

"Before calling the vote, I would express my thanks to Chair Dela Cruz, Vice Chair Moriwaki, the Ways and Means committee and staff for your diligent work. I think we'd be remiss if we didn't also acknowledge the administrative employees who worked closely with Chair Dela Cruz so that we could get the numbers that we needed, especially in trying to determine what was going to be needed and the best way forward to assist those who were affected by the fires in Maui. And I know that the budget is so large and there are so many things that we could talk about for hours, but I did want to acknowledge to Chair Dela Cruz that he did pay attention to make sure that the summer feeding program as well for the children of Hawai'i would be funded and in place, and I think that's critically important as we try to support in education to make sure that, when they're there, they are well fed to get the best results."



The Governor submitted a supplemental budget for FY25. The Governor has sent down three GMs since, requesting additional funds in both FY24 and FY25. The largest expense within the GMs is for unanticipated costs related to the August 2023 wildfires.

## 3. Major Impacts to the Budget and Financia Plan: Maui Wildfire Recovery and Rebuilding

- The August 2023 Wildfires resulted in at least 101 fatalities and over 4,000 households displaced from housing. The immediate costs for
  sheltering have been borne by the State and per the administration will continue to be borne by the State until temporary or permanent
  housing can be constructed to rehouse displaced households. The administration moved approximately \$194,000,000 into the Major Disaster
  Fund (MDE) by sweeping \$164,000,000 from Departments and moving \$30,000,000 from the Governor's Discretionary Fund. Budget and
  Finance is also sweeping 5% contingency, roughly \$64,000,000, from Departments to make up additional shortfalls. GM4 seeks an additional
  \$297,000,000 for direct wildfire costs and \$65,000,000 for the One Ohana Fund.
- A breakdown of current obligations for non-congregate sheltering (NCS), temporary/permanent housing, and other wildfire expenses was
  provided from the Administration during the 02/29/24 WAM Info-briefing and is as follows:
- \$500,000,000 for American Red Cross (ARC) contract (NCS)
- State must obligate all costs upfront; eligible for 90/10 cost-share with FEMA for reimbursable households
  - State cost-share ~\$247,000,000
- \$105,000,000 for DHS Group Site Kala'iola, formerly Leiali'i (Temporary Housing)
- Hawaii Community Foundation is pledging \$40,000,000 to assist with infrastructure expenses related to the site
  - \$17,500,000 for DHS Rental Assistance Program (Temporary Housing)
- \$66,716,070.73 for MC-1 costs
- \$65,000,000 for One 'Ohana Fund
- FY24 Total Estimated General Fund Obligations: \$754,216,070.73
- This total does not include any cost overruns due to the need to house displaced households in NCS beyond June 2024. The current FEMA
  mission end dates of April 2024 for FEMA non-reimbursable and February 2025 for FEMA reimbursable.

## 3. Major Impacts to the Budget and Financial Plan: Hazard Pay

 Following the COVID-19 pandemic, bargaining units with hazard pay clauses within their contracts have begun negotiating with the State on payout for hazard pay.

• Per the 02/29/24 WAM informational briefing on the Administration Financial plan the current estimate from Budget and Finance has the anticipated total at \$299.7M in FY25.

## 3. Major Impacts to the Budget and Financial Plan: Green Affordability Plan (GAP, Phase 2)

 HB2404 is the Administration's latest tax relief measure that seeks to reduce income tax burdens on households, increase the child and dependent care tax credit, and conform certain other State tax codes with Federal deductions. This will result in a <u>reduction</u> to the tax revenues of the State.


