

## FORTY-SIXTH DAY

## Friday, April 5, 2024

The Senate of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2024, convened at 11:55 a.m. with the President in the Chair.

The Roll was called showing all Senators present, with the exception of Senators Fevella, Gabbard, and Kidani who were excused.
