In February, we convened a two-day summit bringing together champions from across the state and nation. Forty-three organizations pledged their commitment to work on this important issue.

"House Bill 2224 is the culmination of their work and the continuing work still ahead. It requires the EOA, in coordination with the State Health Planning and Development Agency, to create a comprehensive long-term care plan to address policy goals to achieve a full continuum of person-centered institutional and community-based services that are available, accessible and affordable.

"I urge my colleagues to vote yes on this very important measure."

H.B. No. 1580, H.D. 1, S.D. 1:

Senator Rhoads moved that H.B. No. 1580, H.D. 1, S.D. 1, having been read throughout, pass Third Reading, seconded by Senator Gabbard.

Senator Richards rose to speak in opposition to the measure as follows:

"Though I understand the intent, my concern is that we leave the door open as it affects animal agriculture. I've had a lot of contact with constituents, and as the state is striving towards food self-reliance, food security, the availability of protein is exceedingly important. I can see where the animal industry can supply this, and, going through the pandemic, that showed us how important it is to have the animal industry, so for that reason, I cannot support this measure. Thank you."

The Chair apologized to the members of the Minority Caucus for not informing them prior to the floor session that there would be no floor amendment offered on the measure and that there would be a vote taken on the measure instead.

Senator DeCoite rose to speak in opposition to the measure as follows:

"While the primary intent of the bill seems to be to deter and penalize acts of animal cruelty, there are potential aspects of H.B. 1580, H.D. 1, S.D. 1 that could affect animal owners or ranchers negatively. The bill proposes increasing penalties for various animal-cruelty offenses, including elevating some offenses to felony status. While this can be beneficial in deterring animal cruelty, it could also lead to harsher consequences for individuals who maybe inadvertently violate the law or engage in practices that are considered standard in their industry, such as certain methods of animal handling or husbandry. The bill includes provisions that restricts certain practices, such as tethering or restraining dogs in certain manners, which may be commonly used by ranchers or animal owners for managing their livestocks or pets. While these restrictions aim to prevent cruelty and improve animal welfare, it may also impact traditional methods of animal management and require adjustments in practices. With the introduction of stricter penalties and regulations regarding animal cruelty, there may be increased regulatory scrutiny and enforcement actions targeted at animal owners, including ranchers. This could lead to additional administrative burdens, compliance costs, and potential legal liabilities for individuals and businesses involved in an animal husbandry.

"Just last week, a woman's chickens were attacked, and 45 of them were killed by someone's dog. She also raises egg-layers and had been producing eggs for the island of Moloka'i. She shot the dog to protect her livestock and is now being accused of cruelty to animals. While some say self-defense, she now has to go to court and prove that it was not intentional. To take off time now to have to fight this out in court costs time and money and now having to replace her livestock.

"The bill's language may be open to interpretation, and there is a risk that certain people have concerns that the new provision in this bill could be misapplied or misinterpreted by authorities, leading to unintended consequences for animal owners or ranchers. Clarity and specificity in the language of the law are essential to ensure fair and consistent enforcement. While H.B. 1580, H.D. 1, S.D. 1 aims to address these concerns related to animal cruelty, it is crucial to consider the potential unintended impacts on animal owners, especially those in the rural areas, including ranchers, and ensure that the legislation strikes a balance between protecting our animal welfare and safeguarding the interests of responsible animal owners. Collaboration between lawmakers, animal-welfare advocates, law enforcement agencies, and industry stakeholders may be necessary to address some of these concerns effectively. For those reasons, I oppose this bill. Mahalo."

Senator Fevella rose to speak in opposition to the measure as follows:

"My opposition is, you know, when they use the terminology 'animal' and 'cruelty to animals,' when it comes to lifestyles, especially with families, that all of us enjoy family luaus. How did you think the pig got to the table? It didn't fall out and be kalua pig. There was a process of doing that meal by grabbing the pig, stabbing um in the throat, killing um, draining the blood (and then some people use the blood to eat), and enjoy the meal. So, by having this bill, somebody takes a picture of me—so when I first got married, the groom has to stab the pig in going forward, and I did that. My baby's first lū'au, I stabbed the pig, and we had done that.

"There are so many provisions within this bill that's gonna get law-abiding citizens to be criminals. One of um, I'll give you guys an example. My sister is the most loving person for animals—well, dogs, period. She went to the store, she left her dog on a line that she exercise every day, came out, and the dog was accidentally hung—hung in the air—off the ground. This bill would make my sister a felon on something that was accidental. Then, my grandfather, when I was a little kid, used to take me out into the field, and they used to call um 'mountain oysters.' I don't know if anybody know what mountain oysters is; it's bull balls. So when they used to go out there and castrate the bulls, we used to have a roundup, and then we used to cook um on the grill, and we used to do all of that. Was in the field. There's no person out there that's going to monitor how my grandfather castrate the baby calves or the bulls at the time.

"So, this kinds of stuff that, you know, I understand the intent of the bill: Basically, if somebody goes ahead and beats the dog to death, I understand that's cruelty. But when you specify 'animal,' that's a lot of things. Another one, again, same thing with grooming with your pets, right? A lot of guys cut ears, which is something that I'm gonna speak of later on. But get family guys out there cut the ears of the dogs; they've been grooming dogs generation after generation, but now, that gon' fall under cruelty to animals.

"This is the thing that a handful of people want to say what is cruel and what is not, what is humane and what not humane. And that's the thing right here as lawmakers: We got to weigh that out. As we grew up in Hawai'i, that's the multicultural thing that we lived in, but now society—when is it going to stop? Telling us what is the lines that we cannot cross? What is the barriers that we should not go across? Those are the things that, now, we're going to have neighbors turning in neighbors. We're going to have guys who don't like your dogs in your yard 'cause the thing bark too much—as soon as you go out there and do something, they call the cops on you. This is the society that we living in, and we as lawmakers are making these laws. Already hard to enforce the laws that we have. Right now, we get gambling houses. You get caught gambling in Hawai'i: misdemeanor. But you go ahead and stab one pig in the neck: felony. What is the just in that?

"So, in going forward, Senate President, I'm in opposition to this bill because we gon' be making our ranchers, our famers, our people that love dogs and animals (whatever you like call um) felons, and they gon' lose not only their jobs but their livelihood. So, again, thank you, Senate President, for your time, and I ask my colleagues to please oppose this bill. Thank you."

Senator Kidani rose to speak in opposition to the measure as follows:

"I rise in opposition and request that the words of the senator from Moloka'i be entered into the Journal as they were my own." (The Chair so ordered, by reference only.)

The Chair then called for a Roll Call vote.

Like I said, the feed-mom-and-pop stores depend on the amount of feed that we sell in the state depends on these industries that go ahead. Not everybody's a criminal-not everybody fights the chicken at a chicken-fight-but then this is going to be a broad thing that's going to be criminalizing anybody that has possession on the bird. So, again, I'm asking my colleagues to please not support this bill because it's too broad and it's going to make law-abiding citizens felons. Thank you, Senate President."

On the other hand, my serious concerns are on page 17, section 9, of the bill, which I'm unable to support, which have liability insurance minimums as blank. While I understand that it's been over 25 years since we changed the minimums, I don't believe the appropriate time is now to potentially increase minimums. In a time in which cost-of-living elements are increasing, insurance prices are going up, other costs are increasing, it would be difficult for me to support a bill that is unknown to the ratepayer. One testimony indicated costs could rise at an estimated cost per year between \$24 to \$67. Yes, that's less than a cup of coffee per month. In another testimony by the Hawaii Insurers Council, it indicated, '4 states including Hawaii have minimum bodily injury liability limits of \$20,000 per person/\$40,000 per accident.' I appreciate the chair of Transportation, Culture and Arts for placing in the Standing Committee Report 3344 suggested amounts which correlate with the average of what 34 other states are currently doing. However, at this time, it makes it difficult for me to vote on blank minimum amounts. We must ask ourselves as policymakers, do we want the unintended consequences of having more folks not insuring their vehicles? Do we want to see increased rates? For these reasons, I am unable to support H.B. 1539, and I'll be voting 'no.' Thank you."

Senator McKelvey rose to speak in support of the measure with reservations as follows:

"I'm going to rise with reservations for now in the hopes that the conference committees can clean this bill up. It's got so much going on, I don't even know where to begin. I mean, it's a Christmas tree and then some—I think it almost borders on being unconstitutional. However, there are some things in there that are good; there are some things in there my constituents think are horrible. Hopefully, they can be worked out, and this can become more focused and, to the previous speaker's comments, there can be some definitiveness given to the minimums. Thank you."

And then we're gonna pass this, knowing that we're gonna have infrastructure issues. So, again, this is the reason why I'm asking my colleagues not to support this bill. Thank you, Senate President."

"As this bill moved along, I was supportive of it. I grew some concerns after our colleague from the Big Island pointed out some issues. But in discussion with my community—and I think the previous speaker touched upon it—this bill could have some very serious unintended consequences, and so, at this point, I'm not gonna support this measure. This would be penalizing somebody—again, you gotta get caught; like everybody said, you gotta get caught. But you never know when you get one roaming neighbor that wanna come and penalize you 'cause they no like the dog. So, again, I cannot see this bill going through and passing because you're gonna make law-abiding citizens, again, criminals. So I'm asking my colleagues to please oppose this bill."

Senator Rhoads rose to speak in opposition to the measure as follows:

"I've introduced several bills over the years to raise taxes on the wealthy and the very wealthy, and this bill goes in the opposite direction. It doesn't affect anybody if they have an estate smaller than \$5.5 million (which is almost no one), and it also gives a tax break to people who are way above that in terms of wealth. So my personal feeling is that we're going the wrong direction on this one. Thank you."

Senator Dela Cruz rose to speak in support of the measure as follows:

"At one time, all 50 states had an estate tax. In 2006, 24 states had an estate tax. And in 2012, that number has fallen to 17 states. Today, only 12 states have estate taxes, and they continue to get phased out.

"The estate tax is imposed when someone dies. That's unpredictable. Public companies—those listed on the stock exchange—don't pay estate taxes and don't worry about them. Hawai'i family businesses are private companies. Unlike public companies, their shareholders and family businesses are one. Shareholders are not able to sell their shares easily, so the family business must loan funds to them and sell off parts or all of their businesses to provide funds. Local businesses face competition from much bigger and financially stronger public companies.

"Instead of estate taxes, those funds could invest in Hawai'i, create more jobs, expand facilities, improve products and services, thereby yielding additional excise tax, income, and property tax revenues. With those additional employees, the state will also generate more income and excise taxes from them. And the vendors and suppliers of growing family businesses and their employees would benefit and also pay more taxes. We're talking about companies like City Mill, Big Island Subaru and Big Island Toyota, Easy Music Center, L&L Hawaiian Barbecue, HPM Building Supply, Goodfellow Bros., ALTRES, Y. Hata, HONBLUE, Zippy's, Jade Dynasty Seafood Restaurant, Kauai Vehicle Service Center, Mana Up Hawai'i, Kamaka Ukuleles, Ace Hardware, Ben Franklin, Honolulu Disposal Service, McCully Bike & Sporting Goods, Liliha Bakery, ABC Stores, Oahu Veterinary Clinic, Finance Factors, Hawaii National Bank, Petland, Martin & MacArthur, Ace Auto Glass, KTA Super Stores, Highway Inn, Island Insurance Companies, Foodland, and Sae Design Group on Maui. So, for these reasons, I ask my colleagues to support the bill. Thank you."

Senator Richards rose to speak in support of the measure as follows:

"I'd like to have Senator Dela Cruz's words entered as my own, and just to reinforce that: When I look at the family businesses that I've dealt with over the generations I've seen here, I seek them out purposely because I know they reinvest into our state, into our economy. They supply the jobs for our people, and their biggest concern is not just making a dollar but supporting the community and building for the future. So, for those reasons, I ask my colleagues to support 2653."

Senator Keohokalole rose to speak in support of the measure as follows:

"I'd like to share an email that I sent to a constituent two days ago who read an article in a local paper about this bill, and this was my reply:

Thank you for your email. While this measure, S.B. 3289, is far from a foregone conclusion, I can say that there are aspects of the bill that were not included in the media reports on it. One of them is the fact that this bill will further prevent separation of old kama'āina families, including many Native Hawaiian families, from being forced to sell their ancestral lands to raise cash to pay taxes. My family is one example. I grew up in the '90s on Waikalua Road in Kane'ohe on 'ohana lands that contained one single multi-acre lot that my great-grandfather, John Kepono Hoapili, built 10 homes on. Those homes were subsequently divided among the four brothers and sisters, including my grandmother, Emma Keohokalole. And at the time I grew up on that lot, there were 40 grandchildren in my generation that either lived on those homes or commuted there so that they could be babysat. We all grew up together. Ownership of that lot has run in my family since the Great Māhele. Over the last 30 years, all but two homes on that lot were sold in a series of subdivisions and divestments after the deaths of kūpuna in the family triggered estate settlements, including tax payments that required cash. Like many old kama'āina and Native Hawaiian families, our family was mostly land-rich and cashpoor. My brother, who owns my grandmother's home now with my dad and my mother, and my cousin Mika, whose brother and sister live with him in the house behind us-my grandmother's houseare the only cousins in that generation that are left on that plot of land on Waikalua Road in Kane'ohe. Without the security that landownership provides, many in my family have subsequently moved away. That original 10-home, multi-acre lot in the middle of Kāne'ohe on the island of O'ahu is worth far more than the estate tax limit.

"So, as noted by the WAM chair, this bill will address many issues, including the one I just articulated. It will also help, as he noted, with the passage of legacy businesses within local families. These processes, as noted in reports, will likely result in the foregoing of tax revenue from families with substantial assets but also not necessarily cash means. From that perspective, this is a difficult issue that I'm wrestling with, but I will also say that those who stand to benefit from this bill are not the wealthiest among us in Hawai'i, although they are likely wealthy. The wealthiest are by and large not state residents. They mostly don't fall within this estate tax scenario and are actually benefiting tremendously from the advantages our state system provides to the ultra-wealthy.

"For those reasons, I've pursued many efforts related to progressive land taxation and empowering the counties, for example, to take better action or more aggressive action around regulating land use themselves, like regulating short-term rentals. It is also part of the reason why I agreed to hold a hearing on a bill that obtained 2,500 pieces of testimony from residents who were frustrated and angry about having to compete with global outside wealth and power to acquire land assets in Hawai'i. So that's why I support this bill and I worked to pass it out of committee, and I will continue to support it and ask my colleagues to join me in that effort. Thank you."
