FORTY-EIGHTH DAY

Thursday, April 11, 2024

The Senate of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2024, convened at 11:32 a.m. with the President in the Chair.

The Roll was called showing all Senators present, with the exception of Senator Ihara who was excused.

The President announced that he had read and approved the Journal of the Forty-Seventh Day.

At this time, Senator Richards welcomed the Grammy Award-winning and Nā Hōkū Hanohano Awards nominee Honoka'a Jazz Band, a group of advanced high school musicians who have upheld a tradition of excellence on the Big Island since 1978. Senator Richards explained that what started as a small ensemble of 13 students expanded to 42 under the guidance of Gary Washburn, a dedicated educator and accomplished jazz musician, and that the band is considered one of the top high school bands in the state. Senator Richards noted that, for the first time since the COVID-19 pandemic began, the band was touring O'ahu. Senator Richards then invited the members to a concert experience that afternoon at 2:00 p.m. Seated in the gallery were band members Alexander Santiago, Brandon E. Gonzalez, Chance Kim, Cheyne Ah Puck, Daniel A.Candelario, Gabriel Motas, Jhaycee Khazheima Queja, Jilleane Marie Gonzales, Jurrel Bielza, Kaile Hinokawa, Kalan Matsumoto, Kaysen K.K Takamine, Khamryan Bragado, Reese Todd, River Aitken, Sante K.Ragpala, Seda Lee, and Sunny Zook and band director Gary Washburn.

The Chair noted that his mother was a proud alumna of Honoka'a High School.

Senator Dela Cruz introduced the bills staff members of the Committee on Ways and Means who were present in the gallery: committee clerk Scott Fuji; bills chief David Cho; legislative aides Emma Shirai, Akira Pescador, and Allurie Almogela; and bills researchers Sean Companion, George Hooker, and Netty Leviticus.
