FORTY-NINTH DAY

Friday, April 12, 2024

The Senate of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2024, convened at 11:37 a.m. with the President in the Chair.

The Roll was called showing all Senators present.

The President announced that he had read and approved the Journal of the Forty-Eighth Day.

At this time, Senator Keohokalole recognized teachers, chaperones, and second- and third-grade students from Le Jardin Academy's kāhuli hui advocacy club who were seated in the gallery. Senator Keohokalole noted that the visitors had attended the signing of the kāhuli snail bill earlier that day.

Senator DeCoite, on behalf of the Maui delegation, introduced dedicated teachers and Hawai'i State Teachers Association members from Maui who were present in the gallery: Hillary Watt, special education teacher for the Baldwin–Kekaulike–Kūlanihāko'i–Maui Complex Area; John "Fitz" Fitzpatrick from Kūlanihāko'i High School; and Carol Holland from Maui High School.

Senator Elefante, on behalf of the Filipino Caucus, welcomed Jeff and Carol Yaranon, who were visiting from the Philippines and celebrating their 25th wedding anniversary. Accompanying them in the gallery were Virginia "Virgie" Mabellos from the Senate Clerk's office; her sister Marjorie Madamba; and her niece Erica Yaranon.

Senator Ihara introduced a group of students from 'Iolani School who had advocated for House Bill 1899, which designated certain native snail species as official state snails. Senator Ihara noted that the bill was part of the Year of the Kāhuli campaign proclaimed by Governor Green the previous year and that it sought to raise awareness and action toward saving the imperiled kāhuli of the forests. Senator Ihara explained that the students had succeeded in their advocacy and had witnessed the signing of the bill by the governor that day. Seated in the gallery were students Miley Cox, Hailee Goo, Landon Hirata, Hoku Hulihee, Cole Ide, Ashton Kim, Paula Kong-Mercado, Logan Lee, Carter Matsuwaki, Gervase Ngo, Nicholas Petersen, Luke Tobin, and Sophia Victorino and teachers Yvonne Chan and Candice Sakuda. Senator Ihara then introduced Kailee Lefebvre from the Coordinating Group on Alien Pest Species, a project of the Pacific Cooperative Studies Unit at the University of Hawai'i at Manoa.

Senator Dela Cruz acknowledged Ford Fuchigami, the Airports deputy director, who was present in the gallery.

Senator McKelvey introduced Department of Accounting and General Services director Mr. Keith Regan and deputy director Ms. Meoh-Leng Silliman, who were seated in the gallery.
