

FIFTIETH DAY

Monday, April 15, 2024

The Senate of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2024, convened at 11:40 a.m. with the President in the Chair.

The Roll was called showing all Senators present, with the exception of Senator Chang who was excused.

The President announced that he had read and approved the Journal of the Forty-Ninth Day.

At this time, Senator Moriwaki introduced Neal MacPherson, her former pastor, who had offered a moment of contemplation prior to the Senate's floor session. Senator Moriwaki explained that Mr. MacPherson had become a photographer after his retirement and that some of his work was in her office. Senator Moriwaki then acknowledged Mr. MacPherson's wife, Leilani. Accompanying them in the gallery was Venus Delos Santos, a member of Senator Moriwaki's staff.
