# Wednesday, April 17, 2024

The Senate of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2024, convened at 11:33 a.m. with the President in the Chair.

The Roll was called showing all Senators present, with the exception of Senator DeCoite who was excused.

The President announced that he had read and approved the Journal of the Fifty-First Day.

Your Committee further notes that Mr. Kaneakua sits on the board of governors for Shriners Children's Hospital. He has also worked as congressional staff for United States Senators Daniel K. Inouye and Mazie Hirono and Congresswoman Tulsi Gabbard. Your Committee therefore recommends that Walt Kaneakua be appointed to the Hawaiian Homes Commission based on his experience, knowledge, and commitment to public service. Mahalo."
