# Monday, April 22, 2024

The Senate of the Thirty-Second Legislature of the State of Hawai'i, Regular Session of 2024, convened at 11:43 a.m. with the President in the Chair.

The Roll was called showing all Senators present, with the exception of Senator Lee who was excused.

The President announced that he had read and approved the Journal of the Fifty-Fourth Day.

"With a career spanning governmental roles and a profound commitment to Hawai'i's land and people, Mr. Kanaka'ole brings a wealth of experience and expertise to the position. Hailing from Wai'ōhinu, Ka'ū, on the Big Island, his upbringing provides him with a deep-rooted understanding of the cultural and environmental nuances crucial to DLNR's mission. His legal background, including a juris doctor and a certificate in Native Hawaiian law, coupled with his extensive work at the attorney general's office uniquely position him to navigate the complex legal landscapes and steward DLNR's diverse holdings effectively. Furthermore, his recent tenure as the interim DLNR deputy director showcases his readiness to assume the responsibilities of the position, evidenced by his instrumental role in legislative coordination and proactive engagement in wildfire recovery initiatives. In light of his exceptional qualifications and unwavering dedication to Hawai'i's lands and people, I urge this esteemed chamber to vote in favor of Mr. Kanaka'ole's confirmation. Mahalo."

Senator Kanuha rose to speak in support of the nominee as follows:

"Mr. President, I have written remarks I'd like to have inserted into the Journal in support of G.M. 594, Ryan Kanaka'ole, and I also urge the rest of my colleagues to support this nominee."

The Chair having so ordered, Senator Kanuha's additional remarks read as follows:

"Mr. President, I am honored to express my strong support for GM594, nominating Mr. Ryan Kanaka'ole for the position of Deputy Director of the Department of Land and Natural Resources (DLNR).

"Mr. Kanaka'ole possesses a profound understanding of Hawai'i's governmental landscape, having served in various public service roles at both the County and State levels. As a Native Hawaiian from the Ka'ū District on Hawai'i Island, he brings a vital Neighbor Island perspective to DLNR, which is crucial for addressing the complex challenges associated with stewarding Hawai'i's land and natural resources.

"Mr. Kanaka'ole's commitment to public service is matched by his deep sense of kuleana towards Hawai'i's lands. He has been a staunch advocate for environmental law, traditional and customary rights, Native Hawaiian law and policies, and issues related to public lands and the public-trust doctrine.

"Given his extensive experience and unwavering dedication, I am confident that Mr. Ryan Kanaka'ole is exceptionally qualified to serve as Deputy Director of DLNR. I urge my colleagues to join me in supporting GM594. Mahalo."

Senator Chang rose to request that remarks in opposition to the nominee be entered into the Journal, and the Chair so ordered. The Chair having so ordered, Senator Chang's remarks read as follows:

"I stand in opposition to the confirmation of nominee Ryan Kanakaole as Deputy Director for the Department of Land and Natural Resources (DLNR).

"Hawaii's severe housing shortage is our most pressing public policy priority. Decades of undersupply in the housing market have rendered housing prices out of reach for all but the very wealthy. As a result, we have experienced seven straight years of population decline. There are more Hawaii-born college graduates residing outside Hawaii than in Hawaii and more Native Hawaiians living outside Hawaii than in Hawaii. Most locals can no longer dream of owning a home working just one job. I do not want another day to go by in which a local family must move out of state due to our shortage of housing.

"DLNR is well situated to contribute significantly to a statewide solution to the housing shortage. It owns valuable land in Transit-Oriented Development (TOD) zones along the rail line, notably in East Kapolei. These are critical areas for housing development. But DLNR has consistently opted against utilizing this land for housing purposes, instead arguing that it must build commercial and industrial developments for revenue-generating purposes.

"In our conversations, Mr. Kanakaole advocated for this DLNR agenda that fails to address the dire need for housing in our state. Despite his background as an attorney for the Hawai'i Housing Finance and Development Corporation (HHFDC) and deputy attorney general for the Department of Hawaiian Home Lands, Mr. Kanakaole demonstrated a reluctance to repurpose its East Kapolei lands near rail for housing. It is unacceptable that the department and its Deputy Director continue to use these limited lands for warehouses and other commercial development, rather than housing.

"It is imperative that our state takes decisive action to ensure that each resident has the opportunity to thrive and prosper in this unique place we call home. Thank you."

Senator Richards rose to speak in support of the nominee as follows:

"I rise in support of the candidate."

The Chair asked Senator Richards if he would like to insert comments into the Journal.

Senator Richards rose and stated:

"I support the candidate. I'm keeping it brief."

Senator Fevella rose to speak in support of the nominee as follows:

"I stand in support of G.M. 94—594, sorry. My glasses made me blurry, but my vision is not blurry in the candidate's ability to help straighten out problems that we have at DLNR. We all know we have our issues, and we stand firm and strong that he's going to bring transparency and clarity to the division, so, again—and then I want to insert additional comments to the Journal, Senate President."

The Chair having so ordered, Senator Fevella's additional remarks read as follows:

"After speaking to Deputy Director Kanaka'ole, I am counting on him to help DLNR be more responsive in addressing pressing DLNR issues for the State. I have high expectations of him and I look forward to working with the Deputy Director."

"At this point, I am supporting this measure because something better came along in what was deemed to be the Makakilo Drive Extension."

# FINAL READING

S.B. No. 2487, S.D. 1, H.D. 1:

Senator Rhoads moved that S.B. No. 2487, S.D. 1, H.D. 1, having been read throughout, pass Final Reading, seconded by Senator Wakai.

Senator Elefante rose to request that remarks in opposition to the measure be entered into the Journal, and the Chair so ordered.

The Chair having so ordered, Senator Elefante's remarks read as follows:

"Considering new information from constituents I represent and the testimonies in opposition from the Attorney General and county prosecutors, I share their concerns and will not be able to vote in support of S.B. 2487, S.D. 1, H.D. 1. Thank you, Mr. President."

Senator Moriwaki rose to speak in opposition to the measure as follows:

"This bill raises the minimum amount of marijuana for the offense of promoting a detrimental drug in the second degree from 28 grams to 30 grams. If a joint is a third of a gram, this is an increase of six joints. The measure also increases the amount of marijuana promoting a detrimental drug in the third degree from 3 grams to 15 grams—that amounts to 36 joints. Illegal marijuana is unregulated, untested, and untaxed. This creates a significant public health concern. It also contains pesticides, trace elements of metals like lead and nickel, and other toxic chemicals. Decreasing penalties for illegal marijuana sends a message to our keiki and the community that this drug is harmless. It is not. It is a threat to our number one industry, tourism, especially the Asian visitor market, and will impact my district in Waikīkī as well as the rest of the state.

"To this day, none of the agencies responsible for health and safety of our communities support expanding marijuana use and, particularly, personal use. In fact, as more data come in, we learn cannabis is even more dangerous to the public's health and safety than tobacco or alcohol use. States that have legalized marijuana report the availability of legalized cannabis products correlates with increased incidents of driving under the influence resulting in increased motor accidents causing injury and death. The Centers for Disease Control and Prevention (CDC) has already warned that cannabis causes harm to developing young brains, including difficulty thinking and maintaining a healthy social life.

"You may have received messages from the Institute for Human Services (IHS) Director Connie Mitchell, who works tirelessly with homeless individuals trying to find them a better place, and especially those who have mental illness and cooccurring drug abuse. She says that she has personally seen too much schizophrenia precipitated by marijuana use among younger people, and marijuana these days is more potent and often laced with other drugs like ecstasy, fentanyl, or meth. Dr. Landis Lum, the physician who heads the IHS detox program, also wrote us that THC use increases heart attacks, strokes, and even lung and testicular cancers. It also impairs judgment and slows reaction times and, like alcohol, causes increased injuries and fatalities from car crashes, falls from stairs and ladders, and so forth. So, with this and many other studies that are now coming in, I ask my colleagues to vote 'no.' Mahalo."

Senator Inouye rose to speak in opposition to the measure as follows:

"Mr. President, may I have the comments from the previous speaker—the good senator of Kaka'ako—entered into the Journal as if it was mine? Mahalo." (The Chair so ordered, by reference only.)

Senator Fevella rose to speak in opposition to the measure as follows:

"Since I came into this square building, we tried to stop young children from smoking cigarettes and using flavored tobacco, and also now, we are lowering the blood quantum on the use of alcohol—and then now, here we are, having a bill like this that just goes forward. Just remember, I am not a promoter of any illegal drugs. I'm not a promoter of any alcohol. But I'm telling you right now, we're going backwards because we're telling the kids, 'No vape, no tobacco, no flavored tobacco, lower the blood quantum for DUIs,' and then here we are with this bill. So that's why I'm in opposition to this bill. Thank you, Senate President."

Senator McKelvey rose to speak in opposition to the measure as follows:

"I'm going to have to rise in opposition to this, but not for reasons which some of the previous speakers have given. My concern is that this situation's playing out in other states. The Senate sent a very good, reasonable recreational legalization bill with guardrails over to the other chamber. In other states where the rush to decriminalization is outpacing their own recreational/medical marijuana market, you could have a black market that could explode, thereby undercutting and creating all the safety hazards that the bill that we sent over would have addressed. And so, because of that—and I think this measure should be discussed in context with that this summer in a working group—I can't support it. Aloha."

Senator Richards rose to speak in opposition to the measure as follows:

"Decriminalization is very different from legalization. It's been stated before, we have guardrails around if we go legalization. My concern is some of the health concerns that have been raised by my colleagues, so I'll be voting 'no.' Thank you."

The motion was put by the Chair and failed to carry, and S.B. No. 2487, S.D. 1, H.D. 1, entitled: "A BILL FOR AN ACT RELATING TO MARIJUANA," having been read throughout, failed to pass Final Reading on the following showing of Ayes and Noes:

Ayes, 9; Ayes with Reservations (Shimabukuro). Noes, 15 (Aquino, DeCoite, Elefante, Fevella, Fukunaga, Hashimoto, Inouye, Kanuha, Keohokalole, Kidani, Kim, McKelvey, Moriwaki, Richards, Wakai). Excused, 1 (Lee).

### S.B. No. 2706, S.D. 1, H.D. 1:

On motion by Senator Rhoads, seconded by Senator Wakai and carried, the Senate agreed to the amendments proposed by the House to S.B. No. 2706, S.D. 1, and S.B. No. 2706, S.D. 1, H.D. 1, entitled: "A BILL FOR AN ACT RELATING TO EXPUNGEMENT OF CRIMINAL RECORDS," having been read throughout, passed Final Reading on the following showing of Ayes and Noes:

Ayes, 23. Noes, 1 (Fevella). Excused, 1 (Lee).

# **RECONSIDERATION OF ACTIONS TAKEN**

S.B. No. 2245, S.D. 1 (H.D. 2):

At this time, Senator Gabbard wished the members a happy Earth Day and encouraged them to hug a tree, surf, swim, or hike their favorite trail. Senator Gabbard noted that this was his 16th session chairing the environment committee and thanked colleagues who had been voting in favor of bills that help protect the 'āina and keep paradise paradise.

#### The Chair responded:

"Senator Gabbard: Hemp, hemp, hooray!"

The Chair then made the following announcement:

"The decking deadline for the executive and judiciary budget bills in conference is 11:30 p.m. tonight."
