"During the confirmation hearing, Mr. Miyahira expressed the necessity for regents to have a thorough understanding of operations in order to effectively manage the university's intricate budget as well as asking the difficult, uncomfortable questions that need to be asked. Mr. Miyahira has committed to utilizing his strong business background to ensure effective university operations, board oversight, and fiscal responsibility. The nominee also emphasized the paramount importance of performance-based accountability, both personal and organizational. He expressed the need to address issues and conflicts before they turn into big, hairy monsters or more serious predicaments. Your Committee is confident Mr. Miyahira will be successful in holding the university administration to achieving their benchmarks. Mr. Miyahira expressed a strong commitment to rectifying the longoutstanding university issues relating to student housing and efficient utilization of the University of Hawai'i campuses. Residing on Hawai'i island, Mr. Miyahira has an interest in leveraging the Hilo campus for his community as well as West O'ahu campus to better cater to the underserved communities.

"So, based on his experience and statements, your Committee voted unanimously to advise and consent for Michael Miyahira to serve as a regent on the University of Hawai'i Board of Regents. Thank you."

Senator Inouye rose to request that remarks in support of the nominee be entered into the Journal, and the Chair so ordered.
