As a per diem judge, she has sat on both the criminal and civil calendars and adjudicated various types of cases including misdemeanor and petty misdemeanor offenses, traffic offenses, restraining orders, summary possession claims, and limited jurisdiction civil claims

"Judge Comeau's legal career started in California, where she went to law school at the University of California, Los Angeles. She first was a law clerk for the Honorable A. Wallace Tashima on the U.S. Court of Appeals for the Ninth Circuit and then a law firm associate for two years.

"In 2010, she returned home to Hawai'i and clerked for the Honorable Susan Oki Mollway on the U.S. District Court for the District of Hawaii. She has been licensed to practice law in the state since 2011. Judge Comeau, in addition to her per diem duties, currently is of counsel at the firm Nakashima Ching LLC. As an attorney, she focuses on civil litigation and has handled all aspects of civil litigation from pre-litigation counseling through appeal.

"Judge Comeau received her bachelor's degree in economics from Dartmouth in 2000 and her juris doctorate from the University of California, Los Angeles, in 2006. At UCLA, she graduated magna cum laude and ranked seventh in her class of 315.

"After reviewing the testimony, which was all in support of the appointment, and other materials submitted to the Committee and having examined the appointee in a hearing, your Judiciary committee finds that Michelle N. Comeau is qualified to serve as a district court judge of the First Circuit and recommends that the Senate consent to the appointment.

Senator Awa rose to speak in support of the appointee as follows:

"Judge Comeau comes from a noble family—Ka'a'awa. Her brother, she mentioned, is in Special Forces—one of the most elite in the military. Her sister's an HPD officer. The only question I have for her would be, unlike her siblings, who went to Kahuku, why she's not a Red Raider, but then again, she is where she is. I support her—excellent choice—and look forward to seeing what she does."

The Chair responded, in good humor, that it was gracious of Senator Awa to forgive the appointee's "transgression."

"I would like to clarify the record regarding an error included in S.C.R. 13, page 1, line 11 which understates the number of Palestinian civilians killed as 13,000. Per the United Nations Office for the Coordination of Humanitarian Affairs, 34,151 Palestinians have been killed in Gaza between October 7, 2023 and this date. Even this number is an underestimate of the true number of deaths, as many are trapped under rubble and have gone unreported.

"I would also like to commend and thank all my colleagues for their support of S.C.R. 13, especially the Senator from Salt Lake, the Senator from 'Aiea, and the Representative from Waikiki for their work in hearing this measure."

Senator Fevella spoke in support of the measure as follows:

"Mr. President, I originally opposed the previous draft because it blamed Israel for the conflict in Gaza. The current draft lays out the facts. On October 7, 2023, Hamas abducted 250 people and killed 1,200 Israelis. To date, Hamas is still holding 130 hostages.

"The measure calls for a bilateral ceasefire and it calls for 'aloha,' which I believe the world needs. I stand with Israel, and I support peace. For this reason, I support S.C.R. 13. Thank you, and God bless!"

The motion was put by the Chair and carried, the Senate agreed to the amendments proposed by the House to S.C.R. No. 13, S.D. 1, and S.C.R. No. 13, S.D. 1, H.D. 1, entitled: "SENATE CONCURRENT RESOLUTION URGING THE MEMBERS OF HAWAII'S CONGRESSIONAL DELEGATION AND THE BIDEN ADMINISTRATION TO CALL FOR AN IMMEDIATE, PERMANENT BILATERAL CEASEFIRE IN GAZA AND THE RETURN OF ALL HOSTAGES, AND TO CONTINUE NEGOTIATIONS FOR LASTING PEACE IN THE REGION," was Finally Adopted, with Senator Rhoads voting "Aye with Reservations."

FINAL READING

Senator Dela Cruz moved that Conf. Com. Rep. No. 1-24 be adopted and H.B. No. 1800, H.D. 1, S.D. 1, C.D. 1, having been read throughout, pass Final Reading, seconded by Senator Moriwaki.

Senator Dela Cruz rose to request that remarks in support of the measure be entered into the Journal, and the Chair so ordered.

The Chair having so ordered, Senator Dela Cruz's remarks read as follows:

"Thank you, Mr. President. Over the past four months, the Senate Committee on Ways and Means worked diligently with Senate leadership and Committee Chairs, executive branch leaders, constituents, stakeholders, and House Finance to deliver a budget that answers the call to address a myriad of persistent and challenging issues for the State. The Conference Draft of House Bill 1800 appropriates \$10,395,945,997 in general funds and \$19,209,528,184 in all means of financing for fiscal year 2024-2025.

"Before we highlight key adjustments included in this year's budget, let us first discuss critical programming for which funding was included in our Senate draft, but not included in the Conference Draft. Said adjustments include support for the Farm to Foodbank program, which would have helped improve financial and food security for our farmers and other vulnerable communities; bilingual and bicultural home assistants to support our English language learners within the Department of Education; a pilot program to provide emergency aeromedical services for our neighborhood island and rural populations; and, lastly, funding for the New Aloha Stadium Entertainment District.

"These vital services and resources remain important Senate priorities, and they reinforce our resolve and commitment to the work ahead. We look forward to working with the current administration to address these critical programs during the interim. This budget prioritizes emergency preparedness, recovery and resilience, workforce development and education, housing and homelessness, economic development and infrastructure, and agricultural, environmental, and natural resource management. The highlights in the Conference Draft include funding for, but are not limited to:

 Teacher Differentials and Seal of Biliteracy Programming for Career and Technical Education;

- Expansion of the Hele Imua Internship Program to provide dedicated staff for each County;
- Hawai'i Promise Program for the University of Hawai'i Community College (UHCC) System;
- · Hawai'i Tourism Authority operations and administration;
- · Geothermal energy exploration;
- · Continuing Summer Learning education programs;
- Repairs and Maintenance at State Parks statewide;
- Student internships, teacher professional development, and training for workforce readiness;
- · Rehab and renovations of Public Housing Units;
- · Biosecurity protection and invasive species mitigation;
- Agriculture and value-added initiatives statewide for UHCC:
- Additional funds for increased law enforcement in airports and harbors;
- Positions and funds for increased recruitment efforts statewide; and
- · State Rent Supplement Program

"In conclusion, I would like to thank from the House: Finance Chair and Vice Chair And, from the Senate: yourself, Mr. President, the Vice Chair of Ways and Means and her staff for putting together the CIP budget, and my fellow colleagues in this body.

"I also wish to extend my heartfelt appreciation to the esteemed subject-matter committee chairs, whose leadership and expertise have been invaluable, and to the esteemed members of the Ways and Means Committee, whose dedication and diligence have greatly contributed to our collective efforts.

"Lastly, mahalo to the Ways and Means staff for their commitment, diligence, and dedication in generating the Conference Draft of our State's Executive Budget: Committee Clerk - Scott Fuji; Budget Chief - Colin Peros; Budget Analysts - Parker Spencer, Alexander Ozawa, Carol An Nacario, and Sean Herman; CIP Specialist - Malcolm Iwami; and Advisor - Kathy Sokugawa. Also assisting our budget team from the bills section is Bills Chief - David Cho; Bills Researchers - George Hooker, Netty Leviticus, and Sean Companion; and Legislative Aides Akira Pescador and Emma Shirai. And from our district office, Office Manager - Dot Fujinaga; and district Legislative Aides - Allurie Almogela, Jacob Lee, and Jona Uehara.

"Mahalo"

Senator Dela Cruz continued:

"I also would just like to acknowledge all the Ways and Means staff that's here—they worked hard on the budget and all the bills—so if you could please stand. And if I may be permitted to submit their names into the Journal. Thank you."

The Chair commented:

"Senator Dela Cruz, I would tell you, as one who gets here early, no matter how late they have been working, they are here at the crack of the work day, ready to go. I've been impressed at how much vigor and enthusiasm they have at 8:00, 8:30 in the morning as they are walking into the building with me from the parking lot."

Senator Moriwaki rose to speak in support of the measure as follows:

"I want to thank them as well and especially Senator Dela Cruz, who has supported me and helped me through the CIP process, and they have been most helpful. I know that they've worked very hard and tirelessly, so I also want to thank you, Mr. President, and also my colleagues here for the opportunity. And I also have written remarks that I'd like to place in the Journal. Thank you."

The Chair having so ordered, Senator Moriwaki's additional remarks read as follows:

"Thank you, Mr. President. I echo Ways & Means Chair Dela Cruz in thanking you and Senate Leadership, the Ways and Means Committee, and colleagues. I especially want to thank Chair Dela Cruz and the dedicated WAM committee staff – who worked tirelessly over the long nights and weekends to ensure that the priorities identified by our communities were considered in this capital improvement budget.

"The budget is this body's expression of our values, priorities and commitment to the future. While it supports Maui's recovery efforts, it also reflects our statewide needs -- health and safety; education; economic development; affordable housing and homelessness; agriculture, environment and natural resource management; and support of community programs. Some highlights:

"--On Health & Safety:

"\$35 million went to infrastructure needs of our hospitals and biosafety labs. It includes funding for repairs to water lines, hazardous material removal, and other improvements to health care facilities. These investments will lead to better, long-term health outcomes for our communities.

"--On Education:

"A significant portion of the budget is dedicated to investing in our public schools-- over \$518 million in renovating and improving classrooms and other school facilities; ensuring the safety and security of campuses; upgrading athletic and playground facilities; and \$100 million for the University of Hawaii for student housing and other improvements and modernization projects.

"--On Economic Development Infrastructure:

"This budget also recognizes the importance of diversifying Hawaii's economy through investments in important infrastructure for technology modernization, energy, airport and harbor modernization; and value-added agriculture production. It also addressed deferred maintenance of important state assets such as the convention center rooftop that could not be put off yet another year.

"--On Affordable Housing and Homelessness:

"We cannot grow our economy and maintain and develop a thriving workforce without a major infusion of affordable housing. This budget includes \$180 million for the Rental Housing Revolving Fund, \$50 million for the Dwelling Unit Revolving Fund, and \$10 million for critical repairs and upgrades to Hawaii Public Housing Authority properties; and \$12 million is also allocated in this budget for infrastructure for community development of East Kapolei.

"--On Agriculture, Environment & Natural Resource Management

"This CIP budget also reflects responsible management of our State's delicate natural environment. This includes over \$26 million for irrigation system improvements and \$16 million to enhance our state parks.

"--On GIA:

"The CIP grants-in-aid were awarded to projects across the state with high priority on meeting the health and safety needs of the vulnerable in their communities; on affordable and supportive housing; economic opportunities; and preserving historic venues. We look forward to these partners advancing their projects to best support their communities.

"Conclusion:

"I present this fiscally responsible budget that puts our community first. It is a culmination of the hard work of many and I again thank Senate President and all of you, and especially Ways & Means Chair Dela Cruz and his staff.

"I want to also thank my staff -- CIP staff Malcolm Iwami, and District staff Charles Izumoto, Venus Delos Santos, Randy Tanaka, and Jimmy Nelson. Mahalo!"

Senator Fevella rose to speak in support of the measure as follows:

"I just want to thank our WAM chair and vice chair. The reason why I say this is because I've been here not as long as everybody else, but since I've been here, Senator Dela Cruz and all of our colleagues here have very good staff. And every time, I don't think that he'll top the previous year, and every year, he gets better. We as WAM chair and members of this body have an easier time in working out our community CIPs and knowing how we go about the budget every year 'cause it's very transparent and very informational, so that we kind of know as we go along how the budget is going. Not all the time it's in our favor, but we know at the end of the day, his staff-Senator Dela Cruz and Senator Moriwaki's staff-does the best thing for the budget in going forward. And I'd also like to thank the colleagues in the House on the Finance and CIPs and, of course, our members in the House, so, again, thank you, Senate President, for your time."

The Chair replied, in good humor:

"We'll think about letting the last part of your remarks go into the Journal, where you spoke so nicely about the House."
