#### FIRST DAY

#### Wednesday, June 26, 2024

The Senate of the Thirty-Second Legislature of the State of Hawai'i, Special Session of 2024, was called to order at 11:02 a.m., by Senator Ronald D. Kouchi, President of the Senate, in accordance with the following Proclamation, which was read by the Clerk and was placed on file:

#### "Proclamation

#### June 25, 2024

I, Ronald D. Kouchi, President of the Senate of the Thirty-Second Legislature of the State of Hawai'i, pursuant to the power vested in me by Section 10, Article III of the Constitution of the State of Hawai'i, and at the written request of two-thirds of the members to which the Senate is entitled, do hereby convene the Senate in Special Session as sought in the petition at 11:00 a.m. on Wednesday, June 26, 2024, in the State Capitol Senate Chamber, for the purpose of carrying out its responsibilities established by Section 3, Article VI of the Constitution of the State of Hawai'i.

The Roll was called showing all Senators present, with the exception of Senators Fevella, Fukunaga, Gabbard, Ihara, Inouye, Kim, Richards, and San Buenaventura who were excused.

Senator Rhoads introduced Dale Arakaki, principal of Pauoa Elementary School, who had been named the state's 2024 National Distinguished Principal by the Hawai'i Elementary and Middle School Administrators Association. Senator Rhoads noted that Principal Arakaki had been the principal of Pauoa Elementary School for 10 years and was credited with the school's dramatic increases in academic achievement and its earning National Blue Ribbon School status in 2018. Accompanying Principal Arakaki in the gallery were communications specialists Kimberly Yuen and Kimi Takazawa and communications interns Tara Oyama and Kimi Maligaya from the Department of Education as well as legislative attorney Jessie Faige, a member of Senator Rhoads's staff. Senator Rhoads also recognized Joe Passantino, who had been named the 2024 Principal of the Year by the Hawaii Association of Secondary School Administrators. Senator Rhoads explained that Principal Passantino had been principal of Ke'elikolani Middle School since 2020, where improvement in student achievement and staff morale was attributed to his sterling leadership.

#### MESSAGES FROM THE GOVERNOR

The following messages from the Governor (Gov. Msg. Nos. 1 to 5) were read by the Clerk and were disposed of as follows:

Gov. Msg. No. 2, submitting for consideration and confirmation, the nomination of BRIAN COSTA as Judge of the Circuit Court of the First Circuit (island of O'ahu), State of Hawai'i, for a term of ten years, was referred to the Committee on Judiciary.

Gov. Msg. No. 3, submitting for consideration and confirmation, the nomination of DYAN MEDEIROS as Judge of the Circuit Court of the First Circuit (island of Oʻahu), State of Hawaiʻi, for a term of ten years, was referred to the Committee on Judiciary.

Gov. Msg. No. 4, submitting for consideration and confirmation, the nomination of STEVEN NICHOLS as Judge of the Circuit Court of the First Circuit (island of Oʻahu), State of Hawaiʻi, for a term of ten years, was referred to the Committee on Judiciary.

Gov. Msg. No. 5, letter dated June 10, 2024, clarifying that Judge Rebecca Copeland was nominated to replace Judge Gary Chang, Judge Brian Costa was nominated to replace Judge Jeffrey Crabtree, Judge Dyan Medeiros was nominated to replace Judge R. Mark Browning, and Judge Steven Nichols was nominated to replace Judge Edward Kubo, was placed on file.

At this time, Senator Rhoads announced that the Committee on Judiciary would be holding a decision-making meeting on the measures at 11:45 a.m. that morning in Conference Room 016.

#### SECOND DAY

#### Thursday, June 27, 2024

The Senate of the Thirty-Second Legislature of the State of Hawai'i, Special Session of 2024, convened at 11:02 a.m. with the President in the Chair.

The Roll was called showing all Senators present, with the exception of Senators Fukunaga, Gabbard, Ihara, Kidani, Kim, Richards, and San Buenaventura who were excused.

The President announced that he had read and approved the Journal of the First Day.

Senator Keohokalole introduced Vincent Tan, a summer intern and Kalani High School graduate studying psychology at Connecticut College. Accompanying him in the gallery was committee clerk Jaymee Weisberg.

The Chair, in good humor, expressed his hope that Mr. Tan would not change his major after studying the members' psychology.

## ORDER OF THE DAY ADVISE AND CONSENT

Stand. Com. Rep. No. 1 (Gov. Msg. No. 1):

Senator Rhoads moved that Stand. Com. Rep. No. 1 be received and placed on file, seconded by Senator Elefante and carried.

Senator Rhoads then moved that the Senate consent to the appointment of REBECCA COPELAND as Judge of the Circuit Court of the First Circuit, for a term of 10 years, seconded by Senator Elefante.

Senator Rhoads rose to speak in support of the appointee as follows:

"Rebecca Copeland has been a full-time judge in the First Circuit's District Family Court for over four years and currently is the presiding judge for Truancy Court and the Early Education Intervention Program. She previously was a per diem judge in the District Court for several years. As a result, Judge Copeland has presided over a range of civil and criminal cases including temporary restraining orders, paternities, adoptions, guardianships, involuntary hospitalizations, assisted community treatment orders, juvenile criminal matters, civil traffic infractions, petty misdemeanors, misdemeanors, summary possession, and small claims.

"For eight years, Judge Copeland had her own practice that focused on family and civil litigation. Prior to that, she was an associate at Damon Key Leong Kupchak Hastert, where she concentrated on litigation and appeals, and she was a deputy solicitor general for the Department of the Attorney General. She also was a law clerk at the Intermediate Court of Appeals. Early in her career, Judge Copeland worked for several years in Texas, where she had gone to law school, at two law firms and a county public defender's office handling appeals and as an adjunct professor at two universities. She was licensed to practice law in Hawai'i over 20 years ago.

"Judge Copeland has been an active member of the Hawai'i legal community, including serving on the Hawai'i Access to Justice Commission since 2011. She was a member of the board of directors for the Hawaii State Bar Association and founded and led their Appellate Section. Additionally, she has written a number of publications on appellate practice and has had numerous speaking engagements. She has also been active in other professional and community organizations, including serving as a board member on the City and County of

Honolulu's Zoning Board of Appeals, a board member of the Hawai'i LGBT Legacy Foundation, a board member of Equality Hawai'i, and a member of the Japanese American Citizens League Honolulu Chapter. In 2016, she received the Hawaii State Bar Association's President's Award and in 2018 was named the Hawaii Women Lawyers Outstanding Woman Lawyer of the Year.

"Judge Copeland graduated magna cum laude from Southwest Texas State University, where she received a bachelor of arts degree in psychology. Her juris doctor is from St. Mary's University School of Law, where she was a staff writer and senior associate editor for the school's law journal and participated in the External Advocacy Moot Court Team.

"After reviewing the testimony, which was all in support of the appointment, and other materials submitted to the Committee and having examined the appointee in a hearing, your Judiciary committee finds that Rebecca Copeland is qualified to serve as a circuit court judge of the First Circuit and recommends that the Senate consent to the appointment. Mahalo."

The motion was put by the Chair and carried on the following showing of Ayes and Noes:

Ayes, 16. Noes, 1 (Awa). Excused, 7 (Fukunaga, Gabbard, Ihara, Kidani, Kim, Richards, San Buenaventura).

Senator Rhoads introduced Judge Rebecca Copeland, who was present in the gallery with her husband, Jesse; and their daughter, Maya. Senator Rhoads noted that Judge Copeland would be filling the vacancy created by the retirement of Judge Gary Chang.

Stand. Com. Rep. No. 2 (Gov. Msg. No. 2):

Senator Rhoads moved that Stand. Com. Rep. No. 2 be received and placed on file, seconded by Senator Elefante and carried

Senator Rhoads then moved that the Senate consent to the appointment of BRIAN COSTA as Judge of the Circuit Court of the First Circuit, for a term of 10 years, seconded by Senator Elefante.

Senator Rhoads rose to speak in support of the appointee as follows:

"Brian Costa has been a judge in the First Circuit's District Family Court for seven years as a full-time judge and two years previously as a per diem judge. In this capacity, he is the presiding judge of the Juvenile Drug Court and the lead judge of the Juvenile Division. He has presided over all matters in the District Family Court including divorce trials, paternity motions and trials, petitions for orders of protection, guardianship, involuntary hospitalization, assisted community treatment, and adoption, juvenile delinquency cases, child protective act cases, and child support enforcement agency appeals.

"Judge Costa previously had his own firm, Costa & DeLacy, for 14 years, and he handled a large case load representing hundreds of criminal defendants, respondents in administrative proceedings, and clients in appellate matters. Judge Costa also worked as a deputy prosecuting attorney in the Honolulu prosecuting attorney's office, where he prosecuted criminal and traffic offenses, and at the law firm Goodsill Anderson Quinn & Stifel, handling labor and employment law matters. Early in his legal career, he was a law clerk for Hawai'i Supreme Court Associate Justice Simeon Acoba, Jr.

"In addition to his professional work, Judge Costa has been an active volunteer with the Youth Challenge Academy since 2021. He recently received the Lokahi Award from the Youth Challenge Academy. He also is a commissioner on the Hawai'i Access to Justice Commission and co-chair of the commission's Pro Bono Initiatives Task Force.

"Judge Costa received a bachelor of science in management degree and graduated cum laude from Hawai'i Pacific University. He received his juris doctor from the William S. Richardson School of Law at the University of Hawai'i at Mānoa, where he graduated magna cum laude.

"After reviewing the testimony, which was all in support of the appointment, and other materials submitted to the Committee and having examined the appointee in a hearing, your Judiciary committee finds that Brian Costa is qualified to serve as a circuit court judge of the First Circuit and recommends that the Senate consent to the appointment. Mahalo."

The motion was put by the Chair and carried on the following showing of Ayes and Noes:

Ayes, 16. Noes, 1 (Awa). Excused, 7 (Fukunaga, Gabbard, Ihara, Kidani, Kim, Richards, San Buenaventura).

Senator Rhoads introduced Judge Brian Costa, who was present in the gallery with his wife, Thuan Costa; and wished to acknowledge his late mother, Jeannette Costa; as well as his father, James Costa; and brother Perry Costa, who were watching the live stream online. Senator Rhoads noted that Judge Costa would be filling the vacancy created by the retirement of Judge Jeffrey Crabtree.

Stand. Com. Rep. No. 3 (Gov. Msg. No. 3):

Senator Rhoads moved that Stand. Com. Rep. No. 3 be received and placed on file, seconded by Senator Elefante and carried.

Senator Rhoads then moved that the Senate consent to the appointment of DYAN MEDEIROS as Judge of the Circuit Court of the First Circuit, for a term of 10 years, seconded by Senator Elefante.

Senator Rhoads rose to speak in support of the appointee as follows:

"Dyan Medeiros has been a judge in the First Circuit's District Family Court since 2015. She has been the presiding judge of Girls Court since 2019 and currently is the lead judge of the Domestic Division. During her tenure on the Family Court, Judge Medeiros has presided over divorce cases involving matters such as custody, timesharing, and support. She has also handled post-divorce cases including modification or enforcement of child custody and timesharing, property division, child support, and relocation; juvenile criminal cases; and child welfare and neglect cases as well.

"Before becoming a judge, Judge Medeiros worked for 19 years in private practice and was an experienced family law practitioner. From 2008 to 2015, she was a partner for Kleintop, Luria, and Medeiros, LLLP. Prior to that, she worked as an associate attorney at Stirling and Kleintop and at Damon Key Leong Kupchak Hastert.

"Judge Medeiros has also been an active participant in the legal community. She served as the chair, vice-chair, and treasurer of the Family Law Section of the Hawaii State Bar Association and has presented at numerous seminars and continuing legal education events. Before becoming a judge, she was a volunteer settlement master for the Family Court for over 10 years and volunteered for almost 20 years at Volunteer Legal Services of Hawai'i.

"Judge Medeiros received her bachelor of arts degree in English from the University of Hawai'i at Mānoa, where she was a University of Hawai'i Regent's Scholar, and her juris doctor from the William S. Richardson School of Law at the University of Hawai'i at Mānoa. Judge Medeiros has been licensed to practice law in the state since 1996 (and I believe we were sworn in on the same day just a few feet from here over in the Auditorium).

"After having reviewed the testimony, which was all in support of the appointment, and other materials submitted to the Committee and having examined the appointee in a hearing, your Judiciary committee finds that Dyan Medeiros is qualified to serve as a circuit court judge of the First Circuit and recommends that the Senate consent to the appointment. Mahalo."

The motion was put by the Chair and carried on the following showing of Ayes and Noes:

Ayes, 17. Noes, none. Excused, 7 (Fukunaga, Gabbard, Ihara, Kidani, Kim, Richards, San Buenaventura).

The Chair made the following comments:

"Before recognizing you, Senator Rhoads, I would say, now that the vote is done, I had the chance to meet with Judge Medeiros on Thursday morning a couple of weeks ago at 10:00. And at 10:10, in my big conference room, the power went out and the room was dark. Fortunately, there is an area in my office where there is natural lighting, and we moved to that spot and continued, and she was nonplussed by all of the activity and temporarily being in the dark and showed great composure. So, you know, just wanted to acknowledge that it was a very interesting meeting. The other three nominees I met with, there was no such excitement like there was with Judge Medeiros and pretty routine."

Senator Rhoads introduced Judge Dyan Medeiros, who was present in the gallery and wished to recognize her late father, Albert Medeiros, Jr.; her 'ohana; individuals from her Family Court 'ohana, including Girls Court; her colleague Chuck Kleintop; and her sister. Senator Rhoads noted that Judge Medeiros would be filling the vacancy created by the retirement of Judge R. Mark Browning.

Stand. Com. Rep. No. 4 (Gov. Msg. No. 4):

Senator Rhoads moved that Stand. Com. Rep. No. 4 be received and placed on file, seconded by Senator Elefante and carried

Senator Rhoads then moved that the Senate consent to the appointment of STEVEN NICHOLS as Judge of the Circuit Court of the First Circuit, for a term of 10 years, seconded by Senator Elefante.

Senator Rhoads rose to speak in support of the appointee as follows:

"Steven Nichols is an experienced defense attorney. He was a deputy public defender for the Office of the Public Defender for 19 years, representing indigent defendants. By the time he left the office last year, Judge Nichols was a felony division supervisor and senior felony trial attorney. He handled a range of criminal cases including Class A, B, and C felonies and tried between 50 and 60 jury trials and between 30 and 40 bench trials. He also gained experience in District and Traffic Court with misdemeanor and petty misdemeanor crimes and represented the Office of the Public Defender on the Oʻahu Jail Diversion Circuit Court Team.

"In October 2023, Judge Nichols established his own law firm, the Law Office of Steven R. Nichols, where he has focused on criminal defense. Since April 2024, this year, he has

been a per diem judge in the District Family Court. At the start of his legal career, Judge Nichols was a law clerk in the First Circuit. He has been licensed to practice law in the state since 2002.

"Judge Nichols has also been an active participant in his community. He participated in the Hawai'i Pacific University 2023 Crime and the Chinatown–Downtown Roundtable Event, the 2021 and 2019 Courts in the Community events, and was an assistant coach for the Mililani High School Mock Trial Team. He currently serves as the president of the Mililani Mauka Elementary Parent Teacher Organization and on the board of directors for the Mililani Community Athletic Association. Judge Nichols also coaches numerous sports, including having been the head coach for the Mililani Basketball Association, head coach of 19 Basketball, head coach of 19 Soccer, Mililani Community Athletic Association basketball head coach, and American Youth Soccer Organization head soccer coach.

"Judge Nichols received a bachelor of arts degree in history from the University of Hawai'i at Mānoa, where he was a Regent's Scholar and graduated summa cum laude. He received his juris doctor from the William S. Richardson School of Law at the University of Hawai'i at Mānoa.

"After having reviewed the testimony, none of which was in opposition, and other materials submitted to the Committee and having examined the appointee in a hearing, your Judiciary committee finds that Steven Nichols is qualified to serve as a circuit court judge of the First Circuit and recommends that the Senate consent to the appointment. Mahalo."

The motion was put by the Chair and carried on the following showing of Ayes and Noes:

Ayes, 17. Noes, none. Excused, 7 (Fukunaga, Gabbard, Ihara, Kidani, Kim, Richards, San Buenaventura).

Senator Rhoads introduced Judge Steven Nichols, who was present in the gallery with his wife, Dr. Sharon Nichols; their daughters, Arianna, Alexandria, and Aubree; and his parents, Richard and Cynthia Nichols. Senator Rhoads noted that Judge Nichols would be filling the vacancy created by the retirement of Judge Edward Kubo.

Senator Rhoads requested that, at the appropriate time, the new judges be invited to the floor to be congratulated by the members, and the Chair so ordered.

The Chair announced that the new judges and their families would be greeted and congratulated on the Senate floor immediately after adjournment.

people. And the reason why I bring this up is because one of the judges that came through here, Judge Souza, I got to see him in action. When he came before us and he told me that he was gonna be the person that he was, he didn't know I was in the chambers, and I got to see him in action. And I'm gon' tell you right now, guys, you guys would be proud of him: He's doing really well out there. And I have confidence since I have met Judges Nichols and Medeiros in my office—I'm glad she didn't take up English and instead decided to become a judge, which is great. But of course, even for him, he's a coach, and I told him, being a coach for girls basketball is a very blessing because they're not the easiest persons to coach, but my hats off to you. I'm just saying, if anybody in this chamber that have got to meet any of these guys later on and the ones before that, if you guys ever get one chance to sit and be blessed in the chambers and watching them in action, you guys gon' know how proud you guys are to have this opportunity and blessed to be able to do these kinds of things that we do because one of the most important things for me as being a senator in this chamber: to be able to go ahead and nominate and vote for judges like this. So, again, thank you, Senate President, and thank you, guys, and good luck. God bless."

Your Committee received testimony in support of the appointment of Judge Rebecca Copeland from the Governor, Hawaii Women Lawyers, King Kamehameha V Judiciary History Center, and twenty-four individuals.

Your Committee received comments on the appointment of Judge Rebecca Copeland from the Board of Directors of the Hawaii State Bar Association.

The Hawaii State Bar Association Board of Directors (HSBA Board) uses a rating system that considers several criteria to assist the HSBA Board in making a recommendation to your Committee on whether the appointee is "qualified" or "not qualified". Specifically, the criteria the HSBA Board employs is the same criteria found in the American Bar Association's Guidelines for Reviewing Qualifications of Candidates for State Judicial Office. Those guidelines include the following criteria, which are not exclusive: integrity, diligence, legal knowledge and ability, professional experience, temperament, financial responsibility, public service, and ability to perform the responsibilities and duties required of the position for which the applicant has been appointed. Upon review of the established criteria, the HSBA Board found the appointee to be qualified for the position of Circuit Court Judge of the First Circuit.

Judge Copeland attended Southwest Texas State University where she received a Bachelor of Arts degree in Psychology and graduated magna cum laude. She received her Juris Doctor from the St. Mary's University School of Law, where she was a staff writer and senior associate editor for the St. Mary's Law Journal and participated in the External Advocacy Moot Court Team.
