#### TENTH DAY

## Friday, January 31, 2025

The Senate of the Thirty-Third Legislature of the State of Hawai'i, Regular Session of 2025, convened at 11:36 a.m. with the President in the Chair.

The Roll was called showing all Senators present, with the exception of Senators Awa, Kanuha, and Richards who were excused.

The President announced that he had read and approved the Journal of the Ninth Day.

At this time, Senator San Buenaventura welcomed participants of the annual Secondary Student Conference (SSC) who were seated in the gallery: Tiffany Edwards Hunt, Elaina Hasting, Emilia Baldan Jenkins, Andrea Antonio, and Khalila-Pietra Comier from Kea'au Middle School and Alayna Kadarusman from Pahoa High School.
