

## ELEVENTH DAY

Monday, February 3, 2025

The Senate of the Thirty-Third Legislature of the State of Hawai'i, Regular Session of 2025, convened at 11:42 a.m. with the President in the Chair.

The Roll was called showing all Senators present, with the exception of Senators Fukunaga and Kanuha who were excused.

The President announced that he had read and approved the Journal of the Tenth Day.

At this time, Senator Dela Cruz introduced staff members of the Committee on Ways and Means: David Cho, AsherRay Palomares, Diana Setness, Fabian Respicio, Aimee Wakai, and Kristie Castillo from the bills office; and Colin Peros, Kristen Hernandez, Leanne Chung, Joseph Kopshy, Holland Morris, Lottie Davis, and Kathy Sokugawa from the budget office.

## STANDING COMMITTEE REPORTS

Senator Wakai, for the Committee on Energy and Intergovernmental Affairs, presented a report (Stand. Com. Rep. No. 4) recommending that S.B. No. 996, as amended in S.D. 1, pass Second Reading and be referred to the Committee on Commerce and Consumer Protection.

On motion by Senator Wakai, seconded by Senator DeCorte and carried, the report of the Committee was adopted and S.B. No. 996, S.D. 1, entitled: "A BILL FOR AN ACT RELATING TO RENEWABLE ENERGY," passed Second Reading and was referred to the Committee on Commerce and Consumer Protection.
