Thursday, April 3, 2025

The Senate of the Thirty-Third Legislature of the State of Hawai'i, Regular Session of 2025, convened at 11:36 a.m. with the President in the Chair.

The Roll was called showing all Senators present.

The Chair announced that he had read and approved the Journal of the Forty-Fourth Day.

At this time, Senator Keohokalole introduced members of his staff: Katie Anderson, who had offered a moment of contemplation prior to the Senate's floor session; Jaymee Weisberg; Kurt Klein; Kiera Williams; Charles Jonsson; Josslyn Rose; and Jules Peleiholani.
