

## FIFTY-FIRST DAY

Tuesday, April 15, 2025

The Senate of the Thirty-Third Legislature of the State of Hawai'i, Regular Session of 2025, convened at 11:38 a.m. with the President in the Chair.

The Roll was called showing all Senators present.

The Chair announced that he had read and approved the Journal of the Fiftieth Day.

At this time, Senator Moriwaki introduced Reverend David Baumgart Turner, pastor of the Church of the Crossroads, who had offered a moment of contemplation prior the Senate's floor session. Senator Moriwaki explained that Reverend Turner had previously served as pastor of other churches on Kaua'i and O'ahu, Punahou School chaplain, a sustainability consultant, and cofounder of the Sustainable Outdoor Learning Center and was executive director of Camp Mokulē'ia. Senator Moriwaki noted that Reverend Turner had also been employed as a staff member for Representative David Hagino and had spent time with Senate President Kouchi. Accompanying Reverend Turner in the gallery was his wife, Kirsten, a sustainable community development consultant and cofounder of the Sustainable Outdoor Learning Center; and Venus Delos Santos and Alex Ozawa, members of Senator Moriwaki's staff.

Senator DeCoite recognized Lisa Paulson, from Maui, nominee to the Hawai'i Tourism Authority; and Andrew Pereira and Walter Thoemmes, nominees to the Stadium Authority, who were seated in the gallery.
