

FIFTY-FOURTH DAY

Monday, April 21, 2025

The Senate of the Thirty-Third Legislature of the State of Hawai'i, Regular Session of 2025, convened at 11:37 a.m. with the President in the Chair.

The Roll was called showing all Senators present.

The Chair announced that he had read and approved the Journal of the Fifty-Third Day.

At this time, Senator San Buenaventura introduced members of her staff who were seated in the gallery: Luis Lopez, who had offered a moment of contemplation prior to the Senate's floor session; Juliet Begley; Amelia Dudley; and John Honda, who had been with her since she was in the House of Representatives.
