Friday, February 28, 2025

The Senate of the Thirty-Third Legislature of the State of Hawai'i, Regular Session of 2025, convened at 11:41 a.m. with the President in the Chair.

The Roll was called showing all Senators present, with the exception of Senators Fukunaga and Kidani who were excused.

The Chair announced that he had read and approved the Journal of the Twenty-Third Day.

At this time, Senator Lee introduced members of his staff who were seated in the gallery: Anthony Miranda, Natasha Quinn, and Danielle Evangelista.

Senator Kim welcomed three Dole Middle School students who were part of the Working Families Group. Present in the gallery were seventh grader Pali and eighth graders Eric and Rylan. Senator Kim noted that the students would be speaking at the Working Families press conference that afternoon at 1:15 p.m.

Senator Hashimoto recognized members of the American Association of University Women who were seated in the gallery. Senator Hashimoto then introduced constituents from the association's Maui branch: public policy chair Sonya Toma and Maui branch president Lauren Akitake, who was also on the UH Board of Regents.

Senator Moriwaki acknowledged advocates who were attending that day's Working Families Day 2025 and were committed to improving the lives of Hawai'i's 'ohana and keiki: Deborah Zysman from HCAN Speaks!, Sergio Alcubilla from the Hawai'i Workers Center, Mike Nguyen from AlohaCare, Angelina Mercado from the Hawai'i State Coalition Against Domestic Violence, and Younghee Overly from the American Association of University Women of Hawai'i.
