

## TWENTY-SIXTH DAY

## Thursday, March 6, 2025

The Senate of the Thirty-Third Legislature of the State of Hawai'i, Regular Session of 2025, convened at 11:35 a.m. with the President in the Chair.

The Roll was called showing all Senators present, with the exception of Senator Lee who was excused.

The Chair announced that he had read and approved the Journal of the Twenty-Fifth Day.

At this time, Senator Rhoads introduced a constituent, Lieutenant Governor Sylvia Luke, who was seated in the gallery.

Senator Moriwaki welcomed Rajan Zed, a guest from Nevada and president of the Universal Society of Hinduism who had offered a moment of contemplation prior to the Senate's floor session. Senator Moriwaki noted that Mr. Zed travelled across the country and worldwide to promote peace and interfaith dialogue with leaders of diverse religions and nonbelievers. Accompanying him in the gallery were members of Senator Moriwaki's staff: office manager Venus Delos Santos, Alexander Ozawa, Charles Izumoto, Cody Rex, and CIP staff member Joe Kopschy.

Senator DeCoite recognized volunteer intern La'i Reyes, who was originally from Moloka'i and was attending St. Andrew's Priory in Honolulu, who was present in the gallery. Senator DeCoite also acknowledged staff members of Lieutenant Governor Luke's who were seated in the gallery who had been instrumental in working with her on a number of bills, including Michele Kurihara, Annie Aki, and Kaleo Chang.

At this time, Senator Fevella rose to speak on a point of personal privilege as follows:

“Today was a very monumental occasion in ‘Ewa Beach: finally gonna start on a new facility with locker rooms, football stadium stands, lights, and everything. I just want to thank my colleagues in this chamber—a lot of them, especially in this chamber, Senator Dela Cruz. When I came to this chamber seven years ago, he asked me what I needed for my community, and I asked him, I needed my football stadium. He told me how much I needed. I told him, ‘\$37 million’—it’s a joke, it’s funny. But he told me that: ‘You not gon’ get it. You not gon’ get

\$37 million. What do you really need?’ I said, ‘No, \$37 million.’ He said, ‘You not gon’ get \$37 million.’ He said, ‘This is not a sprint race; it’s a marathon. What do you need to start the project?’ I said, ‘\$7 million.’ And I was really blessed by this chamber and everybody here to getting that \$6,290,000 to start, but I don’t want to just only talk about Senator Dela Cruz and how much he wen’ help me, lot of guys in this chamber.

“Most of all, our LG, Sylvia Luke, who also taught me 10 years ago, when I came and demand things from her, not knowing the process. She taught me some of that, too.

“And today, it was a blessing day to see our community come together and finally seeing the most beautiful—I don’t want to be biased, but I’m just (sorry, Senator Kim)—the most beautiful football stadium that’s ever going to be built. And I want to thank everybody in here and Lieutenant Governor Sylvia Luke. Thank you, colleagues—appreciate it. Thank you, Senate President.”

Senator DeCoite rose to speak on a point of personal privilege as follows:

“Members of the Senate: This Friday, March 7th, we will celebrate the eighth annual Tourism Day at the Capitol. I, along with my House counterpart, Representative Tam, will be hosting this special event. Tourism Day will take place on the fourth floor from 9 a.m. to noon, and we invite you to join us in recognizing one of Hawai‘i’s most vital industries—one that supports our economy, provides thousands of jobs, and shares our islands’ unique culture.
