Friday, March 7, 2025

The Senate of the Thirty-Third Legislature of the State of Hawai'i, Regular Session of 2025, convened at 11:35 a.m. with the President in the Chair.

The Roll was called showing all Senators present, with the exception of Senators Awa, Fevella, and Lee who were excused.

The Chair announced that he had read and approved the Journal of the Twenty-Sixth Day.

At this time, Senator Rhoads introduced Emilio Balay, an old friend who had been indirectly responsible for him and his wife meeting. Joining Mr. Balay in the gallery was his wife, Cassandra Nesmith. Senator Rhoads noted that they were visiting and that their son Maxwell was serving in the Navy at Pearl Harbor. Senator Rhoads then acknowledged members of his staff: longtime legislative attorney Jessica Faige; office manager Glen Young; Moya Gray; legislative attorney Teddy Brokaw; committee clerk Imiloa Borland; legislative aide Mia Ogata; legislative aide Sara Thorne, who had offered a moment of contemplation prior to the Senate's floor session; and legislative interns Payton Haygood; Mattheo Cadiz; and Brayden Cheung.

Senator DeCoite welcomed Kaua'i County Council Vice Chair KipuKai Kualii and Kaua'i County Councilmember Bernard Carvalho, who were seated in the gallery. Senator DeCoite also recognized representatives of the hotel and tourism industry: Kalani Ka'anā'anā, Daniel Nahoopii, Aaron Salā, Tyler Gomes, and Hawai'i Tourism Authority Chair Mufi Hannemann.

The Chair noted that the councilmembers from Kaua'i were of Portuguese ancestry and that there were to be special guests from Portugal who had not yet arrived.

Senator Kanuha introduced a group of students from his alma mater, Kahakai Elementary School, in Kailua-Kona: student council president Cohen Fediuk, student council vice president Lawai'a Silva, treasurer Levi Ezzo, secretary Kristen Devito, historian Adeline Adair, sergeant at arms Lau'oha Elvenia, junior police officer Kody Miranda, and 2025 May Day queen Riley Costales. Accompanying them in the gallery were Principal Kori Takaki and Vice Principal Ka'ea Yglesias.

Senator Kim acknowledged Ho'oilina Scholar and Hilton Scholar students from the UH Shidler College of Business travel industry management program: Sally Citrawarej, Leslie Ann Agustin, Kana Wang, and Masumi Iwai. Joining them in the gallery were academic advisor Kaitlin Tilitile and director and professor Dr. Daniel Spencer.

At this time, the Chair made the following announcement:

Senator DeCoite rose to speak on a point of personal privilege as follows:

"I'd like to thank everybody for coming out today at Tourism Day at the Capitol. I'd like to give special attention, of course, to HTA, to HVCB, to CNHA, Kilohana—what an amazing job and making such a big turnout. The Chair commented that the Senate's special guests were not present and added that they had arrived in the state the previous day. The Chair explained that the visitors were touring the Archives, where they were paying special attention to the items regarding Portuguese immigration, and that they would later be touring 'Iolani Palace, where there were also references to Portuguese arrivals. The Chair asked Senator DeCoite to introduce the guests.

Senator DeCoite acknowledged members of the Luso American Development Foundation (FLAD), a private, nonprofit, financially independent Portuguese institution that strove to promote the development of Portugal, the Portuguese, and Portuguese descendants in the community through cooperation with the U.S. Visiting from Lisbon, Portugal, were Nuno Morais Sarmiento, FLAD president; Miguel Vaz, director of transatlantic relations; and Leonor Barroso, coordinator of transatlantic relations.
