A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Chapter 302A, Hawaii Revised Statutes, is
- 2 amended by adding two new sections to read as follows:
- 3 "§302A-1154.5 Dental health; dental hygiene supplies. (a)
- 4 Every school shall include on the list of school supplies
- 5 students are required to bring to school toothbrushes,
- 6 toothpaste, and dental floss; provided that if a student does not
- 7 bring these dental supplies to school for any reason, no
- 8 disciplinary action shall be imposed. Each school shall ensure
- 9 that each classroom homeroom has a supply of toothbrushes,
- 10 toothpaste, and dental floss for use by students, at no cost, who
- 11 are unable to bring these supplies.
- 12 (b) Every school shall allow a student a total of ten
- 13 consecutive minutes a day as part of the lunch period for each
- 14 student to brush and floss after the student has eaten lunch;
- 15 provided that the length of each school day shall not be extended
- 16 for this purpose.
- 17 §302A-1154.7 Fluoridated bottled water coolers. Each
- 18 school shall install and maintain in each building on the
- 19 premises, one or more water coolers containing fluoridated water

The department of health shall monitor the 9 efficacy of this Act on the dental caries rate among children and 10 adults in this State for ten years subsequent to the effective 11 date of this Act. From 2002 to 2010, the department of health 12 shall report annually to the legislature on the dental caries 13 rate not later than January 15 of each year. All dentists, 14 dental clinics, and public health services and facilities shall 15 cooperate with the department of health in supplying data for 16 purposes of this section.

- 1 SECTION 6. There is appropriated out of the emergency
 2 budget and reserve fund established in section 328L-3, Hawaii
 3 Revised Statutes, the sum of \$, or so much thereof as
 4 may be necessary for fiscal year 2000-2001, for preventive dental
 5 health services for children and adults.
- 6 The sum appropriated shall be expended by the department of 7 health for purposes of this Act.
- 8 SECTION 7. There is appropriated out of the emergency
 9 budget and reserve fund established in section 328L-3, Hawaii
 10 Revised Statutes, the sum of \$, or so much thereof as
 11 may be necessary for fiscal year 2000-2001, for public water
 12 systems to comply with this Act, including costs for the training
 13 of personnel as to the health risks involved in working with
 14 fluoride and for other costs incurred by county public water
 15 systems under section 340E- , Hawaii Revised Statutes, not
 16 offset by moneys from the sale of bottled fluoridated water under
 17 section 340E- , Hawaii Revised Statutes.
- 18 The sum appropriated shall be expended by the department of 19 health for purposes of this Act.
- 20 SECTION 8. Statutory material to be repealed is bracketed. 21 New statutory material is underscored.
- 22 SECTION 9. This Act shall take effect upon its approval; 23 provided that sections 5, 6, and 7 shall take effect on July 1, 24 2000.

REPORT TITLE: Dental Health

DESCRIPTION:

Requires public and private school students to bring dental supplies to school for use in school; requires water supply authorities to bottle fluoridated water for distribution; makes appropriations for public education and preventive dental services for adults and children; and requires DOH to monitor and report to legislature. (SD1)
